American Indian Movement (AIM) Steps Up

The American Indian Movement often is associated with events of the past, like the 1970s occupations of Wounded Knee and Alcatraz Island.

But the recent unrest here has shown the group remains a powerful force, with members guarding Native housing and more than a dozen Native-owned businesses and organizations against looting and riots.

"AIM has stepped in to ensure the Native community, its members and organizations are being protected," said Minneapolis American Indian Center Director Mary LaGarde, White Earth Ojibwe. **"They've organized and brought the community together."**

George Floyd's death in police custody last weekend happened blocks from the home of AIM's last surviving co-founder, Clyde Bellecourt.

Just the day before, the 84-year-old Bellecourt named two new leaders to the group, which has 14 chapters and six support groups, including one in St. Paul.

Bellecourt, who has been battling prostate cancer, said on Native Roots Radio last Sunday that he's stepping down from day-to-day duties to deal with health issues.

He named Frank Paro, Grand Portage Chippewa, board chairman and president; and Lisa Bellanger, Leech Lake, executive director.

"I'm not going anywhere or retiring," said Bellecourt, White Earth Chippewa. **"I'll always be there to support the community and do the work the creator wants us to do. I ask the movement to support these two young people who've been around from Day One."**

Bellecourt said he and others started AIM on Minneapolis' Franklin Avenue in 1968 to protest police violence.

"From there, we went all the way to Washington, D.C., to take over the BIA (Bureau of Indian Affairs) and ended up at the United Nations to get their involvement in Indigenous issues," he said during the radio announcement.

AIM members took part in the 1969-71 occupation of Alcatraz Island, the site of the former prison in San Francisco Bay.

The group also grabbed headlines in 1973 when it took over

Wounded Knee, on the Pine Ridge Reservation, in a protest against both the U.S. and tribal governments.

The armed takeover led to a 71-day standoff with federal agents; member Leonard Peltier remains in a Florida federal penitentiary serving two life sentences in two agents' deaths. Still, the events raised awareness of broken treaties, unfair treatment and miserable conditions on reservations and in cities.

"What AIM did in this country is awaken Indian people — Indian tribes and urban Indian people who had been so beaten down," Elaine Salinas, former director of the now-defunct Heart of the Earth Survival School, told the Minneapolis Star Tribune in 2019.

"AIM said, 'We are proud people, we are a resilient people, and we have to challenge institutions that marginalized us and destroyed our lives.' It was a very powerful message," she said.

The group continues that mission to this day.

During the violence here, its members have stood guard over the city's Native corridor, which includes tribal offices, the Indian center, the Native American Community Clinic and Little Earth of United Tribes housing, considered the nation's first complex dedicated to urban Natives.

Floyd, who is black, died at the intersection of 38th Street and

patrols, they were given an exemption to an 8 p.m. curfew by Gov. Tim Walz.

Banks, galleries and the boarded-up Indian center were patrolled. No damage to any of the buildings was reported.

Even before the rioting, AIM maintained a community presence as it still fights to bring awareness to local and national issues across the country.


"AIM is the very expression of community," said American Indian OIC chief executive Joe Hobot, Standing Rock Sioux. **"They're all nations of Indigenous people coming together to support one another, to advocate and give our community voice and create alliances with other communities of color."**

Also on Friday, AIM members who were guarding the Leech Lake tribal urban headquarters prevented four white teenagers from Wisconsin from making off with boxes of liquor and groceries from a nearby looted liquor store, turning over the merchandise to the owners Saturday.

Residents who saw the pilfering in progress notified the AIM

members, who stepped in and detained the teens, filming the incident and posting it on Facebook.

"We don't need chapter leaders out there taking selfies and trying to make a name for themselves on social media, looking at the camera and saying, 'Look at me,' Frank Paro 68, told the radio station. 'It's not about you or me. It's about the people.'" He Added.

Since 4,100 National Guardsmen moved in and strictly enforced the Minneapolis' curfew, AIM and other community patrols have been told to stand down at night, but work continues during the day.

A donation center at Pow Wow Grounds on Franklin Avenue has filled with groceries and other items for Twin Cities Natives who have been affected by rioting or the coronavirus pandemic.

On Saturday (May 30, 2020), AIM took 15 bags of donated food and supplies to Elders Lodge in St. Paul, an independent living facility for senior tribal members.

They planned to distribute more to elders Sunday night before the curfew, when highways will shut down until Monday morning.

"A lot of the elders out there can't get access to groceries because of the curfew, no transportation, or their grocery store is destroyed," said Lisa Bellanger, 58.

“A Journey To Freedom” November 20, 1969 - June 11, 1971 Marked the End of the Historical Alcatraz Occupation 49-Years Past

The island's lone guard, who had been warned of the impending occupation, sent out a message on his radio. "Mayday! Mayday!" he called. "The Indians have landed!"

The 1969 Photo above shows Denis Turner (Rincon Indian Reservation Left) and Richard Oakes (St. Regis Mohawk Reservation) at the San Francisco dock waiting for the boat to take them to Alcatraz.

The occupiers proclaimed their purpose as *"To better the lives of all Indian people" by making "known to the world that we have a right to use our land for our own benefit" through reclaiming Alcatraz "in the name of all American Indians by right of discovery."*

Conflicts over leadership and the influx of non-indigenous people diminished the important stance of the original occupants.

On June 11, 1971 the government removed the remaining 15 occupants from the island.

Richard Oakes:

May 22, 1942-September 20, 1972:

Morgan had a reputation for being a white supremacist, and being tough and abusive with the Native American. Oakes supporters contend the shooting was an act of murder, and that Morgan received support from a racially motivated jury and district attorney. Oakes was only 30 years old.

After leaving Alcatraz Turner returning home to the Rincon Indian Reservation in north San Diego County and resumed his studies, earned a BA degree in Economics at the University California San Diego.

For the past 40-plus years he has served as the Executive Director for the Southern California Tribal Chairmen's Association, Inc., (SCTCA).

While Oakes and his followers did not succeed in obtaining the island, they did affect U.S. policy and the treatment of Indians. As a result of the occupation, the official U.S. government policy of termination of Indian tribes was ended and replaced by a policy of Indian self-determination.

In 1975 President Nixon introduced the Indian Self-Determination and Education Act, Public Law 93-628.

This single legislation forever changed the political relationship between the U.S. Government and the American Indian Tribes.

And although it has been 45-years since P.L. 93-638 became law Indian Tribe still face the discrimination of the Government bureaucrats. And the lack of understanding or the outright refusal to honor Tribal Rights by the administration of the various Government agencies.

In way of example is the resent conflict between the Department of Interior and the Department of Treasury regarding the eligibility of the Alaskan Natives Corporations to receive CARES Act funding.

Although the law is very clear as defined in P.L. 93-638 the funding was held up for almost 2-months and only 60% was released while the case winds its way through the courts.

Regardless, of all these' barrier's the American Indian Tribes have made great progress over the past 50-years.

However, we must never lose our focus of "Self Determination and Education" as they serve as the foundation for the advancement of our people.

The dependency on the Government must be minimized and we must keep control of our future.

It was on June 10, 1935 that the most successful self-help organization of the 20th century was founded: **Alcoholics Anonymous.**

It's 85 years old today. It began in Akron, Ohio, started by a stockbroker named Bill Wilson and a surgeon named Bob Smith.

Bill Wilson had gone to Akron on a business trip in May of 1935. He had been trying to give up drinking for years, and he'd always found that the best way to keep from drinking was to spend time with other men who were trying to keep from drinking.

But on his business trip to Akron, he was alone, and he felt tempted to go to the local bar. Instead, he went to a church group meeting, looking for someone else who was struggling with the drink. It was

there that he met the surgeon Bob Smith. The two men became friends and promised to help keep each other sober.

Wilson decided to write a book about his ideas to help spread the message, called Alcoholics Anonymous (1939).

The group began to get coverage in local newspapers. Then in 1941, a journalist for The Saturday Evening Post heard about the organization and wrote an article about it. Suddenly, requests for literature and membership soared. By the end of the year, there were more than 6,000 members.

Today millions attend AA meeting everyday throughout the world.

Minneapolis Riot Fire Destroys Native Youth Nonprofit Center

A third night of rioting in protest of George Floyd's death claimed the home of a Native American nonprofit that provides media arts training to hundreds of youths a year, as a fire early Friday ripped through Migizi Communications.

If the building, a half-block from the Minneapolis Police Department's 3rd Precinct, is deemed a total loss, damage could near \$2 million, said Migizi Executive Director Kelly Drummer, Oglala Sioux. Drummer described what's left as *"just a shell."*

Supporters quickly rallied around the youth organization after the blaze, raising more than \$100,000 in donations by Friday night.

Migizi provides training in media arts such as radio, film and social media. It is the home of First Person Productions and also provides training for "green" jobs, such as solar energy.

Around 400 youth a year receive job training at Migizi, which employs eight people, Drummer said.

Drummer, 46, said Migizi – "eagle" in Ojibwe – was the only minority-owned building on the block as other enterprises are leasing.

The 3rd Precinct in south Minneapolis has been the epicenter of rioters since protests began Tuesday. At first, it was defended by officers in riot gear, firing smoke grenades and rubber bullets, but staff abandoned the building late Thursday as rioters persisted and set the building ablaze.

A Professor Sarah Parcak, a Guggenheim fellow at the University of Alabama at Birmingham and a Guggenheim fellow has taken to Twitter to provide instructions, perhaps with the anarchists and other rioters in mind, on how to remove an obelisk that "might be masquerading as a racist monument," a clear reference to the Washington Monument.

She opens with a "PSA" for anyone contemplating such action.

New York Congressman Caught on Hot Mic

U.S. Representative Eliot Engel (D., N.Y.) was caught on hot mic admitting that he only wanted to speak at a George Floyd rally because of his upcoming primary

The rally was led by Bronx Borough president Ruben Diaz Jr. Engel, whose district covers parts of the Bronx, has not returned from Washington, D.C., for months during the coronavirus pandemic.

When Engel asked Diaz to be allowed to address the crowd, Diaz answered "there's just too many folks here who were scheduled to speak."

"If I didn't have a primary I wouldn't care," Engel

said. Diaz, shaking his head, responded "Don't do this to me. We're not going to do this."

Engel has served in his district since 2013, but faces a heated primary contest this election season. Progressive groups have united around a single candidate, Jumaal Bowman, who is backed by Justice Democrats and the New York Working Families Party. Another primary challenger, Androm Ghebregiorgis, dropped out of the race to endorse Bowman.

Engel's request to speak at the rally comes after massive demonstrations against the death of George Floyd,

ACLU Sues Los Angeles City, L.A. and San Bernardino Counties Over Curfew Orders

"These unconstitutional curfews have suppressed a huge amount of important political protest activity and disrupted the lives of over 10 million people," Ahilan Arulanandham, senior counsel of the ACLU SoCal, said. "The curfews must end now."

Defendants named in the lawsuit include Los Angeles Mayor Eric Garcetti, LAPD Chief Michel Moore, Sheriff Alex Villanueva and San Bernardino police Chief Eric McBride.

AG BARR: Evidence Shows Antifa, Others Groups Guilty of 'Instigating' Violence during Protests

As protests have erupted into violence and destruction in cities across the U.S. for more than a week, Attorney General William Barr made it clear on Thursday that he knows who the real culprits are — and an investigation is underway.

"We have evidence that Antifa and other similar extremist groups, as well as actors of a variety of different political persuasions, have been involved in instigating and participating in the violent activity," he said during a press conference, according to Breitbart.

"Set out to sow discord" Also present at the briefing was FBI Director Christopher Wray, who echoed Barr's message about the role extremist agitators have played in the ongoing demonstrations against police brutality and racial injustice.

According to Breitbart, Wray said such criminals have "set out to sow discord and upheaval, rather than join in the righteous pursuit of equality and justice."

Bolstered by the strength of the nation's intelligence community, Wray added that Americans should expect to see action in response to the widespread chaos reported on the streets of multiple cities.

"We've directed our 200 joint terrorism task forces around the country to assist law enforcement with apprehending and charging violent agitators who are hijacking peaceful protests on a national level," he said, according to Breitbart.

In an earlier address, Barr similarly called out Antifa by name, adding that it was time to "stop watching the violence" and stand up to it with decisive action.

"The violence instigated and carried out by Antifa and other similar groups in connection with the rioting is domestic terrorism and will be treated accordingly," he said on Sunday, according to a transcript provided by the Justice Department.

Judge Jeanine Pirro: Defunding Police Would Lead to Tragedy in America - "Anarchy and Chaos"

Pirro announced her full support for legitimate protesters who are remaining peaceful as they air their grievances, but had nothing good to say about the "criminal" looters taking advantage of the situation, not to mention the "agitators" attempting to spark another "civil war" in this country.

"These agitators, whether they're from within this country or outside of this country, whether they're foreign, whether they're domestic, the whole point is to create chaos and anarchy," she said, and went on to suggest that the coronavirus-related lockdowns had created a sort of "petri dish" in which people's

frustrations were growing out of control.

"The end goal of defunding police departments is to create anarchy and chaos," Pirro said. She noted that the police were the one thing standing in between "anarchy and a peaceful society, between barbarism and a civil society."

"If you want anarchy, get rid of the police departments," the former judge and prosecutor added. "I'll tell you what, for someone who spent 30 years in the trenches fighting against evil in this country. We have a civil war every day in terms of crime, in terms of shooting, stabbing, drug deals, domestic violence, child abuse, bank robberies."

Without the police around to maintain order and justice, she argued that America would no longer be the same country we know and love. "Take down the flags, change the name of the country, and call it a day," Pirro said. "This is shameful."

The Cato Institute found in a survey that while a majority of Americans across racial lines supported various reform measures on policing, very few support abolishing or downsizing police departments.

In fact, approximately 90 percent of Americans of all races opposed the idea of reducing the number of police officers in their communities.

"Protests not about Black Live" Draw Backlash For Fox's Tucker Carlson

Tucker Carlson says protests are *our cities enforcing Democratic 'definitely not about black lives,' Party orthodoxy.* prompting backlash.

Carlson, who referred to the protests as the "Black Lives Matter Riots," expressed disbelief at the idea of dismantling entire police departments, telling viewers, "All of this probably strikes you as wild-eyed craziness, flat-earth stuff."

"Defund the police is a move toward authoritarian social control cloaked in the language of identity politics," said Carlson, noting that if activists are successful it would likely result in a "woke militia policing

"However, the authors report that because the COVID-19 outbreak in China was being contained while the trial was ongoing and new cases were unavailable for enrollment."

"Convalescent plasma use in the study by Li et al⁸ was associated with some clinical improvement in severely ill patients, but not in critically ill patients.

Greater efficacy in less ill individuals is expected because antibody therapies generally work best when administered earlier in disease."

"As reported in case series from Wuhan,⁴ plasma-treated patients had large reductions in their serum viral loads and most were virus negative 3 days after infusion." This observation establishes that convalescent plasma has antiviral activity, which is important because it indicates that antibody administration mediates a clear biological effect.

"The precedent of antiviral drug use against HIV and hepatitis C shows that reductions in viral load translate into clinical improvement, and earlier therapy is more effective than later therapy when organ damage is already present."

"Hence, the antiviral effect of COVID-19 convalescent plasma suggests that its use earlier in the course of disease could have potentially important therapeutic activity, especially in less severely ill individuals."

"Significant concerns have been raised about the use of convalescent plasma in COVID-19. These include transfusion-related lung injury and transfusion-related circulatory overload."

TRALI concerns are unfounded with all NuPlasma products and all FDA authorized convalescent plasma, as HLA testing is required. TACO concerns are not associated with 20-ml

small volume injections, or the slow infusion of an individual 200-ml treatment unit.

"The study by Li et al⁸ reported only 2 adverse events among the 52 individuals who received convalescent plasma, each of whom responded to corticosteroid administration."

"In addition, there have been theoretical concerns that the administration of antibodies might aggravate disease through antibody-mediated enhancement of proinflammatory effects."

"Overall, the paucity of adverse effects is reassuring and reduces concerns about adverse effects from antibody."

Federal Court Judge Rules For Mashpee Wampanoag Tribe

On June 4, 2020 the United States District Court for the District of Columbia rendered a decision in favor of the Mashpee Wampanoag Tribe in the case of *Mashpee Wampanoag Tribe v. Bernhardt*. In its opinion, Judge Paul L. Friedman ruled:

The Court will grant the Mashpee Tribe's motion for summary judgment and deny the federal defendants' and defendant-intervenors' motions for summary judgment.

Furthermore, because the Secretary of the Interior's September 7, 2018 Record of Decision is arbitrary, capricious, an abuse of discretion, and contrary to law, the Court remands the matter to the Secretary of the Interior for a thorough reconsideration and re-evaluation of the evidence before him consistent with this Opinion, the 2014 M-Opinion, M-37209 - its standard and the evidence permitted therein - and the Department's prior decisions applying the M-Opinion's two-part test.

For the first time since the termination era, the Department of the Interior (DOI) attempted to disestablish a Tribal reservation, ordering the homelands of the Mashpee Wampanoag Tribe to be taken out of trust.

The order from DOI Secretary David Bernhardt came on March 27, 2020, as the Tribal Nation worked to respond to the COVID-19 public health emergency, during active litigation on the status of the land, and following the rescission of the 2014 *Carcieri* M-Opinion and the issuance of a new 4-part test to qualify under the first definition of "Indian" in the Indian Reorganization Act (IRA).

On March 30, 2020, the Mashpee Wampanoag Tribe asked the Court to issue an emergency restraining order to prevent DOI from taking immediate action to disestablish its reservation.

The DC District Court righted what would have been a terrible and historic injustice by finding that the Department of the Interior broke the law in attempt-

ing to take our land out of trust," said Mashpee Wampanoag Tribal Chairman, Cedric Cromwell. **"We will continue to work with the Department of the Interior - and fight them if necessary - to ensure our land remains in trust."**

The Court ruled DOI's 2018 decision that the Mashpee Wampanoag Tribe did not prove it was **"under federal jurisdiction"** in 1934, and therefore did not meet the first definition of "Indian" under the IRA—making the Mashpee Wampanoag Tribe ineligible to acquire land in trust—was arbitrary and capricious.

It remanded the decision to DOI with clear direction to issue a decision consistent with the 2014 M-Opinion's standard and the evidence permitted therein, as well as DOI's prior decisions applying the 2014 M-Opinion test.


The Court further directed DOI to properly address each piece of evidence, give a reasoned analysis as to

whether it is probative, explain any departure from past DOI precedent, and view all probative evidence in concert rather than in isolation.

And importantly, the Court's decision also mandates that DOI maintain the land in trust pending DOI's new determination and prevents DOI from applying its new 4-part test in this case.

About the Mashpee Wampanoag Tribe:


The Mashpee Wampanoag Tribe, also known as the People of the First Light, has inhabited present day Massachusetts for more than 12,000 years. After an arduous process lasting more than three decades, the Mashpee Wampanoag were re-acknowledged as a federally recognized tribe in 2007. In 2015, the federal government declared 150 acres of land in Mashpee and 170 acres of land in Taunton as the Tribe's initial reservation, on which the Tribe can exercise its full tribal sovereignty rights. The Mashpee tribe currently has approximately 2,700 enrolled citizens

Game On: Judicial Watch Challenges D.C. Mayor

During the "Peaceful Protest" in Washington D.C., Mayor Muriel Bowser granted permission to have **"Black Lives Matter"** painted on 16th Street NW. Later she allowed the politically charged **"Defund the Police"** to also be painted nearby.

Now Judicial Watch, a government watchdog organization is explaining those decisions made the streets a public forum, and it wants to join the expressive activity by painting its own slogan, **"Because No One is Above the Law!"** on a street.

"Mayor Bowser made a decision to turn D.C. streets into a forum for public expression. Judicial Watch seeks equal access to use this new forum to educate Americans by painting our organization's motto and motivation, 'Because No One is Above the Law!' on a Capitol Hill street," said Judicial Watch President Tom Fitton.

"This rule of law message is timely, as it a reminder that a rule of law applies to - and protects - all Americans. If we are unlawfully denied access and face viewpoint dis-



crimination, we are prepared to go to court to vindicate our First Amendment rights."

In its letter to Bowser and others in the District of Columbia, the organization said, **"We note with interest Mayor Bowser's recent decision approving the painting of 'Black Lives Matter' on 16th Street NW and the approval of and/or acquiescence in the painting of 'Defund the Police' alongside the first message. Both messages are expressive activity."**

The letter explains the Judicial Watch motto is **"particularly relevant today because it applies 'equally to law enforcement and public officials as well as to protesters, looters, and rioters."**

And since the Washington streets now are **"being used as public fora for expressive activity, we would like to have**

our motto painted on a street, preferably Independence Avenue SW, between 2nd and 4th Streets SW, which is near our offices."

It plans to use letter that is the same in size and coloring as the **"Black Lives Matter."**

Judicial Watch, Inc. would pay the cost of the painting, but we would likely need the assistance of the D.C. Government to aid in traffic diversion and parking restrictions while the painting is completed. Of course, the painting could be completed when traffic is typically light, as was done with the 'Black Lives Matter' message."

The organization asks for a response within three days, since **"the timeliness of our message is important."**

That moment when you walk into a spider web suddenly turns you into a karate master.




- "I'll tell you one thing, if things keep going the way they are, it's going to be impossible to buy a week's groceries for \$20."
