The New Socialist America Shut-up, Sit Down and Obey!

My Tribe filed a law suit against the Metropolitan Water District and the Federal Government in the early 40's. The case against the Federal Government was settled in 1992 and the in 2004 with the water district.

And, although the Bureau of Indian Affairs, the U.S. Government Agency that is charged with provided the oversight of the American Indian Tribes, which is a branch of the Department of Interior had funds with which to provide the reservation with domestic water. All that was needed was to drilling down to the lower water level but they refused to allow it.

Why? Because the water district wanted the tribe to cede their water rights the them in exchange for their own water.

My tribe refused to cede their water rights and were forced to live without a domestic water system for the next 37-years until PL-93-638 was passed in 1976 under the Nixon Administration.

This legislation is the most significant legislation ever passed for the benefited of the American Indian

Tribes and Alaskan Natives.

PL-93-638, for the first time in U.S. history allowed for the American Indian Tribes and Alaskan Natives to manage their own affairs including the education of their children. Yet, 44-years have passed and many of the Government bureaucrats refuse to comply with the law. And restrictions still exist on land usage.

In 1976, under the authority of PL-93-638 my tribe requested the water funds from the Bureau of Indian Affairs to construct a domestic water delivery system on the reservation, but were refused. After another year of legal and political action the tribe was finally awarded the funds.

The point is that the American people are about to become the new Indians and the Nation will be their Reservation. They will be under the control of the multiple layers of Government, Local, State and Federal agencies working in tandem to keep the sheep compliant.

And the non-compliant "White People" are to become the "Jews of Hitlers Germany." I know you think I'm going over the top but, just take the time to look at the public school curriculum that includes lessons on "*Whiteness and Black Live Matter*," listed as "*Social Awareness*" or some other misleading names.

Prosecutor Threatens Jailing Entire Congregation: "All of these are violations of the law," prosecutor Michael Dowd wrote in a letter.


Socialist-Democrat Newsom also demands that indoor church services be banned, as well and singing and reciting prayers. Even having Bible studies in your own home is forbidding.

subject your church, owners, administrators, operators, staff and parishioners to the above-mentioned criminal penalties as well as the potential closure of your church,"

Dowd wrote. "Your future compliance is expected." The city of Pasadena also said they will arrest the entire congregation if it comes down to it.

The Church is Fighting Back: The founder of Liberty Counsel, Mat Staver, has taken on representing Harvest Rock Church and plans to fight against the constitution stripping Democrat leaders.

"Criminal activity," Staver said on **The Todd Starnes Radio Show**.

"Let that sink in. You can face up to one year in prison and if you do it again and don't stop, another year in prison. That is stunning that this is happening in the United States of America."

While it's totally wrong in the eyes of the left to go to church, thousands of violent protesters taking to the streets is completely permissible.

"The same prosecutor has turned a blind eye to the thousands of protests that have paraded the streets and caused damage in the city of Pasadena," he said.

Tlingit artist designs stamp for U.S. Postal Service

hope that as a designer I can represent on a national scale the modernity of Native people — that we're engaged in modern culture while still carrying forward our traditional heritage."

Merging traditional artwork with modern design touches, this stamp depicts one of many stories about Raven, a figure of great significance to the Indigenous peoples of the Northwest Coast. Among the cultures of the region, Raven plays an essential role in many traditional tales, including stories about the creation of the world. Inspired by the traditional story of Raven setting free the sun, the moon and the stars, Worl depicted Raven just as he escapes from his human family and begins to transform back into his bird form.

"Many depictions of this story show Raven with the Sun in his mouth representing the stealing of the Sun. I was trying to showcase a bit of drama," Worl said. "The climax of the story is after Raven has released the sun and the moon and has opened his grandfather's final precious box, which contained the stars. In this design I am imagining Raven in a panicked state of escape — transforming from human form to raven form and holding on to as many stars as he can while trying to escape the clan house."

Sealaska Heritage Institute

The U.S. Postal Service has tapped Rico Lanáat' Worl, a Tlingit/Athabascan artist based in Juneau, to create a Northwest Coast art stamp for distribution in 2021.

The design of the stamp, titled "Raven Story" by Rico Lanáat' Worl, was unveiled this week by the Postal Service as part of its Forever Stamps series.

The Postal Service had planned to unveil the stamp with Sealaska Heritage Institute (SHI) at Celebration 2020, but the event was cancelled because of the pandemic. SHI is working with the agency to hold a release ceremony next year.

The Postal Service has featured Northwest Coast art stamps in the past; in 1996, it released a stamp featuring Worl's clan uncle, Nathan Jackson, performing a Raven dance. However, this is thought to be the first time such a design has been illustrated by a Tlingit artist.

Antonio Alcalá, who served as art director on the project, reached out to Worl about creating the stamp after seeing his work for sale at the National Museum of the American Indian gift store in Washington DC.

"It was a huge honor to be invited to participate. I also felt the weight of needing to represent well since I was showcasing as a Tlingit artist on a national platform," Worl said. "I

Worl called the depiction an exciting moment of humanity for Raven, who is a powerful being much of the time.

"I think it's a moment we all feel at times. A moment before we accomplish a goal when we may feel frazzled and have trouble holding everything together in our hands, while trying to accomplish multiple goals at the same time. Even the greatest among us experience the moment that is on the cusp between accomplishment and failure."

Rico Lanáat' Worl is a Tlingit/Athabascan social designer and artist with training in anthropology.

His work began with the development of the arts department at Sealaska Heritage Institute, implementing programs to empower the Indigenous artists of Southeast Alaska. The programs focused on developing fundamental skills and access to resources.

Through his current ongoing project, Trickster Company, he carries forward the goals of empowering indigenous artists. Through this brand he works to celebrate indigenous resilience and cross-cultural connection, break into a tourist market which profits millions of dollars from knock-off "Native" artwork, and represent the story of how Indigenous people are not only here today but engaged in modern lifestyles.



These goals are also foundational in his work outside of the brand. His crafts range from product design, digital design, jewelry making, printmaking, public art and most recently he has been working to develop his skills in sculpture and computer-aided 3D design.

Sealaska Heritage Institute is a private nonprofit founded in 1980 to perpetuate and enhance Tlingit, Haida and Tsimshian cultures of Southeast Alaska. Its goal is to promote cultural diversity and cross-cultural understanding through public services and events.

SHI also conducts social scientific and public policy research that promotes Alaska Native arts, cultures, history and education statewide. The institute is governed by a Board of Trustees and guided by a Council of Traditional Scholars, a Native Artist Committee and a Southeast Regional Language Committee.

Jackboots in America: Dawn of the Socialist Reich

At six in the morning, a house in a quiet residential neighborhood was surrounded by 17 SUVs, two armored vehicles, and 29 armed government agents wearing military garb. One of the agents shouted and banged on the front door until the terrified owner of the house emerged barefoot in shorts and a T-shirt. He was greeted by two rifle barrels aimed at his head. This is not a description of 1938 Berlin. It is Judge Andrew Napolitano's account of the 2019 FBI raid on the home of Roger Stone, whose crime was being a long-time Trump friend and supporter.

"Why," asked Napolitano, "were there more FBI agents sent to arrest Stone than Navy SEALs sent to kill Osama bin Laden?" It was a message of terror, he says, the behavior of a police state. "Totalitarianism," wrote George Orwell, "if not fought against, could triumph anywhere." That's right, it could happen here. It is happening here. Courtesy of the Democratic Party, there are many parallels between 1930s Germany and contemporary America.

The Democratic Party has embraced violence as its modus operandi. The treatment of Roger Stone is the party's way of intimidating its opponents. In 1930s Germany, the SA, a violent paramilitary group better known as Brownshirts or Storm Troopers, helped the Nazi Party's rise with violent intimidation of Germany's leftists and Jewish population.

The contemporary version of the Brownshirts is Antifa, whose objective, says Dinesh D'Souza, is to "beat people into obeisance." With the support of Democratic mayors and governors, violent Antifa mobs have trashed our cities, assaulted Trump supporters, and provided justification for more government control over the individual.

The Democratic Party has sent a message to its adherents that anything goes in the pursuit of power, from weaponizing the FBI and IRS against political opponents to rigging elections. Democrats will not hesitate to deprive you of your basic

rights if it suits their purpose. Knocking down monuments and re-writing history are part of the campaign of intimidation. "The most effective way to destroy people," said George Orwell, "is to deny and obliterate their own understanding of their history." Hitler understood this and so does the Democratic Party.

The Nazi Party in Germany identified members of targeted groups in order to blacklist them from holding jobs in business, universities, and government. Blacklists are making a comeback in America. Rep. Ocasio-Cortez is urging a blacklist of Trump supporters. "Is anyone archiving these Trump sycophants," asks AOC, "for when they try to downplay or deny their complicity in the future?" Other Democrats are proposing the "Trump Accountability Project," a "permanent record of every staffer, appointee, donor, endorser and enabler." Washington Post columnist Jennifer Rubin tweeted that Trump supporters "should never serve in office, join a corporate board, find a faculty position, or be accepted into 'polite' society. We have a list," Rubin declared. The blacklist idea has spread to Harvard University, where a group of students has petitioned the school to bar Trump administration alumni from teaching or speaking on campus.

David Atkins, a Democratic Party official in California, wants to "deprogram" 75 million people who watch Fox News, subscribe to Breitbart, and vote Republican. He refers to conservatives as "a conspiracy theory fueled belligerent death cult against reality and basic decency." Atkins insists that he is not advocating re-education camps for conservatives, but he is not very convincing. I suspect that Atkins and many others in the Democratic Party would love to wire their opponents up and administer electric shocks until they see the light.

One of the most effective strategies of leftist tyrannies is to divide and conquer. It is happening here thanks to Democratic Party support

for identity politics, where special interest groups are set at each other's throats. The Left is achieving the "balkanization" of society, says Mark Levin in *Ameritopia*. One result is the inquisition against white people that is gaining momentum in schools and corporations. Whites are coerced into confessing their "systemic racism."

The City of Seattle, for example, is holding a segregated training session for white city employees that will train them to "undo their whiteness" and affirm their "complicity in racism." If you refuse to comply, you could lose your job and be blacklisted. Jodi Shaw, a staff member at tony Smith College, has refused to apologize for her "white privilege" as required by Smith's Critical Race Theory training. Failure to condemn her whiteness is likely to result in Shaw being shunned, harassed, fired, and blacklisted from working at another college.

Another nightmare of Nazi Germany was the banning of books. In the US, more than 100 titles have been either removed or threatened with removal from both school and public libraries in more than 30 states. Some of the best American novels are being banned, including Harper Lee's *To Kill a Mockingbird*, J.D. Salinger's *The Catcher in the Rye*, and Mark Twain's *The Adventures of Huckleberry Finn*. The assault on books is an assault on the First Amendment.

For some time, the Democratic Party has engaged in a campaign to destroy the Bill of Rights. Democrats have attempted to silence anyone who denies global warming, criticizes Islamic terrorism, or advocates a stronger military. Mark Steyn, author of *America Alone*, observed that we are turning into "one vast college campus" where there is one correct view and all others are prohibited. "The Left says, we don't want to win the argument, we want to cancel the argument." The constitutional right to free speech amounts to nothing, Steyn believes, when public pressure kills dissent.

The Democratic Party is the official

endorser of political correctness. PC is an attempt to shut down any speech that is not in accord with the liberal playbook. Contradictory views are labeled as "hate speech." PC is purely totalitarian and, if permitted to flourish, will destroy the rights we enjoy under the Constitution. All individual rights, including freedom of religion and the press, stem from freedom of speech. PC is a way of stifling free expression in favor of socially controlled thought. Controlled by the Democrats, that is.

Another hateful feature of Nazi Germany was absolute control over the media. In the US, the mainstream media are owned by the Democratic Party. Formerly objective news sources like the *New York Times* and *Washington Post* have become no better than Pravda. Their bias is revealed by a cowardly reluctance to ask the tough questions of Joe Biden and Kamala Harris. Media's refusal to report on the Biden pay-for-play scandal signals a free pass for any and all forms of governmental corruption.

The latest example of tyranny is the use of the coronavirus as an excuse to deprive citizens of their rights as individuals. Democratic governors are enforcing arbitrary rules of behavior to tell us when we can go to work, when we can leave our homes, where we can eat, when we are allowed to get a haircut, and when we can visit our loved ones. The rules only apply to us, not to the people who make the rules.

Despite evidence that lockdowns don't work, the political elite are reveling in their newfound power. Don't expect them to give it up any time soon. "We know that no one ever seizes power with the intention of relinquishing it," said Orwell.

Left-leaning Democrats want to jettison the US Constitution. "We should never forget," said Sen. Rand Paul, "the Constitution wasn't written to restrain citizen's behavior. It was written to restrain the government's behavior." Advice we should take to heart.

Comply, be Fired or Ruined

Diamond and Silk, the famous conservative duo, have published a new book discussing their careers and the decision made by Fox News to fire them.

Why were we such a threat? We only did one video every week, and it was hidden behind a paid subscription wall. When you really think about it, was this part of the systemic racism that everybody was talking about?" Silk added, implying that racism may have been a factor in their firing.

December 29, 2020 marks the 130th anniversary of the **Wounded Knee Massacre** on the Pine Ridge Indian Reservation, South Dakota.

Time should not diminish its memory as it was only one of numerous acts of terrorism and genocide committed against our people.

Just as we celebrate Christmas in honor of the birth of our Lord and Savior, Jesus Christ (*At least for many of us believers and not so politically correct folks*) and with the New Year right around the corner let us take a moment to remember and honor our people murdered at **Wounded Knee, South Dakota**.

On that infamous day, December 29, 1890 it is estimated that 275 Lakota Sioux men, women and children were murdered with hundreds more wounded and 25 U.S. soldiers killed and for no other reason than fear! Fear of the "Ghost Dance" was the reason given as if one could justify the incomprehensible murdering and maiming of so many innocent people. Why, because of the political policies at that period in time.

After all what more could the "Indians" want? The Government was going to take care of them as long as the rivers flow and the grass shall grow.

Again, 47-years ago on February 27, 1973, **Wounded Knee**, South Dakota became the center of national attention when the American Indian Movement (AIM) leaders, Denis Banks and Russel Means led an armed takeover and occupation of Wounded Knee.


The protest followed the failure of an effort of the Oglala Sioux Civil Rights Organization (OSCRO) to impeach tribal president Richard Wilson, whom they accused of corruption.

The armed occupancy of Wounded Knee which received national attention, ended after 71 days when Lawrence "Buddy" Lamont, a local Oglala Lakota, was killed by a shot from a government sniper on

April 26, 1973. He was buried on the site in a Sioux ceremony. A U.S. marshal was also shot and paralyzed.

After Lamont's death, tribal elders called an end to the occupation. Knowing the young man and his mother from the reservation, many Oglala were greatly sorrowed by his death. Both sides reached an agreement on May 5, 1973 to disarm.

Over 200 federal armed law enforcement were joined by local law enforcement and Wilson's private militia, *Guardians of the Oglala Nation* (GOONS).

With the decision made to end the protest, many Oglala Lakota began to leave Wounded Knee under the cover of darkness walking out through the federal agents lines.

Three days later, the siege ended and the town was evacuated after 71 days of occupation; Government agents took control of the town.

The stand at Wounded Knee electrified American Indians, who were inspired by the sight of their people standing in defiance of the government which had so often mistreated them.

Many American Indian supporters traveled to Wounded Knee to join the protest. At the time there was widespread public sympathy for the goals of the occupation, as Americans were becoming more aware of longstanding issues of injustice related to American Indians.

AIM leaders Dennis Banks and Russell Means were indicted on charges related to the events, but their case was dismissed by the federal court for prosecutorial misconduct, and upheld on appeal.

With the support of the U.S. Government, Wilson stayed in office and in 1974 was re-elected amid charges of intimidation, voter fraud, and other abuses.

The rate of violence climbed on the reservation as conflict opened between the political factions during the following three years; More than 60 opponents of Wilson's tribal government died violently during those years, including Pedro Bissonette, director of the Oglala Sioux Civil Rights Organization. Traditional tribal members blamed Wilson's private militia, Guardians of the Oglala Nation (GOONS).

Shortly following the Wounded Knee standoff 21-year old Leonard Peltier, a young AIM leader was asked by traditional Indian people at Pine Ridge, to help protect them from being targeted for violence by Wilson's tribal GOONS. He went to their aid never to return home to his wife and children.

On June 26, 1975 two FBI agents in unmarked cars followed a pickup truck onto the Jumping Bull ranch. The families immediately became alarmed and feared an attack. Shots were fired and a shoot-out ensued. More than 150 federal agents, GOONS, and law enforcement officers surrounded the ranch occupied by 40 Indians.

When the shoot-out ended FBI Special Agents, Jack R. Coler and Ronald A. Williams and American Indian, Joseph Stuntz lay dead. Stuntz's death has never been investigated, nor has anyone ever been charged in connection with his death.

Leonard Peltier was convicted for the deaths of the two FBI agents killed during the shoot-out on the Pine Ridge Indian Reservation.

He was sentenced to life in prison where he remains as a political prisoner to this day.



Yet, 60 Oglala Sioux died at the hands of the GOONS after that infamous day and no one was ever investigated, charged or prosecuted. The FBI and GOONS prevailed.

Numerous doubts have been raised over Peltier's guilt and the fairness of his trial, based on allegations and inconsistencies regarding the FBI and prosecution's handling of this case.

Even former U.S. Attorney General, Ramsey Clark served *pro bono* as one of Peltier's lawyers and has aided in filing a series of appeals on Peltier's behalf. In all appeals, the conviction and sentence have been affirmed by the 8th Circuit Court of Appeals.

The sad irony is that 130-years after the December 29, 1890 **Wounded Knee Massacre** and 47-years since the 1973 armed protect on the Pine Ridge Indian Reservation, South Dakota very little has changed for the American Indians.

However, progress is being made as more tribes are getting involved in the political process but dependency is hard to break.

Wovoka (AKA *Jack Wilson*) was born in Smith Valley area southeast of Carson City, Nevada, around the year 1856.

Quoitze Ow was his birth name.

From the age of eight until almost thirty he worked for a rancher in the Yerington, Nevada area, David Wilson and his wife Abigail, who gave him the name Jack Wilson for when dealing with European Americans.

David Wilson and his wife were devout Christian, and Wovoka learned Christian the-

ology and Bible stories while living with the Wilson's.

One of his chief sources of authority among Paiutes was his alleged ability to control the weather. He was said to have caused a block of ice to fall out of the sky on a summer day, to be able to end drought with rain or snow, to light his pipe with the sun, and to form icicles in his hands.


Wovoka claimed to have had a prophetic vision during the solar eclipse on January 1, 1889. His vision entailed the resurrection of the Paiute dead and the removal of whites and their works from North America. He taught that in order to bring this vision to pass the American Indians must live righteously and perform a traditional round dance, known as the "**Ghost Dance**", in a series of five-day gatherings. His teachings spread quickly

among many American Indian peoples, notably the Lakota.

The **Ghost Dance** movement is known for being practiced by the victims of the **Wounded Knee Massacre**; Indian Agents, soldiers, and other federal officials were predisposed towards a militaristic posture when dealing with a movement that was so antithetical to their views and ideas.

What people are missing in all this is that Trump’s 2018 executive order gives the DOJ the power to seize all assets of individuals and companies that were complicit in aiding or covering up this foreign interference in U.S. elections.

The National Emergency order specifically calls for seizure of all assets of entities that have, “directly or indirectly engaged in, sponsored, concealed, or otherwise been complicit in foreign interference in a United States election.”

That would, of course, have to include practically every CNN fake news anchor, every Big Tech CEO, every fake news journo-terrorist from NBC News, the NY Times and the Washington Post. They are all complicit in gaslighting America and covering up the massive foreign election interference that just took place.

Trump’s executive order further explains that asset seizures shall target people and entities which have: ...materially assisted, sponsored, or provided financial, material, or technological support for, or goods or services to or in support of, any activity described in subsection (a)(i) of this section or any person whose property and interests in property are blocked pursuant to this order; or (iii) to be owned or controlled by, or to have acted or purported to act for or on behalf of, directly or indirectly, any person whose property or interests in property are blocked pursuant to this order.

In other words, the executive order covers every person who has been corrupted or compromised by communist China. And that includes at least 80% of Democrat lawmakers, by our estimates, including Senators Feinstein and Schiff.

On November 15, 2020 Rep. Louie Gohmert told Chris Salcedo on Newsmax that people on the ground in Germany report that ScytI, which hosted elections data improperly through Spain, was raid-



ed by a large US ARMY force and their servers were seized in Frankfurt.

Andrea Widburg at *American Thinker* earlier reported that ScytI is a Barcelona-based company that provides electronic voting systems worldwide, many of which have proven vulnerable to electronic manipulation. ScytI has (or had) Soros and Democrat party connections. Microsoft co-founder Paul Allen’s Vulcan Capital has invested \$40 million in ScytI.

We heard more from our source on this raid in Germany: The US government, once they determined that this Dominion server was involved in switching votes, then the intelligence community began a search for the server and discovered that the server was in Germany.

In order to get access to that server and have it available for use in a legal manner they had to have the State Department work in tandem with the Department of Justice. They had to request that the government of Germany cooperate in allowing this seizure of this server.

Google has announced that is offering a six month course that will be accepted in-lieu of and over a college degree for job applicants.



