Representative Alexandria Ocasio-Cortez (AOC), (D-NY) and Representative Ilhan Omar, (D-MN) teamed up yesterday with a radical leftist communist who says that America deserved the 9/11 attack.

AOC and Omar were joined by Hasan Piker on the gaming site Twitch to help get out the vote for Democrats. Piker was suspended by the gaming site last year for telling Representative Dan Crenshaw (R-TX) that the US deserved the attack on 9/11.

"America deserved 9/11, dude. F— it, I'm saying it," said Piker at the time. Later Piker took refuge in that last hope of the exactly quoted by saying that he was misunderstood, he was taken out of context, and "obviously" he didn't mean what he said, even though he said what he said exactly.

"Obviously, 9/11 was a horrific tragedy," said Piker, explaining his comments. "3,000 Americans died, OK? Seven thousand troops have died since then in endless wars. And if you're spending all of your energy getting upset at me because I think that is abhorrent and awful, maybe you should spend your energy elsewhere and realize that those who justify the endless bloodshed don't actually have the best interest of those young men and women at heart."

Or maybe he should look at Joe Biden's record in those so-called endless wars, in comparison to Trump's record in ending those endless wars.

As the Atlantic noted in the last year of the Obama-Biden administration, they promised to end the wars, but Obama/Biden accelerated the violence in the Middle East.

"Under Obama, the United States has been at war for 2,687 days," said Rolling Stone in May of 2016. "That's longer than under George W. Bush — or any other U.S. president, for that matter."

Tribes make new push to stop DAPL

BISMARCK, N.D. (AP) — Tribes opposed to the Dakota Access Pipeline once again have asked a federal judge to stop the flow of oil while the legal battle over the line's future plays out.

Standing Rock Sioux and others say potential harm to their water supply outweighs any economic impacts of shutting down the line, which has been moving North Dakota oil to Illinois for more than 3 years.

The Standing Rock Sioux and other tribes succeeded on their first attempt, only to have an appeals court overturn U.S. District Judge James

Boasberg's shutdown order earlier this year. Now, they're asking the judge to clarify his earlier ruling to satisfy the appellate judges and then to again order the line to cease operations, the Bismarck Tribune reported.

"The Tribes are irreparably harmed by the ongoing operation of the pipeline, through the exposure to catastrophic risk, through the ongoing trauma of the government's refusal to comply with the law, and through undermining the Tribes' sovereign governmental role to protect their members and respond to potential disasters," attorneys Jan Hasselman and Nicole Ducheneaux wrote in a Friday filing.

BILLINGS, Mont. (AP) — A federal judge has denied a request by Montana tribes to halt construction of the Keystone XL oil pipeline from Canada over worries about potential spills and damage to cultural sites.

Work started this spring on the pipeline, which would carry oil sands crude from Hardisty, Alberta, to Steele City, Nebraska. However, much of it is stalled after a separate ruling in July by the nation's top court.

The decision last week involves the Assiniboine and Gros Ventre tribes of the Fort Belknap Indian Community in Montana and the Rosebud Sioux Tribe in South Dakota.

The tribes say the 2019 permit vio-

lated their rights under treaties from the mid-1800s.

U.S. District Judge Brian Morris said in an Oct. 16 ruling that the tribes did not show they would suffer irreparable harm from the work that's been done so far.

He did not make a final ruling, and invited further arguments.

Work on much of the pipeline itself is on hold after a U.S. Supreme Court this summer upheld a lower court ruling that invalidated a permit needed for the pipeline to cross hundreds of rivers and other water bodies along its route.

That case was referred back to the 9th U.S. Circuit Court of Appeals for further consideration.

 - 8) **Class Warfare** — Divide the people into the wealthy and the poor. This will cause more discontent and it will be easier to take (Tax) the wealthy with the support of the poor.

Text Messages Reveals Joe Biden Was Involved With Son, Hunter's Business Bobulinski: "the big guy" referenced in the email is Joe Biden.

It's becoming increasingly difficult for Democratic presidential nominee Joe Biden to credibly deny that he was not, as reports from the *New York Post* appear to show, involved in the overseas business dealings of his son Hunter Biden.

Newly released text messages seem to show Hunter Biden arranging a business meeting between representatives of a Chinese company and his father, the former Vice President of the United States of America Joe Biden, The Blaze reported

Latest Evidence

The text messages from May 2, 2017, were obtained and then revealed on Twitter by Sean Davis, the co-founder of The Federalist, and appear to show Hunter Biden setting up a business meeting involving his father, his uncle James Biden, and the now-bankrupt Shanghai-based China Energy Fund Committee.

"Mrng pls let me knw [sic] if we will do early dinner w your Uncle & dad and where, also for document translation do you want it in simple Chinese or traditional?" the first text message reads.

Hunter Biden then replied: "Not sure on dinner yet and whatever is the most common for a Chinese legal DOC."

"Chinese legal docs can be both, i'll [sic] make it traditional," the individual responded.

Hunter Biden then added, "Dad not in now until 11 - lets me I [sic] and Jim meet at 10 at Beverly Hilton where he's staying."

It Happened

According to Davis, another text message appears to show that the meeting did indeed happen.

Davis reported, "The next morning, on May 3, 2017, Hunter's business partner-turned-whistleblower Tony Bobulinski texted James Biden - Hunter's uncle/Joe Biden's brother - and asked him to 'please thank Joe for his time' for the meeting they all had on May 2 to discuss the China business deal."

Bobulinski, who says he was Hunter Biden's former business partner, has recently come forward claiming that he can substantiate some of the reports from the *New York Post* and other outlets, Fox News.

According to Bobulinski, an email from Hunter Biden's laptop which shows "remuneration packages" for six people, including "the big guy," involved in a business deal with a Chinese company, is real.

Bobulinski also said "the big guy" referenced in the email is Joe Biden.

Despite the ever-growing evidence, Joe Biden has adamantly denied any involvement in his son's overseas business dealings. At the final presidential debate, he claimed that "nothing was unethical" and that "I have not taken a penny from any foreign source, ever, in my life."

Was all this Biden business legal or are we witnessing a cover-up?

Senator Bernie Sanders Looking at Cabinet Post Should Biden-Harris Win

Vermont Sen. Bernie Sanders is reportedly making a push to be nominated as labor secretary in a potential Joe Biden administration, sources told Politico.

Sanders is interested in having a position in Democratic presidential nominee Biden's potential cabinet, an unnamed person close to the Vermont senator told Politico.

the Department of Labor, according to the source.


"I can confirm he's trying to figure out how to land that role or something like it," someone close to Sanders told Politico. "He, personally, does have an interest in it."

Sanders wouldn't confirm or deny his interest in being named labor secretary in a statement to Politico.

"Right now I am focused on seeing that Biden is elected president," Sanders said, according to Politico. "That's what my main focus is."

Former Ohio Gov. John Kasich, former Arizona Sen. Jeff Flake and Massachusetts Gov. Charlie Baker are among the "Republicans in Name Only" (RINO'S) whose names have reportedly been floated to serve in a potential Joe Biden cabinet.

However, RINO's like Mitt Romney, Susan Collins and Lisa Murkowski were not mentioned but may still be on a list somewhere as they have been very supportive if the Socialist-Democratic left wing agenda.



Northern California Tribes Opposed To Delta Tunnel Conveyance Water Project

In early March 2020, just weeks before California shut down due to COVID-19, more than 200 tribal citizens, environmentalists and others gathered in the city of Redding to protest a proposed massive water tunnel in the state.

Members of the Yurok, Hoopa Valley, Karuk, Pit River, Winnemem Wintu, Pomo and Miwok nations held an outdoor rally before speaking at a meeting on the Delta Tunnel Conveyance project, saying it would destroy water quality and devastate the state's salmon population and other important fish species in the San Joaquin Delta estuary.

Gov. Gavin Newsom has since released his final "Water Resilience Plan" for California, which includes the underground tunnel, a multibillion-dollar project that would pump billions of gallons of water from the San Joaquin Delta to the southern part of the state.

It also includes a proposed Sites Reservoir dam project in Northern California.

Some tribal citizens worry the governor and other state officials are proceeding without their feedback amid the pandemic and wildfires that have consumed over 4 million acres in the state.

The Karuk Tribe lost many members' homes in recent weeks, as well as important tribal offices. Some have been unable to access Zoom.

"Governor Newsom should honor his tribal responsibility for informed and meaningful consent with all of our California tribes before moving ahead with this destructive project."

Malissa Tayaba, executive director of traditional ecological knowledge and a citizen of the Shingle Springs band of Miwok Indians, also voiced concerns about a lack of participation, noting tribes had to push for the March meeting and citing a recent notice of intent for the U.S. Army Corps of Engineers to prepare an environmental assessment. Tribes also had to fight for two seats on a stakeholder committee, she said.

The governor's office did not return a call and email seeking comment, and a voicemail box for a Califor-

nia Department of Water Resources spokeswoman was full.

The proposed tunnel would be a major addition to the State Water Project, the complex system of reservoirs, aqueducts and pumping plants that deliver water

to more than 27 million Californians and 3 million acres of farmland.

Newsom last year halted a project that would have built two tunnels and carried more water, in part to address environmental concerns.

His administration this year began the first steps in a lengthy review process for the one-tunnel project.

Also this summer, a new contract took effect for California's most powerful water broker, Westlands Water District.

The Interior Department in February awarded the district a permanent entitlement to annual irrigation deliveries that, according to the Los Angeles Times, amount to about twice as much water as L.A.'s 4 million residents use each year.

Westlands has been known to file lawsuits to block endangered species protections that hamper delta deliveries, the newspaper reported.

California tribes have been resisting various delta tunnel projects for decades, saying they would negatively affect salmon and other species and traditional cultural practices, including plants used for medicines and access to sacred sites. They also say the project would harm burial and village sites along the delta.

The Sacramento Delta system is the largest estuary on the West Coast. It is a nursery for hundreds of fish species, including four species of chinook salmon and delta smelt, green and white sturgeon and lamprey, along with hundreds of migratory birds and natural grasses.

Caleen Sisk, Winnemem Wintu chief and spiritual leader, explained that under normal conditions, the Sacramento River flows into the delta from the north and the San Joaquin from the south.

The rivers meet and flow out through the Carquinez Straits into the San Francisco Bay and on to the ocean.

But when the project pumps there now are in operation, they create "reverse flows" that pull water south, Sisk said. The reverse flows negatively impact salmon migration patterns and entrap baby salmon, as well as other fish species necessary for a healthy water system. The natural fresh water springs under the sand will be destroyed when workers dig 150 feet to bury the tunnel, Sisk said.

"Newsom talks about truth and healing for our California tribes after decades of genocidal policies," Sisk said. **"It will not happen if his administration insists on supporting water projects that destroy our salmon and our ancestral homelands."**

State officials say they need

the tunnel because intake for the current system is only 3 feet above the average sea level, making it vulnerable to climate change.

Proponents say it would modernize the state's aging water distribution infrastructure.

California tribes whose homelands are on the delta estuary also are organizing against the tunnel.

Tayaba noted the project directly impacts all tribes along the delta.

"We have been strengthening our traditional practices and culture for the past 30 years," she said. **"We have identified our village sites, collected plants and materials we need for our practices and our lives. This project threatens our birds, plants, animals, fish, sacred sites and burial sites."**

Going forward, Tayaba feels the most important work will be to educate the non-Native delta community about how the tribes use the water and what the entire delta system means for traditional cultural practices.

The tribes have requested but haven't seen any project alternatives at this time. They also are demanding that the state procure their informed consent on any project that affects water and ancestral homelands.

"For many of California's tribes, water and salmon are life. They are intertwined," Gali said. **"We are salmon people. The delta tunnel project will further pollute our water supply and threaten extinction for our salmon."**

State officials say they need **"to show people a better way to do things."**

Mark Johnston, the tribe's executive director, added that the tribe prides itself on being bold and innovative.

"Being the first tribe to have an approved ITAMP is an honor and challenge that we take seriously, and we are well-prepared to carry the burden of going first," he said.

The ability for tribes to exercise this authority was made possible by the Indian Trust Asset Reform Act, which created an avenue to expand tribal self-determination. The Coquille Indian Tribe began developing its plan in 2019 and submitted it to the federal government in June.

"We haven't seen salmon on the Pit River in 80 years, and that is just one example of one tribe's important loss to our way of life," said Morning Star Gali, Ajumawi Pit River and tribal organizer for the group Save California Salmon.

The Coquille Indian Tribe in southwest Oregon has become the first tribe in the nation to receive federal approval to manage its trust forest lands and resources.



An illegal immigrant from El Salvador allegedly murdered one Texas officer and wounded another during an altercation Tuesday at an apartment complex in Houston.

The deceased victim, Sgt. Harold Preston, was a 41-year black police veteran who'd shown up at the complex around 8:00 am in response to a domestic disturbance call from a woman who was trying to move out of her ex-boyfriend's apartment.

"Harold Preston had just bought a breakfast taco at a Whole Foods in south Houston on Tuesday when the call came in: Two officers at a domestic dispute on Holly Hall needed help," the Houston Chronicle reported.

"The 65-year-old Houston Police sergeant headed their way. Preston, who joined the Houston Police Department in 1979, had handled countless domestic calls over his long career. But at 9:25 a.m., a 51-year-old man shot and killed Preston as he tried to escort the man's estranged wife into the apartment to collect her things."

Preston's partner, Ofc. Courtney Waller, sustained a wound to the arm but made it out OK, reportedly thanks to the help of a good Samaritan: Report Advertisement "Harold Preston had just bought a breakfast taco at a Whole Foods in south Houston on Tuesday when the call came in: Two officers at a domestic dispute on Holly Hall needed help," the Houston Chronicle reported.

The suspect, Elmer Rolando Manzano-Martinez, a 51-year-old illegal alien with a history of criminal behavior, was arrested soon after.

"Manzano has convictions dating back to the early 2000s in Texas. He was convicted on two misdemeanor assault charges lodged in 2000 in Dallas County, at least one of which was domestic violence-related," according to the Chronicle.

"Probation on both of those charges was revoked in 2003. In 2002, Manzano plead guilty to a charge of felony evading arrest in Harris County."

Manzano-Martinez also has a history of alleged domestic abuse.

"The shooting closely followed three domestic violence complaints involving Manzano, and Waller encountered the former couple during the complaints on Sunday, Monday and Tuesday," the paper noted.

One of the complaints involved a "terroristic threat," leading some members of Houston's law enforcement community to wonder why he hadn't been arrested.

"After the shooting, some in the law enforcement community had mentioned Manzano could have been charged with making a terroristic threat after one of the weekend calls," local station KTRK noted.

In a statement issued late Tuesday, Harris County District Attorney Kim Ogg, a Democrat, dismissed concerns about his prior lack of arrest. "The only person responsible

for this horrible crime is the killer himself and any attempt to blame prosecutors is sadly political and not factual; the record speaks for itself; the officers in these cases didn't believe that a crime had occurred and that left no evidence on which to base any charges," her office reportedly said.

The good news is that Manzano-Martinez has finally been charged with capital murder of a police officer, attempted capital murder of a police officer and aggravated assault causing serious bodily injury. He's also been denied bail.

The bad news is that there's still no explanation for why he'd been allowed to roam free and was apparently never handed to U.S. Immigration and Customs Enforcement.

Houston's relationship with ICE has reportedly always been rocky.

"The Harris County Sheriff's Office in 2017 ended a program known as 287(g), which partnered with ICE to train a team of county deputies to determine the immigration status of jailed suspects and hold those selected for deportation," the Chronicle notes.

Houston Police Chief Art Acevedo, who appeared at the 2020 Democrat National Convention and endorsed Democrat nominee Joe Biden, isn't a fan of SB4.

"The problem is the perception problem that it creates, that local police officers are going to be more interested in immigration enforcement of people who don't bother anybody," he reportedly said in 2018.

However, he was and still remains a fan of Preston: So does Texas Gov. Greg Abbott.

"Our hearts are with the family of Houston Police Sgt. Harold Preston who was shot and killed in the line of duty this morning. This tragic loss is a grave reminder of the dangers our brave law enforcement officers face while keeping our communities safe," the governor said in a statement following Preston's death.

"Cecilia and I ask our fellow Texans to join us in lifting up Sgt. Preston's family in prayer in their time of need. We also ask all Texans to pray for the speedy recovery of Houston Police Officer Courtney Waller who was shot while responding to the same incident and is recovering in the hospital. The state stands ready to assist the Houston Police Department in bringing to justice the perpetrators of this horrific tragedy."

U.S. Immigration and Customs Enforcement forced to release 250 Criminal Immigrants By Federal Court Order

Officials with Immigration and Customs Enforcement (ICE) said Tuesday the agency was forced to release 250 illegal immigrants with criminal histories in California due to a COVID-19-related federal court order.

The agency made the announcement a week after Senior U.S. District Judge Terry J. Hatter Jr., a Carter appointee, demanded in an Oct. 15 ruling that the agency release or deport migrants who were being detained at the Adelanto ICE processing center in Southern California so as to curb the spread of virus infections.

In a statement, the agency said that "despite requests to transfer detainees to alternative locations," it was forced to release 250 migrants from the Adelanto facility, which is being operated by a federal contractor.

Detainees released included migrants who had criminal histories for a myriad of offenses including assault with a deadly weapon, "lewd/lascivious acts with a child," driving under the influence, child cruelty, illegally reentering the country after being removed and other crimes.

ICE Senior Official Performing the Duties of the Director Tony H. Pham ripped the court order for endangering the public welfare and safety while accusing Hatter of overstepping his authority.

"While opponents who continuously seek to discredit the agency might otherwise mislead the public to believe that those in detention pose no risk to public safety, nothing could be further from the truth," said Pham. "ICE has complied with this overreaching court order; however, the public should know that the ruling un-

doubtedly places them at greater risk."

The Los Angeles Times has reported that California Democrats have sped up the release of thousands of inmates, including one woman who was convicted of murder.

In New York City, meanwhile, criminals released early went on to re-offend, with some 50 former prisoners winding up incarcerated again, the New York Post reported.

The release of 250 detainees left the facility with 465 detainees, or a few less than Hatter demanded. Business Insider reported that at least 162 had tested positive for COVID-19, but

ICE officials said the agency follows "an aggressive inspections program for its detention centers" while following Centers for Disease Control and Prevention

(CDC) guidelines aimed at harnessing the virus. Also, the agency said it limited the number of detainees at Adelanto and was conducting frequent COVID-19 testing there.

"As an added precautionary measure for communities, no detainee was released until officials established a high degree of certainty that they did not pose a COVID-19 public health risk," the ICE statement said.

In Hatter's court, government lawyers argued in favor of keeping up to 1,052 migrants at the facility after citing World Health Organization recommendations that detainees should be kept 39 inches away from each other to limit viral spread — or half the distance the CDC advises.

However, Hatter, 87, criticized that, citing the Trump administration's withdrawal

from the WHO: "The government's reliance on the WHO, therefore, is disingenuous."

In his ruling, Hatter also said that the "case involves human lives whose reasonable court pursuant to the United States Constitution."

The Trump administration has a contentious history with Democrat-appointed federal judges in California over immigration policy. The administration sued California in 2018 over its 'sanctuary' law.

ICE reported in February that 411 detainees who had been released were rearrested and booked into the Orange County Jail for additional offenses including identity theft, domestic violence, and DUI, Fox News reported.


