The Occupation of Alcatraz will forever be immortalized in American Indian History and tribal folklore as the birth of the American Indian resistance against the mistreatment, oppression and domination of the American Indian people by the United States Government.

51-Years Ago On November 20, 1969, 89 American Indians who called themselves Indians of All Tribes (IOAT) took over the small Island of Alcatraz. The Alcatraz Occupation lasted for nineteen months when it was forcibly ended by the U.S. government on June 11, 1971.

The Occupation of Alcatraz is the most significant achievements in the history of the American Indians and the U.S. Government. It should be declared National Day or Recognition by the 500 plus Tribal Governments. Why, because it changes the tribal relationship between the Tribal Governments and the U.S. Government forever. "Alcatraz Day" would be a fitting formal National holiday replacement for Columbus Day.

The occupiers specifically cited their treatment under the Indian termination policy and accused the U.S. government of break-

ing numerous Indian treaties.

In Nixon's July 8, 1970, Indian message, he decried termination, proclaiming, *"Self-determination among Indian people can and must be encouraged without the threat of eventual termination."*

By late May 1971, the government had cut off all electrical power and all telephone service to the island.

Left without power, fresh water, and in the face of diminishing public support and sympathy, the number of occupiers began to dwindle. On June 11, 1971, a large force of government officers removed the remaining 15 people from the island.

Though fraught with controversy and forcibly ended, the Occupation is hailed by many as a success for having attained international attention for the situation of native peoples in the United States, and for sparking more than 200 instances of civil disobedience among the American Indian tribal people.

IMPACT: The Occupation of Alcatraz had a direct effect on federal Indian policy and, with its visible results, established a precedent for Indian activism.




## CIMC's Lorenda Sanchez Awarded Honorary Doctorate



When the U.S. entered World War II, military leaders remembered the success of the Choctaw Code Talkers and enlisted new recruits from the Navajo, Kiowa, Hopi, Creek, Seminole, and other tribes to encrypt messages for the Army and Marine Corps.

Working with Navajo leaders, the Marine Corps initially recruited 29 Navajo men to train as Code Talkers in specially designed courses. By the end of the war, the Marines had over 400 Navajo men trained as Code Talkers, many of them serving in the Pacific Theater. The Army had similar training programs for its Code Talkers, who generally served in Europe and North Africa.



Photo above was taken in Viet Nam in 1966-67 by an unknown photographer and was posted on the internet. The good looking guy, second from the right is Richard "Dumbo" Salgado. He served with the 1st Calvary Airborne Division in Viet Nam. Richard is a tribal member of the Soboba Band of Luiseno Indians. He currently lives in Palms Springs CA. Richard's Father and brother are also veterans. His father, Ernest Salgado Sr., served in WWII and his brother Ernie Jr. was in the Army National Guard and was called to active duty in 1966.



Corporal, Ira Hamilton Hayes, A Pima American Indian and five other U.S. Marines were photographed on February 23, 1945 by Joe Rosenthal. *"Raising the Flag on Iwo Jima"*

The photograph became a famous iconic winning the Pulitzer Prize for Photography and came to be regarded in the United States as one of the most significant and recognizable photograph taken during WW II. It depicts six United States Marines raising the American flag atop of Mount Suribachi on the island of Iwo Jima.

## Girl Scouts Lack Leadership After Justice Barrett Fiasco

Amy Coney Barrett was sworn-in as an associate justice on the U.S. Supreme Court on Monday, becoming the fifth woman ever to be confirmed to the prestigious position.

It was an accomplishment the Girl Scouts of the USA wanted to celebrate — but after posting a tweet congratulating the new justice, the group swiftly faced pushback from many on the left. **The backlash prompted the organization to delete its original tweet — but now, according to The Daily Wire, they're taking some serious flak for the reversal.**

The tweet from the Girl Scouts appeared innocent enough. According to the Daily Wire, it read plainly: ***"Congratulations Amy Coney Barrett on becoming the fifth woman appointed to the Supreme Court since its inception in 1789."***

Attached was an image above that featured pictures of the five women justices, Sandra Day O'Connor, Ruth Bader Ginsburg, Sonia Sotomayor, Elena Kagan, and now, Amy Coney Barrett.

It was apparently too much for many on the left, however, and it didn't take long for the Girl Scouts to bow to the leftist mob.

According to the Daily Caller, the organization said they didn't want to make a "political or partisan statement."

***"Girl Scouts of the USA is a non-political, nonpartisan organization. We are neither red nor blue, but Girl Scout GREEN. We are here to lift up girls and women,"*** the group said, as the Daily Caller reported.

**"Pathetic" and "Sad"**

Supporters of Barrett were, predictably, outraged at the development.

According to the Daily Caller, former Fox News host and ex-NBC contributor Megyn Kelly refused to accept the group's ***"pathetic"*** excuse, tweeting: ***"It's not 'partisan' to generically congratulate the 5th woman ever to join the High Court. It's patriotic."***

Joining Kelly in the sharp critique of the Girl Scouts was the Independent Women's Forum, which wrote in a thread of tweets: ***"Of course the [Girl Scouts] caved to the mob and deleted this tweet congratulating Amy Coney Barrett. SAD."***

In a similar vein, National Review's Erin Hawley pointed out that the Girl Scouts have posted decidedly partisan and political tweets from in the past that they didn't feel compelled to delete.

***"Sadly, the message to our young girls is clear: Your success matters only if you subscribe to a certain type of progressive feminism,"*** Hawley wrote Thursday.

The Securities and Exchange Commission (SEC) charged a company co-founded by Paul Pelosi Jr. with fraud in 2019 after learning that two convicted criminals were running the business.

The SEC said the company was ***"secretly controlled"*** by James E. Cohen and Joseph Corazzi, both of whom had previous fraud convictions.

The SEC charged four individuals with fraud, including former New Mexico Gov. Toney Anaya, and suspended trading in the company's stock. Pelosi owned over 10 million shares in the company in 2009.

The SEC suspended trading in Natural Blue stock. A notice filed in the Federal Register on by Jill M. Peterson, assistant secretary of the SEC, revealed that the company has not filed any periodic reports, which are required by law, with the SEC in four years.

***"It appears to the Securities and Exchange Commission that there is a lack of current and accurate***

***information concerning the securities of Natural Blue Resources, Inc. because it has not filed any periodic reports since the period ended September 30, 2010,"*** Peterson said, in the order announcing suspension of trading.

The Free Beacon reported that Pelosi was still listed with The New Mexico Office of the Secretary of State Business Service Division as the president of **Natural Blue** at the time it filed the report.

The New Mexico Office of the Secretary of State Business Service Division had designated Natural Blue as a company ***"not in good standing."***

***House Speaker Nancy Pelosi's son Paul Pelosi Jr. visited Ukraine in 2017 to meet with government officials in connection to a business initiative.***

***Now, unearthed records reveal that Paul Pelosi Jr. was an executive of a gas industry company that did business in Ukraine - and his mother Nancy Pelosi was featured in one of the company's promotional videos.***

**SURPRISE! THAT TWEET WAS REMOVED!**

The American Mirror, flagged Pelosi Jr.'s appearance in 2017, preserved a clip of Pelosi Jr. on the Ukrainian station following the video's removal from YouTube.

## Candace Owens: 'If you believe that government can stop a virus, then you are an idiot'

Conservative activist, author, and BLEXIT founder Candace Owens is blasting out some final warnings to last-minute voters and she is as blunt as ever in her choice of words.

Owens took to Twitter to tell her nearly three million followers that without social distancing from socialism, totalitarianism is the end game. The authoritarian leanings of mostly Democrat governors and other elected officials are laying the groundwork for a reversal of the country's traditional free-market system.

***"At this moment, our governments are telling us when to open our businesses, when to see our family, and when and how we are allowed to BREATHE. This is NOT America. This is not FREEDOM. This is NOT about safety or a virus. This is about implementing SOCIALISM. Wake up,"*** she wrote.

A subtweet from Owens ominously quoted former U.S.S.R. boss Nikita Khrushchev who bragged that his regime planned to weaken the U.S. with incremental socialism ***"until you fall like overripe fruit into our hands."***

On the theme of unchecked governmental authority, the California bureaucracy, for example, under ultra-liberal Gov. Gavin Newsom, has even gone so far as to promulgate guidelines that imposes certain limits on family Thanksgiving celebrations, including banning indoor feasts.

In a separate tweet, Owens expressed the belief that people are lapsing into what might amount to the Stockholm syndrome by accepting government edicts at face value.

***"If you believe governments are stripping away rights and monitoring are every move because they care,***

***then you possess the logic of a slave who has fallen in love with its master."***

The power grab may be backfiring on Democrats. Trafalgar Group chief pollster Robert Cahaly told FNC's Maria Bartiromo on Sunday Morning Futures that President Trump's reopen-America message is sending late deciding voters, including some Biden-leaning voters, into the GOP column.

***"The issue we see moving on is shutdowns. Even young voters who identify that they don't like the president, they like shutdowns even less. Even suburban women who say they have problems with the president, they like their children at home in shutdowns even less."***

France, Germany, Spain, and the U.K. are currently heading to lockdown status one kind or another as



a result of a surge in COVID infections.

It had always made sense that Papa Joe had at least looked the other way when Hunter invoked in the Vice President's name to get lucrative payouts from two of our most threatening foreign rivals: Russia ( *through their Ukrainian oligarchs*) and China ( *through the Bank of China*). Somewhat in parallel, as Trump was being impeached, it was obvious the media was looking away from Joe Biden's condoning of his son's corruption.

**But the newly unearthed Hunter Biden communications**, documenting active Joe Biden corruption, indicts both our former Vice President and our left-leaning media for fraud and treason.

**Joe Biden's defenses** – of never having been involved with or spoken to Hunter about his son's businesses – were first given the lie by a newly revealed April 17, 2015 email from corrupt oligarchic Burisma Holdings third in command, Vadym Pozharskyi to Hunter Biden regarding the meeting Hunter had arranged in D.C. with his father, one conveniently omitted from official records:

*“Dear Hunter, thank you for inviting me to DC and giving an opportunity to meet your father and spent [sic] some time together. It's really [sic] an honor and pleasure...”*

Had Burisma hired Hunter Biden in 2014 with the expectation of help from father Joe? A May 12, 2014 email from Pozharskyi to Hunter, when the heat was on Burisma, says so:

*“We urgently need your advice on how you could use your influence to convey a message/signal, etc to stop what we consider to be politically motivated actions...”*

Is it possible, though, notwithstanding his false denials about communications with his son, that Joe Biden was an innocent dupe of Hunter, who used his father to get big paydays? Not if you put any sensible interpretation on Hunter's text to his daughter, strongly suggesting that Joe was Hunter's criminal partner, sharing in his son's corrupt largesse:

*I love all of you. But I don't receive any respect and that's [sic] find I guess – works for you apparently. I Hope you all can do what I did and pay for everything for this family Fro [sic] 30 years. It's really hard. But don't worry unlike Pop I won't make you give me half your salary.*

Is there other evidence that Joe partook in Hunter's corrupt lucre? Certainly. In one deal to partner with a Chinese energy firm, a May



13, 2017 email describes remuneration packages for six people, including a line that suggests Hunter was to hold a 10% interest in the company for the benefit of the “big guy”:

*At the moment there s a provisional agreement that: 20 H, 20 RG, 20 JG, 20 TB, 10 Jim, 10 held by H for the big guy?*

If Hunter earlier got a 10% interest in a 1.5 billion (now \$2BB) Bank of China fund, , how much of that 10% was held for the “big guy”?

Since this 10% interest was worth \$3MM-\$10MM million annually in fees, half of these earnings may be earmarked for Joe. One way or the other, it is not irrational to conclude that China owns Joe.

**On April 13, 2014**, Hunter had not yet been publicly announced as a Burisma Board Member. As his father was preparing to fly to Ukraine, Hunter emailed Archer to put this trip in the context of their corrupt assistance through “my guy”, in order to negotiate what Hunter had hoped would be a \$25,000 monthly fee:

*We need to ask for long term agreement and across the board participation. This is a huge step for us that could easily become very complicated. And if we are not protected financially regardless of the outcome we could find ourselves frozen out of a lot of current and future opportunities.*

*The contract should begin now- not after the upcoming visit of my guy.*

*That should include a retainer in the range of 25k p/m w/ additional fees where appropriate for more in depth work to go to BSF for our protection. Complete separate from our respective deals re board participation.*

**On April 14, 2014** the U.K. in London, encouraged by their joint anti-corruption efforts with the U.S., seized \$23 million of Burisma's founder Mykola Zlochevsky's wire of funds directed to Cyprus.

Two days later, Hunter's partner Devon Archer met in the White House with the Vice President past midnight. Only a fool would believe this meeting was not related to Burisma and to the potential hiring of Archer and Hunter.

**On May 13, 2014**, Hunter was announced as a Burisma Director with a role in “corporate governance.” His pay has been reported alternately as \$50,000 or \$83,000 per month.

**Did Joe deliver for his son?** A letter to the U.K. court from a Ukrainian prosecutor never came once Hunter Biden was hired, the British court did not send the \$23 million back to Ukraine, but was now forced, without the letter, to allow the money to proceed to Zlochevsky's bank account in Cyprus. But that \$23 million is chump change.

**Very quickly, at the urging of Vice President Biden and Secretary of State John Kerry**, the IMF lent an emergency \$4.91 billion for the Ukrainian finance sector to keep the banking system afloat.

Immediately Hunter's client Igor Kolomoisky ( *an owner of Burisma through his PrivatBank Group*) lent \$1.8 billion of it to shell companies in Cyprus, backed by fake contracts with other shells. Eventually, Kolomoisky and PrivatBank looted U.S.-backed foreign aid for \$5.6 billion.

**Famed American investigator Kroll & Company** found that the looting ended at the end of 2016, when, not coincidentally, Joe Biden was going out of power. Also, not coincidentally with the Vice President gone, Kolomoisky fled the Ukraine while its Central Bank, now freed of Biden's influence, finally seized control of the bank and received \$5.5 billion in **International Monetary Fund (IMF)** funds to reflate it.

**Earlier in 2016, Joe Biden** had withheld \$1 billion in foreign aid until an anti-Burisma prosecutor was fired. The three pending Burisma cases were now transferred to the National Anti-Corruption Bureau of Ukraine (NABU), a U.S. stepchild and staffed with an agent from James Comey's FBI. Right before Biden left office, NABU dismissed two of the three cases, and settled the last with a token \$7 million payment.

**So as his father** was leaving office, Hunter's clients had succeeded in stealing billions of dollars, largely plundered from or repaid by foreign aid.

All was well thereafter except that Ambassador Marie Yovanovitch, Biden's-recommended holdover, denied visas to former Ukrainian prosecutors wanting to visit the U.S. to complain about the Biden centric corruption.

Their pleas were ignored by Comey's FBI, by church mouse Deputy Attorney General Rod Rosenstein, and of course, by Yovanovitch's State Department.

By the time the complainants got to Rudy Giuliani, Volodymyr Zelensky had been newly elected and only President Trump under diplomatic protocol could complain to him about Biden's corruption.

**When Trump tried to get Zelensky to investigate the Biden-centric corruption**, he was impeached on the fabricated complaint of a third party pro-Obama Deep State operative “whistleblower” all of which was not a crime or wrong doing.

However, Biden one again escaped being held accountable.

**While the sham partisan impeachment was proceeding**, the American media ignored an existential drama in the Ukraine, a country about which the impeachers claimed to care deeply. Zelensky had been strongly supported in his election bid by the exiled Kolomoisky, who had owned the television network on which Zelensky had become famous, and had supported his campaign lavishly.

**Indeed, when Zelensky was elected**, Kolomoisky felt secure enough to return to Ukraine, a development noticed with alarm by the IMF.

The IMF made it clear that Zelensky would have to demonstrate his anti-corruption credentials, and distance himself from ( **formerly Biden protected**) Kolomoisky. If not, IMF would cut off Ukraine, leaving it to oligarchic Russian influence.

Had President Trump successfully importuned Zelensky to investigate the Biden-enabled corruption, which would have centered on Kolomoisky, and had Zelensky therefore shown himself to be free of Kolomoisky corruption, the IMF would have been comfortable loaning billions to Ukraine and saving it for NATO and the United States.

Just as Zelensky was relenting, with the impeachment Zelensky now was now allowed to lay off Kolomoisky, and, indeed, was forced to stand down, to the great national harm of Ukraine.

**Kolomoisky**, now emboldened by the impeachment, petitioned to have his previously seized, now re-flated, PrivatBank returned to his ownership. It was not surprising that Kolomoisky, with his bread no longer buttered on the anti-corruption Western side, announced that Ukraine would have no choice but to pivot toward Russian influence.

**How our major media treated these earth-shaking disclosures?** By silence, mainly, with a few jabs suggesting that the Biden laptop is Russian disinformation, an impossible reconstructive feat.

This is the same media to which it never occurred that Christopher Steele employed Russian spies to document a Trump-Putin collusion, seemingly Russian disinformation to assist his covert sponsor **Hillary Clinton**.

The masthead of the *Washington Post* claims, “**democracy dies in darkness.**” In light of the media concealment of a presidential candidate's corrupt involvement, the Grim Reaper is now briskly striding toward the Land of the Free.

### "The Coronavirus Impact On The World & Rez!"

Covid-19 has had many impacts of every society around the world. The identification and impact(s) will take years to unravel, analyze and mitigate.

On a much more local level, the "impact" of stay-in-place recommendations/orders has given many of us the time to go through those paper piles on the dining room table and throughout the office as well as boxes and envelopes containing pictures and other ephemera.

The luxury of hours not spent commuting, attending meetings, cooking for gatherings, or "visiting" around gives the appearance of a slow-down in lifestyle; in reality, it is the great confrontation with conscience about that to-do list that keeps growing but keeps being ignored.

Much of this paper and other stuff are your "archives". Why did you keep them? Do you want your descendants to see them? Do they reflect your or community history, making them bailable long snout valuable to tribal archives, local and other formal archives.

The professional definitions of an archive has been diluted so much since my early training but *"the documents showing the history of a place, organization, or family, or the place where these are kept"* (by ) is

the closest to what I believe. Archives not only provide interesting history, but also are the basis for creating, protecting and preserving legal rights.

Because of all the technology available, microfilming to discs to flash drives, the opportunity to reduce the clutter and/or to share with siblings and friends becomes easier. But what to do with the originals?

Many records managers say they can be tossed once replicated electronically. I have some reservations (no pun intended) because unless one utilizes a professionally certified duplication process that meets legal standards, there is wiggle room for courtroom drama challenging whether or not a document has been electronically altered.

Additionally, we know that paper lasts about 100 years but many digital methodologies have not been around long enough to develop a track record. We do know, for instance, that tapes stored near telephone or electric circuitry can become "erased".

As I have been involved with several cases where the original photography or oral history has been verified by a scrap of original paper, I am overly cautious about throwing stuff out. (Subsequently don't visit

my office!). The legal pressures on many tribal rights only serve to strengthen my conservatism.

While many of you readers don't have to worry about this, that pile of pictures does deserve your attention. There are few things as depressing as inheriting or being gifted a box of pictures of people you have no idea of who they are and can only guess approximate dates by hair styles, glasses, cars or geographic features in the background.

So get a good cup of coffee and a Number Two pencil and start labeling pictures on the back:

- *Names of people portrayed (you may want to include relationships)*
- *Location (specifics, not just "home"/"in-town"/"rez")*
- *Approximate date/specific date if you know it*
- *Occasion/significance of photo (birthday, powwow, meeting, visitors, etc)*
- *Special things to notice in pic*
- *For landscapes, you may wish to include names (USA geographical/traditional) of hill/mountain ridges, water features, etc.*
- *Point out any flora or fauna, again by "common name" and/or traditional*

Remember, this is one way for you to "talk" to your progeny, several generations hence. Think about what you want them to know. While "a picture is worth a thousand words", those words give context and explanation.

Don't try to do it all in a day. Just "resolve" to do as much as you can while enjoying that cup of "jo" each day. When you have done what you can do but have a pile of pics without enough identification data, then it is time to enlist others. With social distancing, this may preclude one-on-one (I always enjoyed taking material to senior citizen lunches), you can accomplish much with posting on FaceBook and other media as well as private communication asking for help in providing pertinent information.

If you are extremely motivated, you can create an electronic bibliography for each pic. Just develop a numbering system that is comfortable for you. Make sure to have at least one flash drive with the information stored in another place than where you keep your computer.

We'll discuss paper/manuscripts another time. Get busy.


