Another Jesus statue beheaded, destroyed



The Catholic Diocese of El Paso said the 90-year-old Sacred Heart of Jesus statue inside St. Patrick Cathedral was destroyed around 10 a.m. Tuesday, September 15, 2020 when the church was open for prayer, the El Paso Times reported.

The statue was on display behind the main altar of the church, the paper said.

Father Michael Lewis told KTSM-TV that *"it does feel like an attack on our faith. It feels like an attack on our community and what ties us together, brings us together."*

But Lewis added to the station that the person responsible *"damaged the statue, but he can't damage our faith."*

Plans are in place to have the statue repaired, KTSM added.

El Paso police identified the man accused of destroying the statue as

Isaiah Cantrell, 30. He was arrested and charged with criminal mischief and possession of marijuana, the paper said, adding that he was booked into jail on bonds totaling \$20,500. the statue, the El Paso Times reported.

Bishop Mark J. Seitz told the Times the statue is one of his *"favorite representations of Jesus,"* and that while he's sad it was destroyed, he's praying for the culprit.

"He certainly must be a person who is greatly disturbed to have attacked this peaceful place in our city and this image of the King of Peace," Seitz added to the paper. *"I hope this might be the impetus for him to receive the help he needs."*

In July, a statue of Jesus was found decapitated at a Catholic Church in South Florida, and a statue of the Virgin Mary was burned outside a Boston church.

Mitt Romney Supports Trump's Supreme Court Nomination

Senator Mitt Romney, a Utah Republican, dismissed concerns from Democrats that the Supreme Court will become more conservative if President Donald Trump's nominee to replace Justice Ruth Bader Ginsburg is confirmed.

"I recognize that we may have a court which has more of a conservative bent than it's had over the last few decades," he said. *"But my liberal friends have over many decades gotten very used to the idea of having a liberal court. And that's not written in the stars."*

Although Romney said he understands that many Americans don't want the court to become more conservative, he argued it would be appropriate for the country.

"It's also appropriate for a nation—which is, if you will, center right—to have a court which reflects center-right points of view, which again are not changing the law from what it states but instead following the law and following the Constitution," the senator said.

"I intend to follow the Constitution and precedent in considering the president's nominee. If the nominee reaches the Senate floor, I intend to vote based upon their qualifications," Romney said in his statement earlier on Tuesday.

Historically, during a Presidential election year when the senate and the president are opposing political parties 9 out of 10 times the senate

blocked the presidential nomination supreme court nomination as was the case in 2016. But when the senate and the president were of the same political party 17 out of 19 times a supreme court justice was approved.

Murkowski of Alaska and Susan Collins of Maine have cited their 2016 position, as well as fairness, in opposing confirmation of Trump's nominee before the election.

However, Romney put it in perspective. *"My decision regarding a Supreme Court nomination is not the result of a subjective test of 'fairness,' which, like beauty, is in the eye of the beholder. It is based on the immutable fairness of following the law, which in this case is the Constitution and precedent,"* he said. *"The historical precedent of election year nominations is that the Senate generally does not confirm an opposing party's nominee but does confirm a nominee of its own."*

While Murkowski and Collins spout *"fairness,"* millions of law abiding American citizens are not allowed to work, attend church services, operate their small businesses or even visit family members in some liberal states, yet Socialist Democrat anarchist are allowed to have free reign to riot, loot and destroy public property and not a peep from them. And not one case of Covid-19 has been reported.

A Catholic voters group has launched a \$9.7 million campaign against Democratic presidential nominee Joe Biden, targeting Catholic voters in swing states.

"Joe Biden's record makes clear he will not protect our Catholic values or defend our way of life," CatholicVote President Brian Burch said in a statement. **"For Catholics who cherish the Faith and their freedom to live it, a Biden presidency represents an existential threat."**

The CatholicVote video ad focuses on Biden's **"radical stance on abortion,"** with the narrator saying **"Joe Biden would force American Catholics to pay for abortions, sacrificing his Catholic values to kneel before the leftist mob."** **"The murdering of unborn babies is plain evil."**

After criticism last year, Biden backtracked from his previous support of the Hyde Amendment, which bans federal funding for abortion under government programs like Medicaid.

The organization also released **"The Biden Report for Catholic Voters,"** which covers Biden's career **"from a Catholic perspective"** and highlights where he stands on issues like **"sanctity of life,"** religious liberty, judges, education and the dignity of work.

vice." Hussain is also listed as **"a scholar at the Texas-based Qalam Institute."**

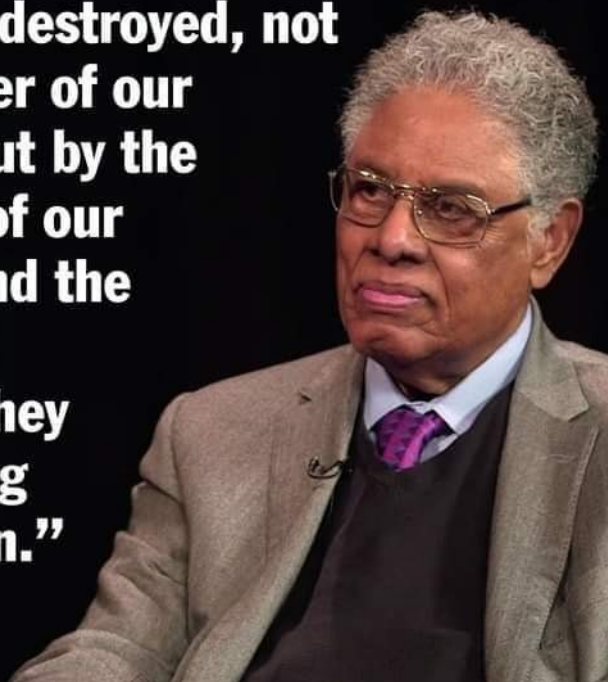
He isn't the only one of their leaders with controversial views. They all want sex slaves.

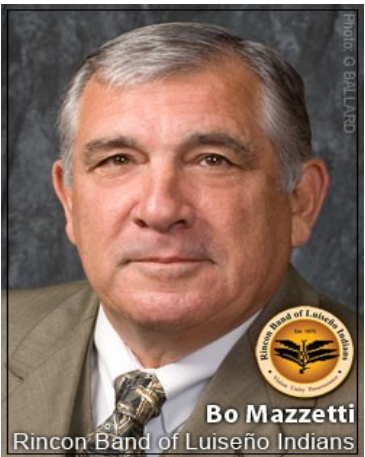

California became the 31st State on September 9, 1850 after the Mexican-American war 1846-48. The Treaty of Guadalupe Hidalgo to end the war was signed on February 2, 1848.

The Treaty included specific rights for the Indigenous people. But instead the California Tribal people were left to fend for themselves and many tribes were annihilated. -

A \$5-bounty for the wholesale murdering of California Indian men, woman and children was offered by the State with their scalps as proof of death.

This act of ***“Ethnic Cleansing or Genocide”*** was subsidized by the federal Government.

The Mission Indian Federation was one of the strongest and influential American Indian political organizations in the nation from 1920 to 1960 but many believe it ended with the death of its leader, Adam Castillo a Soboba tribal member in 1953.

Beginning in 1953 with the federally issued Public Law 280 in California, the State and Counties began to expand their regulatory jurisdiction over the California tribal governments.

A majority of the San Diego County American Indian Tribes were in an on-going conflict with the Country over jurisdiction resulting from the ambiguities of Public Law 280.

And more specifically the confrontation with the San Diego County Sheriff, John Duffy who was charged with enforcing the will of the San Diego County officials.

During these early days the tribal leaders were without representation or an organized method of combating the continuous infringements of the their sovereignty, specifically their jurisdictional right on their respected reservations.

Several tribe had filed law suit against the Federal Government, State and County but in the interim the Federal Courts failed to halt the attacks on the tribes.

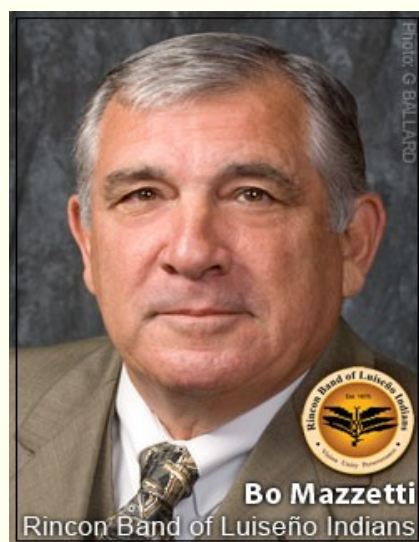
The federal court, in consort with the federal governments attorneys simply stalled the law suits.

These actions by the States, Counties and federal officials against the American Indian Tribes fueled the

movement for Tribal Rights on many front. The most publicized were the Occupation of Alcatraz in 1969 and the exploits of the American Indian Movement including the siege at Wounded Knee in 1973.

However, many other tribal leaders chose to take up the battle through the political process, education and the unification of the Tribal Government.

One of those individuals was a youngster, Bo Mazzetti a Tribal member of the Rincon tribe in north San Diego County, He was also elected to the Rincon Tribal Council and was serving as the Indian Affairs Officer for San Diego County.



Although Mazzetti was only 24-year old in 1972 he is a U.S. Navy veteran and had earned a BA degree in engineering from Cal Poly Pomona, California.

And he grew up learning tribal politics at the kitchen table from his father, Max “Governor” Mazzetti who was a highly respected tribal leader. Bo is the current Tribal Chairman for the Rincon Tribal Council.

In 1972, the San Diego County Tribal Chairman's Association (SDCTCA) concept was initiated by Bo Mazzetti.

With the assistance of California Indian Legal Services (CILS) Office in Escondido, California the San Diego County Tribal Chairman's Association (SDCTCA) was formed. ***“There was a need to create a unified front due to the fact that almost every reservation in San Diego County was having major issues and constant confrontations with the San Diego County Sheriff, John Duffy.”*** Mazzetti said.

The SDCTCA was official chartered on January 30, 1972 and consisted of 9 San Diego County tribes.

In 1975 the San Diego County Tribal Chairman's

Association changed its name to the Southern California Tribal Chairman's Association (SCTCA) and expanded its membership base.

For the past 45-years the SCTCA has served as a prime example of tribal unity, rely on each other for support and political power. The SCTCA has grown to include 20 tribes in San Diego, San Bernardino, Santa Barbara and Riverside Counties.

In 1976 the first California Tribal Chairman's Association (CTCA) was officially formed. Again, California Indian Legal Services (CILS) assisted with putting the organizational documents together. Alex Garfield, chairman of the Tule River served as the first chairman.

The statewide organization grew out of the of the Southern California Tribal Chairman's Association model. The CTCA association gradually developed a strong political presents in a short time, however due to the subtle undermining by the BIA causing conflict between the tribes and the limitations on funds for the organization the organization was abandoned in 1980-81.

After the disbanding of the California Tribal Chairman's Association tribal leaders lost touch with each other. With the introduction of gaming the tribal lawyers and lobbies were interacting but the individual tribal leaders remained distant from each other.

Over the years, one of Chairman Marzetti's goals was to work with the tribes thought out the state to bring them together again, to work collectively to address the numinous issues facing the tribes.

Chairman Mazzetti stated ***“When I was on my tribes Council, in the early 1970's tribes and councils new each other throughout the state. But by the 1990's not that many tribal leaders even know each other no less had a direct relationship with one another.”***

The Bureau of Indian Affairs separated the California tribes into three geographical regions northern, central and southern which allowed them to maintain their control over the tribal government by keeping them iso-

lated om each other with the exceptions of the tenure Mission Indian Federation from 1920 to 1960 and the California Tribal Chairman's Association from 1976 to the early 1980s.

And although in 1976 the U.S. Supreme Court ruled that the State and Counties did not have any jurisdiction except for specific crimes they continue to attempt to force their jurisdiction over tribal lands.

The goal for all of us to have Indian gaming and that work and those efforts turned out positive, but we lost one of the main things we historically had, tribe to tribe relationships and support of and for each other.

It was his goal to get back to the old days when tribal leaders knew each other on a first name basis and if there was any issue we just need to contacted and talk directly with each another, leader to leader not thought attorneys, lobbyist or someone else.

Chairman Mazzetti goal was to bring the California tribal leaders together to reach out to each other and then to organize Tribal Chairman Associations in central and norther California with one day forming the California Tribal Chairman's Association comprised of all three regional Chairman's Associations.

Chairman Mazzetti, working over a period of several years to develop and improve relationships between the tribes on a statewide level has been successful.

Mazzetti thought that since he knew the majority of the tribal leader throughout the state, he kept encouraging the Northern and Central California tribal leaders to organize and form their own regional Tribal Chairman Associations.

In Central California he work with Chairman Marshal McKay of the Yocha Dehe to help organize the Central California Tribal Chairman's association.

In the Northern California he work with Leonard Masten for the Hoopa Tribe and Chairman Garth Sundberg of the Trinidad Rancheria.

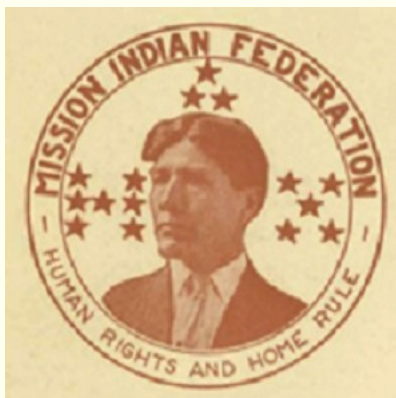
On January 14, 2015, 22 tribes from the central California region met at the Colusa Indian Reservation and voted to form the Central California Tribal Chairman's Association As

the newly developing northern and central Tribal Chairman's Associations were developing and organizing, Mazzetti moved on to his goal and started organizing and coordinating the development of the statewide organization that would eventually become the California Tribal Chairpersons Association.

On June 20, 2018 the first statewide meeting of the three Chairman's Associations, Southern, Central, and Northern was held in Sacramento, California. All the tribal leaders who attended voted and strongly supported the creation of the California Tribal Chairperson Association. At the meeting each of the three associations selected 3 representatives to represent their regional association as members of the board directors for the California Tribal Chairperson Association. On April 9, 2019 the California Tribal Chairpersons Association (CTCA), formally establish as a statewide American Indian Tribal organization to collectively address critical issues facing tribes in California.

The first formal organizational meeting for the California Tribal Chairperson Association was held in Sacramento on September 25, 2019. At this meeting 2-representative from each of the three regional Tribal Areas were selected to represent the organization as it Executive Board.

the CTCA Executive Board consisting of; Bo Mazzetti-Chairman of Rincon Indian Reservation was elected Chairman, Michael Hunter-Chairman of Coyote Valley Band of Pomo was elected Vice Chair, Erica Pinto-Chairperson of Jamul Indian Village was elected Secretary, Garth Sundberg-Chairman of the Trinidad Rancheria was elected Treasure, and Dale Miller-Chairman of Elk Valley Rancheria and Kevin Day-Chairman of Tuolumne were elected as Members at Large for CTCA.

Anyway, Politico recently intoned, **"The death of the city: Teleworking, not the coronavirus, is making urban living obsolete."**

Along the theme I have constantly hammered, twenty years later we ARE in the information age and our world, should we choose such, is dominated by technology (and a big dose of artificial intelligence).

Now the "Pandemic" has caused many things, mainly commerce, to shut down and basically telling us to "cool it" and sit and contemplate what is truly important. We have had a lot of time to consider what is important, what is needed for survival.

And on another battlefield, our public institutions, public schools/libraries/public health agencies/courts, are under siege and threatened with disappearance.

It is no secret that we are headed for some extremely poor financial times over the next few years.

All this may sound doom-sayerish.

To me, at worst, it means the glass is half full. Personally, I think it one of the most exciting times for tribes.

Most nations are small enough to intimately know their constituency and develop a conceptualization of where they want to go.

Because federal and foundation largesse will vastly shrink, each community will have to really think about how they want to live over the next decade, what values and legacies they wish to honor and retain, and how to accomplish such in a self-sustaining manner.

Tribal Sovereignty persists. It is a time to be creative, to assert the

world as you wish it to be, not as it is or was.

So is your tribe in an inclusive planning mode? Has the community articulated its vision of the next era? Can the community articulate what is important/what is not? What is needed to survive?

There are two definitions of "vision" that are particularly apt:

- 1) the faculty or state of being able to see; and
- 2) the ability to think about or plan the future with imagination or wisdom.

Do you want to go "back to the future", do you want to create a community that exists on traditional beliefs and economy?; do you see a new hybrid in which "indigenous knowledge and skills are melded with 21st century technology? There are many more options. What are yours?

Then, of course, comes the assessment of human, real property and asset assessment, both now and ten/twenty years hence.

What skill sets do community members possess? (*This means what is your human resource, from 0-80+ youngsters at heart*). What ones are needed? (*Organized into five year increments*)

(Remember, for every "job" taken by a computer, answering service, ect) a computer programmer or repair-person must be acquired).

What physical assets does the Tribe possess? (physical structures/minerals/natural resources/right of ways/etc.) Can/should they be leveraged to attain self-sufficiency?

What are the "gap and barriers" in your current situation that need to be addressed and overcome? How will this occur?

For starters, do you have the following and do they need to be updated or shared with the Community?

Everyone needs to be on board with a shared vision in order to make all the little pieces of a community synchronize, work in unison, be transparent in impact and flexible in meeting change.

- a. Overall Economic Development Plan
- b. Tribal Specific Health Plan
- c. Tribal Specific Education Plan
- d. 21st Century Technology Plan
- e. Capital Improvement and Maintenance Plan
- f. Tribal Government Training Manual


