BREAKING REPORT: First Extremist To Enter Capitol Building During Siege Identified As BLM/Antifa Activist: “We gotta f* * *ing rip Trump right outta that office!”

Far-Left Antifa/BLM activist John Sullivan has been identified as one of the people who allegedly was part of the siege of the Capitol building you know, he was one of the “violent Trump supporters” we’ve been hearing so much about in the news.

Independent journalist Andy Ngo was first to identify John Earle Sullivan, who was arrested on July 10, 2020, in Provo, Utah.

From the Deseret News - One of the organizers of a protest in Provo that resulted in a motorist being shot was arrested a few days ago.

John Earle Sullivan, 25, of Sandy, was booked into the Utah County Jail for investigation of rioting, making a threat of violence and criminal mischief.

Sullivan is part of the Insurgence USA group, according to a police affidavit.

“As a protest organizer John Sullivan is heard and seen as he is promoting protesters to block roadways, keeping motorists from traveling lawfully and freely.”



Sullivan was also captured on video threatening to beat a woman in an SUV, according to the affidavit, and then kicking her door, leaving a dent.

Sullivan was seen with Jesse Taggart — the man charged with shooting the motorist — throughout the protest, the affidavit states.

“As a protest organizer, John Sullivan is heard talking about seeing the shooting, looking at the gun and seeing smoke coming from it. John did not condemn the attempted murder nor attempt to stop it nor aide in its investigation by police.”

Sullivan’s Instagram page is filled with activist posts that contain language like “F*ck Trump.”

In a video Sullivan identifies himself as *“John Sullivan of Salt Lake City, Utah, and part of Insurgence USA”*

Near the end of the video, Sullivan tells the crowd, *““ We gotta f* * *ing rip Trump right outta that office!”*

That’s not all...apparently he was interviewed by CNN’s Anderson Cooper last night.

This friend of Sullivan’s asked who paid him, *“Possibly the DNC?”* she asks, tagging another friend. The friend who she tagged replied by *“liking”* her comment!

But wait, there’s more...

One of John’s friends called “lefty boogy,” on Instagram who “liked” one of his posts, posted this notice on Instagram to rally the troops to DC on January 6 to meet at Black Lives Matter Plaza.

The notification asks activists to bring *“tactical gear, bulletproof vests -no firearms unless you are licensed.”* In his comment section “lefty boogy” says, *“Fight back. — Also if u can’t bring a gun I recommend knives and pepper spray.”*



A Record Five American Indians and One Native Hawaiian took the Oath of Office as Congress Members

The 117th U.S. Congress is officially on the clock, and it includes a record number of Indigenous members, among them the first Native Republican woman.

Republican Rep. Yvette Herrell, Cherokee, of New Mexico's 2nd Congressional District, (Photo below).



"I am humbled and honored to have been sworn in today to serve the people of New Mexico in the 117th Congress!" Herrell posted on Twitter.

Herrell, meanwhile, penned a blog post describing "historic" irregularities in the 2020 election.

It's unclear the extent to which GOP leaders in Congress will be able to control Wednesday's joint session, which could drag into the night though the challenges

to the election are all but certain to fail. Many current and former party officials have warned the effort is undermining Americans' faith in democracy.



(photo above) Democratic Rep. Kai'i "Kai" Kahele, a Native Hawaiian representing Hawaii's 2nd District, was sworn in Sunday at the U.S. Capitol. When he was sworn in, Kahele held Akaka's bible in his left hand.

"Today, this public school educated, Native Hawaiian son of Hawai'i, will become a United States Congressman," he said in a Twitter post. *"Mahalo nui loa to everyone who made this day possible!"*

Reps. Herrell and Kahele were joined by Reps. Sharice Davids Ho-Chunk (D Kansas), Rep. Deb Haaland, Laguna Jemez Pueblos (D New Mexico), Tom

Cole, Chickasaw (R Oklahoma), and Markwayne Mullin, Cherokee (R Oklahoma).



Democrats Haaland, of New Mexico's 1st District, (Photo above) and Davids, of Kansas' 3rd District, (Photo below) are serving a second term after being the first two Native women elected to Congress in 2018.



Cole is the senior Native member of Congress and has served Oklahoma's 4th District since 2003. He is

serving his fifth term as Oklahoma's Rep. (Photo below)

"In my view, the election's over," Cole (told Fox25 in Oklahoma City last month.

"While the election didn't turn out the way I want at the presidential level, I respect the will of the American people."



Cole, Mullin and Herrell have join other Republican lawmakers in objecting to the Electoral College certification of President-elect Joe Biden's victory by Congress on Wednesday.

The House of Representatives includes 222 Democrats, 211 Republicans and two vacancies. With the COVID-19 protocols in place, members of the new Congress were able to celebrate in their own way, and many took to social media.



Mullin (Photo above) told Indian Country Today there are many discrepancies in how votes were cast in various states, which is why he won't support certifying the Electoral College votes.

"Just today, for instance, I swore an oath to uphold the Constitution, and we're simply following that," Mullin said.

Kahele is only the second Native Hawaiian in Congress since statehood. The late Sen. Daniel Akaka, Kahele's mentor, was the first as a senator.

Kahele documented his swearing-in on social media, and he started quickly. A minute after midnight, Kahele posted Sunday on Twitter that he was too excited to sleep.

'Take their children away & put Them in "Re-Education Camps."

Biden Boosts "Domestic Terrorist" Law Targeting Conservatives

Pulitzer Prize-winning journalist Glenn Greenwald speaking on Fox News' "Tucker Carlson Tonight" on January 8, 2021 expounded on his fears that, led by President-elect Joe Biden and Silicon Valley, the institutional left is gearing up to wage a new "War of Terror" against all conservatives, particularly supporters of President Trump.

"The same framework used to assault civil liberties in the name of foreign terrorism is now being seamlessly applied ... to the threat posed by 'domestic white supremacist terrorists,' the term preferred by liberal elites, especially after yesterday, for Trump supporters generally," he wrote this week for his Substack blog.

"In so many ways, yesterday was the liberals' 9/11, as even the most sensible commentators among them are resorting to the most unhinged rhetoric available."

A staunch opponent of the first War on Terror and the deterioration of U.S. civil liberties and privacy rights that it engendered, Greenwald already sees this "War on Terror" erupting as the left uses the rioting at the U.S. Capitol to attack civil rights.

"The Biden administration in about a week is saying explicitly that they want, first of all, a new law to further criminalize domestic terrorism, even though every act that constitutes domestic terrorism is already criminalized," he said.

What they really want to do, Greenwald argued, *"is increase their power to monitor political groups, to infiltrate them, to criminalize activities that currently are not criminalized nor should they be — whether it be advocacy of speech or other things."*

In other words, they want to treat all non-establishment speech and advocacy — particularly that coming from the right — as potential acts of terrorism.

"They're saying they want a new law similar to the way that the 9/11 attack and the emotions surrounding it was instantly seized upon to institute a whole series of new laws that endure to this very day," Greenwald continued.

"Secondly, they are explicitly saying ... this war on terror is not going to be directed at foreign non-state actors or terrorist groups or foreign countries like China or Iran or Russia. It's going to be directed inward."

All of this, he added, is a product of their Trump hysteria, which itself is a product of their greed and thirst for power.

But what makes this "War on Terror" far more dangerous, according to Greenwald, is Silicon Valley's full participation in and endorsement of it.

"These companies have greater power than any corporations in the history of the world. Not just wealth, but the amount of data that they have on us — and now the control that they exercise over our political discourse. A tiny handful of tech oligarchs are more powerful than any nation-state," he explained.

"They determine what we can hear, what we can speak, what is true and what is false with zero accountability and zero transparency. They overwhelmingly donated to the Democrat Party and support the Democrat Party, are part of that coalition."

Indeed, this week Facebook, Twitter, Instagram, Snapchat and other tech giants all banned President Donald Trump from their platforms, thus depriving the country's own commander-in-chief of a voice on social media.

NOTE: Censorship of any opposing view is the foundation of totalitarianism or a one-party rule if you will.

The irony in the political rhetoric of the Socialist Democrats and their main stream media and big tech partners of conservative "Nazism," while in fact their playbook is exactly that of Hitler's Nazi Germany.

Nazi Germany Has Arrived, as Facebook CEO Comrade Zuckerberg Censors President Trump

On January 7, 2021 Facebook, CEO Comrade Mark Zuckerberg said in a post that he has blocked President Donald Trump's Facebook account "indefinitely."

Yes, a Socialist billionaire is censoring the President of the United States of America. *Unbelievable!*

Comrade Zuckerberg said the firm perceives the *"risks of allowing the President to continue to use our service during this period are simply too great" and will ban him at least for the next two weeks 'until the peaceful transition of power is complete."*

The move comes a day after violent pro-Trump protestors stormed the US Capitol while lawmakers worked to certify the 2020 presidential election results.

Facebook and Twitter took action against Trump's posts, including removing a video in which Trump told his violent supporters to *"go home, we love you, you're very special" while also spouting baseless claims of election fraud.*

The hypocrisy of the Socialist never seems to come as a big surprise. As Comrade Zuckerberg censors President Trump for what he thinks in his judgement are supposedly *"baseless claims"* of voter fraud and inciting his supporters to storm the capitol building.

It was reported that facial recognition software was used by investigators to identify rioters indicate that a large number of the rioter were identified as members of the terrorist ANTIFA



thugs posing as Trump supporters.

Yet, Comrade Zuckerberg never once objected to the violence caused by the left-wing rioter and looters or their leftwing supporters, including Biden, Harris and Pelosi to name a few of them.

Dan Bongino, the former NYPD officer and Secret Service sent a message that every American needs to hear about ever-present double standards especially in the context of the anti-Trump corporate media describing widespread civil unrest that included looting and arson over the summer, as mostly peaceful protests.

The country *"is not a Parcheesi club,"* and the same standards of acceptable behavior must apply to everyone regardless of an artificial ideological litmus test, he declared.

Recalling the anarchy, for example, at a U.S. courthouse in Portland, Bongino wondered *"do you think that would have been allowed to happen if it were a group of,*

God forbid, conservatives or libertarians? You damn well know the answer is no. Those people would be arrested and tried immediately...Why was that allowed to continue for a month?"

"The answer is...because there isn't one guiding set of principles in this country. There is one rule for the left and media, and another set of rules from conservatives who call out violence anytime it happens...[violence] is never the solution to our problems in this country...It is not a Parcheesi club. There has to be one set of principles that is assigned to both sides that we have fidelity to. And if we don't have that, we don't have a country," he told Fox News, Sean Hannity on January 6, 2021.

Separately in the Fox News segment, Bongino asserted that *"We have roundly condemned the violence tonight on this network. Everyone. Period. That's it. Where was the media...when my Secret Service friends were calling me with a mob outside of the White House during the*

summer of protest who were generally in fear for the first time?... Where were the mass condemnations there?...there isn't one guiding set of principles in this country," he reaffirmed.

Unlike CNN's Chris Cuomo, a law-school graduate, who previously revealed his ignorance of the U.S. Constitution by asking on-the-air about where it said that protests have to be peaceful. Bongino added that *"the only people freaking out tonight are the people without principles."*

Along these lines, in a column that is critical of President Trump's post-election behavior, New York Post columnist Miranda Devine predicted that pro-Trump protesters *"won't receive the kid-glove treatment that BLM-Antifa received with last year's 'mostly peaceful' protests."*

"They didn't throw bricks at police or burn police buildings to the ground or beat innocent passersby senseless. But they will have the book

thrown at them because it's not the crime you commit that matters anymore, it's who you are.

So, as bad as the Capitol Hill anarchy looked, we shouldn't be surprised after the way leftist violence was condoned most of last year.

You let the genie out of the bottle, there's no telling where it goes."

However, in a statement issued through White House aide Dan Scavino because Trump's Twitter account is locked, the POTUS committed to an orderly transfer of power even though he still disagrees with the outcome of the election because of rampant irregularities in key swing states.

And now the Socialist with the help of the RINO's are doing everything they can to impeach President Trump for telling his supporter to protest in peace.

And to make matter even more absurd the FBI, using face-recognition-software have identified many of the "Trump Rioter" as members of antifa. But the Socialist media and big tech have yet to bother reporting this minor bit of news.

The Rincon and San Pasqual Tribes Celebrate the Unveiling of the Inter-Tribal Ambulance Service



"First of its kind in the State of California"



The Rincon Band of Luiseno Indians and the San Pasqual Band of Mission Indians celebrated the unveiling of the first Inter-Tribal Ambulance Service on Friday, January 8, 2021 at the Rincon Fire Station located at 33485 Valley Center Road in San Diego County.

The tribes entered into an agreement to establish a jointly owned and operated Advanced Life Support Paramedic Ambulance Service.

Inter-tribal Ambulance Service (IAS) is the first of its kind in the State of California where two Tribal Governments have worked together to provide enhanced paramedic level of care and ambulance service as a joint venture.

Bo Mazzetti, Chairman of the Rincon Tribe stated. *"We cannot be more excited to be celebrating our partnership with San Pasqual which will serve and benefit our tribal people."* members and our surrounding com-

munities,". *"Having our own ambulance service means faster response times, saving more lives and high quality care for our tribal people and neighbors. This is a win-win for all."*

As things progress, benchmarks and evaluations will take into account the ability and the opportunity to expand services to other reservations and areas within the County.

Chairman Steve Cope of the San Pasqual Tribe commented. *"This joint venture will allow the tribes to provide dedicated ambulance services to its Tribal Members and reservation residents with increased responsiveness to their emergency and medical needs,"*

"We applaud this action where tribes are working together using their skills and resources for the betterment and increased safety of their

The tribes worked to establish a fully functional Rescue-Ambulance staffed 24/7 with full-time Career Firefighter Paramedics who will provide the highest level of all risk care and service.

Staffing with fulltime dual function Firefighters and Firefighter Paramedics enhance the ability to provide high level quality advanced life support measures to those who live, work and play in both communities. Additionally, the unit will be dispatched by the state-of-the-art fire communication center (North Comm JPA) which has the ability to track and communicate vital information to responders through an advanced Computer Aided Dispatch System and Advanced Vehicle Location Systems.

"Having our own advanced life support ambulance allows us better coordination and control over our own assets," said Chief Ed Hadfield

of the Rincon Fire Department. *"While we operate with surrounding agencies, providing the highest level of service, coordination and control of our own assets places our communities as a priority."*

The Rincon Fire Department will oversee the day-to-day staffing and operations. Having a rescue ambulance staffed with Firefighter Paramedics dedicated to serving the two communities is critical to advanced care. At no cost to taxpayers, Rincon's public safety operations respond to emergencies in the neighboring communities, with more than a majority of calls generating outside of the Reservation.'

Both tribes have successful Casinos and contribute financially to the local community, schools and non-profits. They have also increased the services on their reservations.

Some California Tribal Casinos Ring in New Year

"Tribes operate under federal laws and not under Gov. Gavin Newsom's orders"

CALIFORNIA — "We're open!" says Thunder Valley Resort Casino near Sacramento (Photo above). Morongo Casino Resort & Spa located off interstate-10 between Palms Springs and Los Angeles, CA declares, "Good Times are back!" Barona Resort Casino near the City of San Diego says, "We're open 24/7."

Splashy messages on websites and freeway signs for California's tribal casinos are a jarring contrast with the sober restraint that Gov. Gavin Newsom has ordered amid a crushing surge in coronavirus cases that has overwhelmed hospitals statewide.

California's self-governed tribal casinos have largely left safety rules unchanged since reopening in the spring as the government has stiffened restrictions on other businesses in most of the state.

Stay-at-home orders that began in early December prohibit indoor religious services and on-site dining, close gyms and cardrooms, restrict hotel reservations and limit capacity to 20 percent at retail stores.

Tribal casinos operate under federal law on federally protected land, known as rancherias in California, so they're not required to fall in line with Newsom's orders. The country's 574 federally recognized tribes also are sovereign entities and can decide on how to operate their businesses without approval from states.

Tribes outside California have reopened casinos with limited capacity and other safety precautions. Casinos on the country's largest Native American reservation, the Navajo Nation in the Southwest, have been closed since March.

Casino revenue is also a major source of income for tribes, which don't have a tax base like state and

local governments.

With few other places open New Year's Eve, casinos have come under scrutiny for ringing in 2021 with a bang. Graton Resort & Casino in Rohnert Park, north of San Francisco, faced a backlash after announcing last week that it would close for a private party with up to 4,000 people. It abruptly canceled the event and "apologized for any inconvenience" in a statement online.

The San Manuel Casino in Highland, east of Los Angeles, said Tuesday that its New Year's Eve events were also off. It will remain open for "current limited capacity" but there will be no midnight countdown, booze at the bar or tableside dining.

Pechanga Resort Casino in Temecula, California's largest tribal casino, said Monday that it was closing to the "general public" on New Year's Eve after previously canceling special celebrations and postponing concerts through March.

Closing to the public on New Year's Eve was done to "further discourage attendance," Jared Munoa, board president of the Pechanga Development Corp., said this week.

Cache Creek Casino Resort, north-

west of Sacramento, said it canceled plans for a public New Year's Eve party in early December but will open for "a small number of special guests," estimated at less than 1 percent of normal crowds.

Some casinos are sticking to festivities. Thunder Valley, near Sacramento, promotes "2021 Celebration Giveaway" drawings Friday and Saturday, with \$8,000 grand prizes.

Viejas Casino & Resort, east of San Diego, advertises a \$50,000 Bingo "celebration" on New Year's Eve.

Bradley Pollock, a public health professor at UC Davis Health, acknowledged tribal rights and the economic benefits that casinos deliver but said "anything that encourages people to come together physically is not good." He said New Year's Eve celebrations are "even more egregious."

The Associated Press checked policies on websites of California's 10 largest tribal casinos and sought comment from each by email or phone. Some confirmed the policies and underscored their commitment to safety; others didn't respond.

All post significant restrictions, such as temperature checks at the door,

required face coverings and more space between slot machines. Buffets and many, but not all, restaurants are closed.

Gaming and dining capacity is more limited but few specify by how much. Two exceptions: Pechanga and Pala Casino Spa Resort, near San Diego, say they cap attendance at 50 percent of normal.

The few that have strengthened restrictions since November's surge are still far looser than non-tribal businesses. Cache Creek stopped bar service unless food is purchased. Sycuan Casino Resort, near San Diego, introduced a dining cap of eight people per table and other rules.

The right of tribes to determine their own rules is unquestioned. San Diego County Supervisor Nathan Fletcher, who has denounced restaurants and churches that defy health orders, said when casinos prepared to reopen in May that he was in no position to criticize.

"This is a decision that is for them to make, and there is a very long and very dark history of the country, of white people in particular, telling our Native Americans what they should and shouldn't do," he said. "I'm not going to be a part of continuing that into the future. I respect their sovereignty."

Information on how COVID-19 has spread from casinos is limited. KPBS obtained San Diego County records and reported that outbreaks at seven casinos were linked to at least 638 COVID-19 cases from late June to mid-December. It said at least 208 outbreaks occurred in restaurants and at least 125 at large retailers and grocery stores.

Pollock, of UC Davis Health, said hotels present limited risk of spread but dining and gaming are more troublesome.



"Learning American Indian History; On-Line@Archives."

In the last column I mentioned some of the TV serials that ought to be included in each stay-at-home schooling schedule. I'd now like to add "Mankind: the Story of All of Us". This marathon series was originally aired in 2012 by the History Channel but remains timeless today.

Narrated by Josh Brolin and others, the series very quickly jumps from the Big Bang to humanoid hunters in Africa. The next eight hours (if done as a marathon) takes one through the evolution to our modern world, exploring various topics of the human psyche, invention and social organization.

For junior (middle) school age learners, viewing in 15 minute segments followed by discussion or essay writing utilizing the questions "What did you learn from this?" and "How did/does this impact your life today?" can turn any facilitator (older sibling parent, caretaker) into a true teacher....leading the learner through seemingly unrelated topics to an understanding of how the past impacts their present.

For older age learners, viewing the segments in larger time chunks would be appropriate.

This retrospect of other-world history leads me to one of my favorite segments when teaching "Introduction to Indian Country through Archives".

The colonization of the Americas impacted the continent's humanoids in so many ways, the tendrils of which exist today.

From Belgium to Russia; from the Vikings to the Mongols — each "exploring" or "conquering" entity had an "Indian Policy". Even if one's territory was not touched by one or of these early groups, often their philosophy or practices were adopted or fought over by another group which did. (search term, ie, Denmark plus American Indian policy)

Understanding the panorama of these nations' impact on the indigenous nations of the Americas provides context not only for a learner to understand what happened to their people, but also the decisions made by their leadership at that time.

It is also helpful to understand how a monarch's fit of ire, religious conversion or simple megalomania would set the stage for events thousands of miles away.

While many are challenged by not being able to read other languages, Spain gave the world a gift in honor of the 500th Anniversary of Columbus' voyage to the Americas by translating and digitizing many of the records related to that event.

Moving to domestic archives. The University of Oklahoma has a fine collection of tribal treaties and constitution. New on the scene, the National Archives Office of Innovation partnered with the Indigenous Digital Archive project of the Museum of Indian Arts and Culture, Santa Fe, New Mexico to provide context about and connection to the National Archives' holdings of the Ratified Indian Treaties, newly conserved and scanned for the first time thanks to the generous gift of an anonymous donor.

The Indigenous Digital Archive is a two time IMLS National Leadership Grant project of the Museum of Indian Arts and Culture in partnership

with the New Mexico State Library, and the Indian Pueblo Cultural Center. Additional support has been provided by the Knight Foundation, the New Mexico Historical Records Advisory Board, a Mellon Foundation Council on Library and Information Resources Digitizing Hidden Collections grant, and the Santa Fe Community Foundation.

The National Archives also has provided digital access to a several Bureau of Indian Affairs Photographs Finding Aid; *Tribal Nations; Topics; States & About Search*.

Tribes Sue to Stop Relocation of Rare Documents

If this information were to ever leave the Pacific Northwest, it would be a loss not only to tribal nations, it would be a loss to the entire Pacific Northwest

In Seattle, Washington and Oregon, \$2.4 million maintenance backlog and more than two dozen tribes, and cultural groups from the Northwest are suing the federal government to stop the sale of the National Archives building in Seattle, a plan that would force the relocation of millions of invaluable historical records to California and Missouri.

The government is planning to sell the vast warehouse under a law aimed at unloading excess federal property, but the lawsuit filed in U.S. District Court on Monday says the building is anything but "excess." It contains irreplaceable documents dating to the 1840s and is used all the time for research about everything from tribal history to Japanese internment during World War II and fur seal hunts on remote Alaskan islands.

"This is the DNA of our region," Washington Attorney General Bob Ferguson told an online news conference Monday. "These are documents that are not digitized. Moving them a thousand miles away essentially and effectively eliminates public access to these critical documents."

The records would be moved to National Archives facilities in Kansas City and Riverside, California.

The Seattle building has a reported

The sale is opposed by eight U.S. senators and many representatives from Alaska, Idaho, Oregon and Washington.

"The records stored in Seattle's Federal Archives are vital to telling the story of the Pacific Northwest's history," Washington Sen. Patty Murray, the third-most-senior Democrat in the Senate.

The lawsuit says the Seattle archives is ineligible for sale under the Federal Assets Sale and Transfer Act, which exempts buildings used for research in connection with federal agricultural, recreational or conservation programs.

"This generation is witnessing our history come to life with a resurgence of our language, our cultures, our songs, our dance, our tribal journeys," said Fawn Sharp, president of Quinault Indian Nation on Washington's Olympic Peninsula. "We're just getting to a point of having a basic understanding of this rich and vast history. If this information were to ever leave the Pacific Northwest, it would be a loss not only to tribal nations, it would be a loss to the entire Pacific Northwest."

PHOENIX - The sight can be jarring: As a runner's graceful stride brings her closer, her face comes into focus.

A rich, red handprint covers her mouth. *We will not be silenced.*

The painted hand has become a powerful symbol for the Missing and Murdered Indigenous Women Movement, known as MMIW, a cause boosted by the increasing number of athletes embracing it.

"I didn't really think the paint would impact me as much," said Rosalie Fish, a member of the Cowlitz Tribe of southwest Washington and a standout runner whose stops have included the Nike Cross Regional Southwest in Casa Grande.

"I would just be running like any other time, except now it would be for other people. But instead, it was actually very emotionally tolling to run for women that were no longer here."

President Richard M. Nixon: A True Friend Of the American Indian People

Leonard Garment wrote a memo to President Richard Nixon on April 17, 1970, urging White House support for a Senate bill to return Blue Lake to the Taos Pueblo.

The land was taken from the pueblo in 1906 and turned into a national forest. The pueblo refused compensation because it was determined to get the land back.

If the story has a familiar ring to it: It's because the land was illegally taken by President Theodore Roosevelt, now a figure at Mount Rushmore on land that the Supreme Court said was also illegally taken.

"Over the years, since 1906, this particular issue has snowballed," Garment wrote. "It is now the single specific Indian issue and as such of major symbolic importance." Garment underlined "the" to reinforce his point.

He outlined reasons for the bill and cited the opposition (both within the White House and especially in the Senate). "The question, however, is what position you as President should take, for both moral reasons and political reasons."

The White House decided to go forward. Bobbie Kilberg, a White House fellow, was tasked with announcing the president's support for Taos. It was nearly the Fourth of July, and more senior people were on vacation.

On her way to the White House Press Room she ran into Ken Belieu. Literally. The two collided, papers flew around, and he told her in no uncertain terms that the statement could not be released. She told him the memo had been cleared. But he wanted to appeal.

So they went into John Ehrlichman's office. Ehrlichman was the president's domestic counselor (and in many ways, deputy president).

Belieu said New Mexico Sen. Clinton Anderson, a former secretary of agriculture, was against the return of any tribal lands. Give it to

the pueblo, he argued, and you'd have to do the same for the Utes, then the Navajos, then the Cheyenne.

The politics were complicated. Anderson was the mentor to the Senate's Interior and Insular Affairs Chairman Henry Jackson, and the Nixon administration was trying to win support for the Anti-Ballistic Missile Treaty. The threat was that Anderson and Jackson could be "no" votes. Garment was firmly for the announcement and Belieu against.

Ehrlichman went into the Oval Office to talk to Nixon. He returned with a big smile on his face. "We got it."

"What happened?" Kilberg asked. "Well, John said Nixon got red in the face and said if he's going to vote against the ABM treaty over Blue Lake, well, goddamnit, let him do it. You go out and do it."

Nixon was in. The paper supporting Taos was suddenly elevated into a presidential message, rejecting termination and supporting self-determination. (The White House had already assigned Kilberg to work on the policy draft. She had spent the summer working on the Navajo Nation so had "experience" in Indian affairs.)

Garment suggested pueblo leaders be invited to the White House. The president immediately said it was a wonderful idea. He wanted

to make a big deal of this.

The decision was made to release the message as a "state paper" as opposed to a presidential speech.

"A speech becomes distracting, becomes a personality thing," Garment said.

"It didn't make sense to Nixon to make a speech about the history of mistreatment of the Indians in America, the importance of independence for Indian tribes and self-determination. Nobody would know what he was talking about. These state papers were addressed to a particular audience that's familiar with the social or political complexities of a nation that dealt them with some seriousness," he said.

The message was released on July 8, 1970, and the leaders of the pueblo were invited to the White House.

"To the Congress of the United States: The first Americans - the Indians - are the most deprived and most isolated minority group in our nation. On virtually every scale of measurement - employment, income, education, health - the condition of the Indian people ranks at the bottom."

"The time has come to break decisively with the past and to create the conditions for a new era in which the Indian future is determined by Indian acts and Indian decisions," the message said.

"This policy of forced termination is wrong, in my judgment, for a number of reasons. First, the premises on which it rests are wrong. Termination implies that the federal government has taken on a trusteeship responsibility for Indian communities as an act of generosity toward a disadvantaged people and that it can therefore discontinue this responsibility on a unilateral basis whenever it sees fit."

President Lyndon B. Johnson had also published a message on Indian affairs -- and that too called for the end of termination as a policy. "I propose a new goal for our Indian programs: a goal that ends the old debate about 'termination' of Indian programs and stresses self-determination; a goal that erases old attitudes of paternalism and promotes partnership self-help," the Johnson message said.

One reason why the Nixon policy is remembered is that much of Nixon's program became federal law.

Indeed the "golden era" of legislation was spurred by this message ranging from the Indian Health Care Improvement Act to the Indian Finance Act which was Anchored by the Indian Self-Determination and Education Assistance Act of 1975.

Garment arranged for Taos leaders to be at the White House and for the meeting to be held in the Cabinet

Room. "That was a big thing," Kilberg said, because usually it was reserved for heads of state or governors.

Thus, the White House was recognizing the pueblo as such, sovereign tribal governments.

Kilberg recalled who was in the room. The cacique, then 94-year-old religious leader, Juan de Jesus Romero. Paul Bernal, who was a secretary and translator. Unseen, she said, were two very important canes, one from the king of Spain and the other from Abraham Lincoln, given to the pueblo.

In December 1970 the same leaders would come to Washington for the signing ceremony, the official return of Blue Lake to the Taos Pueblo.

The cacique thanked the president for being there. Then the president made remarks, and Bernal again had to translate for the cacique so this went on for 15, 20 minutes.

"I was thinking, 'Oh, gosh, am I going to be fired? Is this guy just furious?' Because I knew he was late for ... his next event," Kilberg said. "But he seemed to be really engaged in it, and he lingered."

At the end she was asked to join the president and walk to the East Wing.

"I said: 'Mr. President, I really apologize. I know that took very long time and the translations can be very cumbersome.'"

"And he looked at me and said, 'Young lady, don't you ever say that.' He said, 'That was one of the most moving, wonderful experiences I've ever had at this White House. We did something good that you ought to be proud of. We did something important for the Indian community. And what the hell, HUD can wait.' And then he went off."






