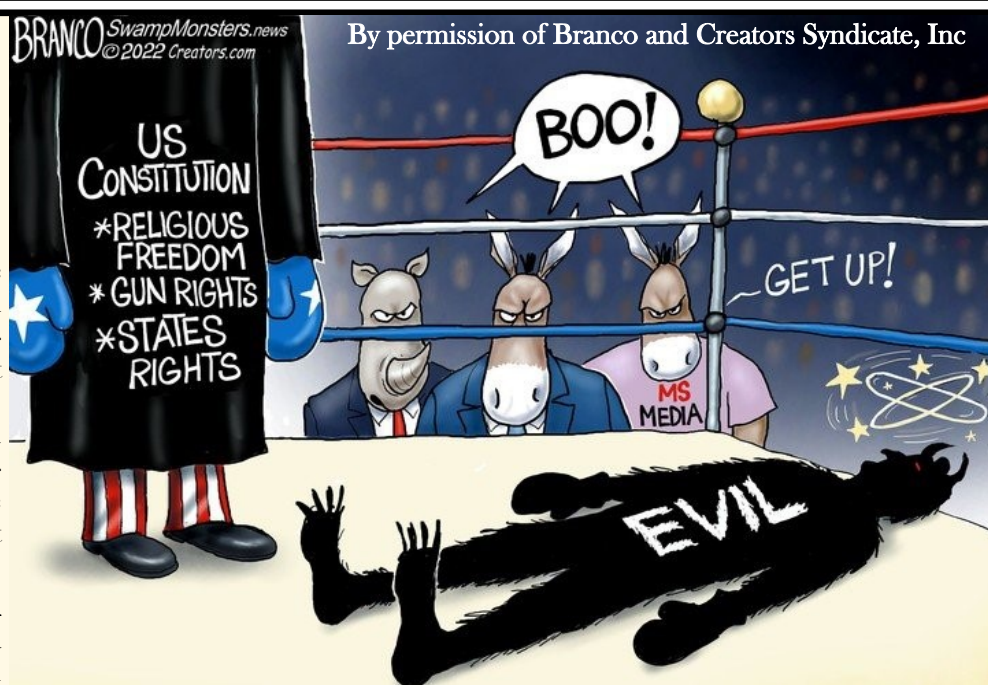

Pelosi's husband buys over \$3 millions in semiconductor stock before Senate votes on \$52 billion in subsidies to tech industry

CNN, MSNBC, ABC, CBS, NBC ignore Pelosi's husband buying over \$3 million of computer chip stock ahead of vote

Paul Pelosi – the husband of House Speaker Nancy Pelosi (D-Calif.) – purchased over \$3 million dollars worth of stock in a semiconductor company potentially weeks before an expected Senate vote on a bill that would subsidize \$52 billions to computer chip manufacturing and semiconductor companies.

According to a financial disclosure report, Paul Pelosi bought 20,000 shares of semiconductor company Nvidia on June 17. Nvidia closed at \$158.80 on June 17, which means Pelosi bought more than \$3 million of Nvidia stock on that day.

On June 15, leaders of big tech companies wrote a letter to Pelosi, Senate Majority Leader Chuck Schumer, and House Minority Leader Kevin McCarthy. The tech companies asked Congress to pass "competitive legislation" to

financially help companies such as Alphabet, Amazon, Microsoft, and Nvidia.

"The bill would include, at a minimum, billions of dollars in subsidies for the semiconductor industry and an investment tax credit to boost U.S. manufacturing," Reuters reported, citing a source.

Politico reported, "Majority Leader Chuck Schumer has told senators to expect votes as soon as Tuesday (July 19, 2022) to move forward on \$52 billion in initial funding for chip factories, as well as a tax credit for ongoing semiconductor production, a person familiar with the plans said."

Bloomberg op-ed: Biden must 'stop the fall in gasoline prices,' set \$5 gallon minimum to combat climate change.

Bloomberg opinion published a piece Wednesday calling for President Biden to increase gas prices, intentionally and forever, in order to hasten a transition to alternate forms of energy. The op-ed, written by columnist Eduardo Porter, called for a "\$5-a-gallon floor on gasoline prices."

Porter described the policy as "one bold move" that would put a "real dent" in "the emission of heat-trapping carbon dioxide that is causing such havoc with the weather," although he admitted it was unlikely the president would make it.

"As any economist will tell him, the most efficient

way to reduce fossil fuel consumption is to raise its price relative to alternatives, encouraging people and businesses to switch to cleaner sources and use less energy altogether," Porter wrote.

Biden faced backlash in June for suggesting that high energy prices are a "chance" to make a "fundamental turn" to so-called clean energy.

"Higher energy prices will eat into consumers' pocketbooks and slow the economy," Porter admitted. "What's important for the president to understand is we have no choice. Fossil fuels must become more expensive."

Maxine Waters pays daughter another \$16,500 in campaign funds, adding to \$1.2M in previous payments

Other members of the Waters clan have also made off with donor cash over the course of the congresswoman's decades-long career.

In 2004, the Los Angeles Times revealed that the Waters campaign had shelled out over \$1 million to other family members over the previous eight years. Waters defended the practice at the time, telling the paper, "They do their business, and I do mine."

"We don't have to answer your questions," she added. "We are not bad people."

Waters topped Biden, Pelosi and many worthy other as the most "Corrupt" member of congress. And to add insult to injury she is now the Chairwoman of the "Finance Committee."

A domestic violence suspect was shot dead by a female cop in Portland after the man took a shot at her partner during a scuffle caught on camera.

The officers were responding to a report of a male and female physically fighting, according to a statement released by the Portland Police Bureau.

"While attempting to arrest the male suspect, a shot was fired by the suspect, resulting in an officer returning fire. The suspect was declared deceased at the scene," the release said.

Video footage shared online shows the man battling with the officers and at one point a shot can be heard ring-

ing out. The male officer ducks his head at the same time, appearing to barely miss being shot. A split second beforehand, his partner can be heard screaming, "Gun!"

As the cops fight with the suspect, a woman on the scene is heard repeatedly screaming, Stop it!" and "Let him go!"

The female officer, identified as Officer Mina Cavalli-Singer, had her gun in her hand and when the man tried to grab the weapon she opened fire, shooting him several times.

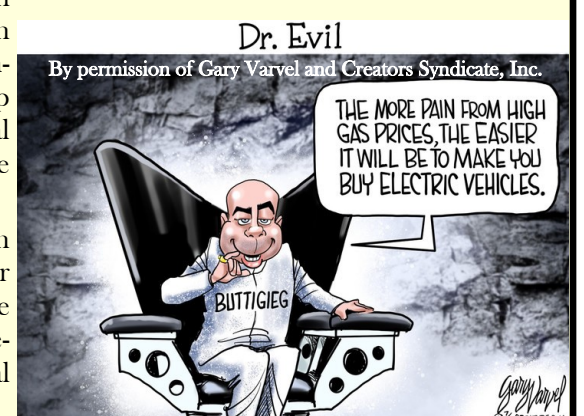

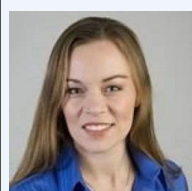

Transgender 'bill of rights' would erase women

In practice, the Trans Bill of Rights guts protections and programs for biological women. Every American must now decide: do I support this vision of trans rights, or do I stand for women's rights?

It is impossible to support both because they are in direct conflict. The press materials promoting the Trans Bill of Rights focus on the idea of inclusivity, personal fulfillment, and preventing the bullying and mistreatment of LGBTQ+ and gender-nonconforming communities, all of which sounds very nice.

Of course, Americans oppose bullying and want everyone treated with kindness and respect. But the Trans Bill of Rights isn't just a feel-good statement of support or warning against bullying. It has serious legal implications — particularly for women.

The Trans Bill of Rights would redefine the term "sex" under the Civil Rights Act to include "gender identity and sex characteristics" and prohibit public accommodations and federally funded programs from offering spaces and programs exclusively for women.

In other words, it would become illegal to take into account sex or "sex characteristics," and single-sex facilities would cease to exist. If a female athletic team cannot discriminate against males, then men will dominate competitions meant for women.

If women's locker rooms, rape crisis centers, and domestic violence shelters are required to take in men, women's privacy and security will be compromised. If men are allowed to opt in to

women's prisons, then female prisoners will face physical harm.

We already see this happening today. Female athletes around the country are being forced to compete against physically-advantaged biological males.

NCAA Swimmer Lia Thomas is the most notorious example, with the NCAA just last week selecting Lia as the "female athlete of the year." That was a slap in the face to all female swimmers who have spent their lives training and competing without the benefits of testosterone and having undergone puberty as a male, which creates lasting physical advantages, including greater height, bone mass, lung capacity, and more.

Yet this phenomenon goes far beyond one swimmer. Male-bodied athletes are competing — and often dominating — track and field competitions, skateboarding, weightlifting, fighting sports, volleyball, and more.

The Trans Bill of Rights would accelerate this trend by forbidding the taking of sex into account entirely so that any man — not just men who identify as women — could choose to compete in women's sports, apply for an engineering scholarship meant for a woman, enter a female prison, or choose to undress in a women's locker room. Single-sex facilities would disappear.

The Trans Bill of Rights' erasure of single-sex institutions wouldn't affect men and women equally. No one worries about allowing biological women to enter men's sports. No one is concerned about the physical safety of male prisoners faced with a biological female, or women using a male chang-

ing room. Women who are physically weaker, more vulnerable to assault, and who have historically suffered from discrimination alone would pay the price.

Americans can make a different choice and reject the Trans Bill of Rights' radical, anti-woman agenda. The Women's Bill of Rights — a resolution recently introduced in Congress and supported by a bipartisan coalition of women's organizations and advocates — stops the assault on women and single-sex institutions.

It clarifies the definition of terms like "female" and "women" under existing law as based in biology and affirms that there are circumstances in which single-sex is not only legal, but necessary.

The Women's Bill of Rights would not prevent the adoption of protections for

transgender and nonbinary people. Accommodations can be made in athletics, prison systems, education, and shelters. Yet those accommodations would not be achieved by erasing women as a matter of law as would be done by the Trans Bill of Rights.

One cannot be for both women's rights and this vision of trans rights. One cannot stand up for women without knowing what the term woman means.

Americans know what a woman is, what a female is, and what a mother is. Our laws should too.

This only the "Tip of the Iceberg," our children are next as Biden said, "The students belong to the State." This wasn't a flub. If you think that it can't happen don't be fooled because it happened to my people.

Justice is lost at the hands of such judges...

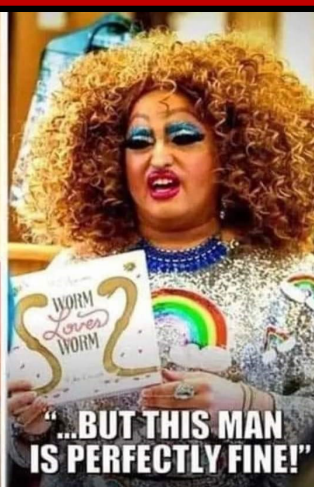
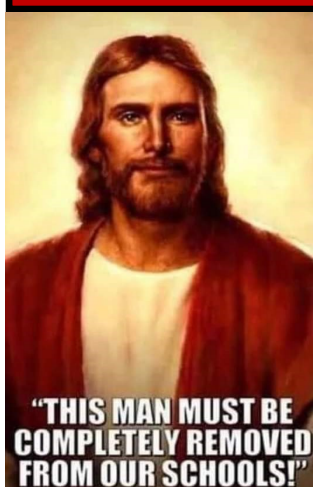

Minnesota Chippewa Tribe members voting on whether to continue blood quantum

The “Blood Quantum” policy is nothing less than Self Genocide.

Like a lot of Americans, Sarah Agaton Howes' family is, as she puts it, *"mixed from all over the place."* Her mom's family is from Norway. Her dad is a member of the Fond du Lac Band of Lake Superior Chippewa, and so is she. But the 46-year-old also has relatives from the Red Cliff and Bad River Ojibwe bands in Wisconsin, and the Muscogee Nation in Oklahoma. Her husband is Filipino.

"And so my kids can't be enrolled here," she said of the Fond du Lac Band. *"And so what that means for them is that even though they're raised here, they grew up in our culture, that they aren't going to be able to vote or feel a part of our community in the same way."*

Tribal members have cards that show their Certified Degree of Indian Blood. Howes' is 25 percent (*One Quarter Degree*). But because her kids' dad is non-Native, they have only one-eighth Minnesota Chippewa Tribe blood. So they can't be enrolled tribal members.

"Our family, our kids have clans, they have names and so I know who they are. And they know who they are," Howes said. *"And the only one that doesn't know who they are, is the enrollment office."*

But that could soon change, pending the outcome of a historic vote that could help determine who is allowed to be an enrolled tribal member.

The Minnesota Chippewa Tribe includes six Chippewa, or Ojibwe bands, in northern Minnesota, including the Fond du Lac Band. Only the Red Lake Band is not included. The Tribe's constitution requires that a person have 25 percent tribal blood — a requirement known as “blood quantum.”

Tribal officials plan to begin counting ballots on an advisory vote that will guide the tribe as it considers reforming its constitution. It's a contentious issue that divides families. Some tribal members fear that expanding membership would further stretch already scarce resources.

But others argue that if nothing is done, the tribe's enrollment will drastically decline as members marry non-tribal members.

"I think that we are fulfilling the government's goal of making ourselves extinct if we don't do something to change it." said Melissa Walls, a descendant of the Bois Forte Band of Chippewa who doesn't qualify for enrollment.

"And it totally flies in the face of Anishinaabe or any indigenous cultural teachings about who belongs."

"It isn't real"

Blood quantum is a relatively new idea, a race-based policy imposed by the federal government.

Beginning in the 1930s the government pressured many tribes into adopting tribal constitutions that included blood quantum to decide membership. In Minnesota, it was used by white settlers to acquire tribal land. Federal law only allowed Native people who had "mixed blood" to sell their land.

But there was no way for federal officials to accurately determine the Native American percentage of an individual's blood.

"Blood quantum isn't actually a real thing," said Jill Doerfler, chair of the American Indian Studies department at the University of Minnesota Duluth, who has studied blood quantum for two decades and written a book about it.

"It's not something that can be carved up into percentages," she said.

She said agents in Minnesota borrowed what were then cutting edge ideas and techniques from the burgeoning field of anthropology to try to quantify how much Native blood someone had.

"So they did some scratch tests on people's chests," Doerfler said, describing how they would look at the color of someone's skin after they scratched it.

"They took some hair samples, they did some head measurements. And that was the basis for blood quantum and then later, even judges would see people before them and say, 'Yes, mixed blood, no, full blood.'"

Doerfler said the Minnesota Chippewa Tribe historically had a much more open definition of belonging. But under pressure from the federal government, the tribe adopted the 25 percent blood quantum in the early 1960s.

Since then, the tribe's population has slowly declined, as tribal members married non-tribal members. Doerfler calls it "mathematical termination."

Today, out of a total population of around 40,000 among the six bands, fewer than 20 percent are children.

A study conducted by Wilder Research nearly a decade ago on behalf of the Minnesota Chippewa Tribe found that if no changes are made, the tribe's population would decline 80 percent by the end of the century.

"If something isn't done, tribes will eventually be gone. The population could dwindle to the point of non-existence," said Cathy Chavers, chairwoman of the Bois Forte Band and the current President of the Minnesota Chippewa Tribe.

EDITORS NOTE by Ernie C. Salgado, Jr.,

What a revelation, in the finding of the study. Jill Doerfler calls it *"mathematical termination,"* and she is spot on. I call it calls it *"mathematical genocide."* Anyone with a basic understanding of mathematics should be able to understand it's a simple elimination process.

Many tribal leaders understood the devastating results of the Government imposed “Blood Quantum” and refused to include them in their tribal membership criteria. One of the first things the late Wilma Mankiller did when she was elected Chief of the Cherokee Nation was to change the tribal membership policy. And although it still has a “Blood Quantum of 1/164,” I look for it to be eliminated as the membership become more educated in understanding the real relationship with the U.S. Government, which is “Political and not Racial.”

The termination of the American Indian people was and still is the unofficial policy of the federal government even though the “Termination Policy” officially ended with the passage of President Richard Nixon's P.L. 93-638 in 1975, “The Self Determination and Education Act.”

To have a better understanding of how our government really works I have provided a short summary as follows:

The Government is administered by an extremely large and powerful bureaucracy whose only purpose is to maintain the status que.


The conseritive minded have Dubbed them as the “Red State” simple because they can't be held accountable for their actions. And a good example is that of the former FBI acting Director who broke several federal laws but was never charged with a crime. My point is that although congress passes legislation the bureaucracy doesn't always comply. Again, the “Termination Policy.”

The relationship between the American Indian Tribes and the United State Government is “Political and not Racial” as established by Treaties. However, the U.S. Government in an effort to eliminate its obligations as defined in the Treaties sought the “Termination” of the American Indian Tribe by establishing a “Blood Quantum” which would eventually lead to their “Termination” or a low enough number that the Government could declare them “Non Existent.”

The Termination Policy was part of President Roosevelt's “New Deal” for the American Indian tribes. He appointed John Collier a card carrying Communist as the Commissioner of Indian Affairs in the early 30's. Once in office Collier imposed his political ideology of a Communist State upon the American Indian Tribes. The Reorganization Act, the Dawes Act and Allotment Act are three of the most devastating legislation to the well being of the American Tribe. And ironically are still in effect.

Again, the “Brainwashing” conducted by the Government at the reservation and boarding schools has had a devastating impact on the Tribal community to this day. Even though P.L. 93-638 allowed the American Indian Tribe to determine their own membership criteria a great majority of the Tribal people have accepted the Governments policy of “Blood Quantum” as their definition of an American Indian for federal Recognition. Some tribe are so indoctrinated into this mindset they have “Disenrolled” tribal member. However, in many cases it is motivated by political reasons and money, which are all short sighted and morally wrong.

I pray for the Chippewa Tribe and all the Tribes in the Country that they find their way and grow their Tribe forever!

Biden's six favorite lies about inflation and the economy

Every modern president has stretched the truth now and then, and the media loved to torch Trump nearly every other day for lying. But Biden's routine misstatements about money and the economy seem to go unchallenged.

In recent months, as the economy has slipped into a soft recession and with inflation at 9.1 percent the Biden whoppers keep coming fast and furious.

Here are six of the most economically consequential deceptions of the Biden administration

1) Nobody making under four hundred thousand bucks will have their taxes raised. Period.

This one was reminiscent of the infamous George H.W. Bush claim in 1988 "read my lips: no new taxes." Biden didn't say he wouldn't raise taxes on the middle class once or twice, but routinely throughout the campaign — and he even STILL says it.

Except that inflation is a tax that hits the middle class and the poor hardest and over the past year, prices have outpaced wages and salaries by roughly four percentage points. With the average worker wage and salary at roughly \$60,000 per year (that's a lot less than \$400,000) this means a \$2,400 per worker Biden inflation tax and as much as double that for families with husband and wife both working.

2) Inflation is worse everywhere but here.

Biden claimed this most recently in a speech in Philadelphia as an excuse for high inflation here at home. It is hogwash. Inflation is lower in Australia, Canada, China, France, Germany, Italy, Japan, Switzerland, the United Kingdom, and many other countries.

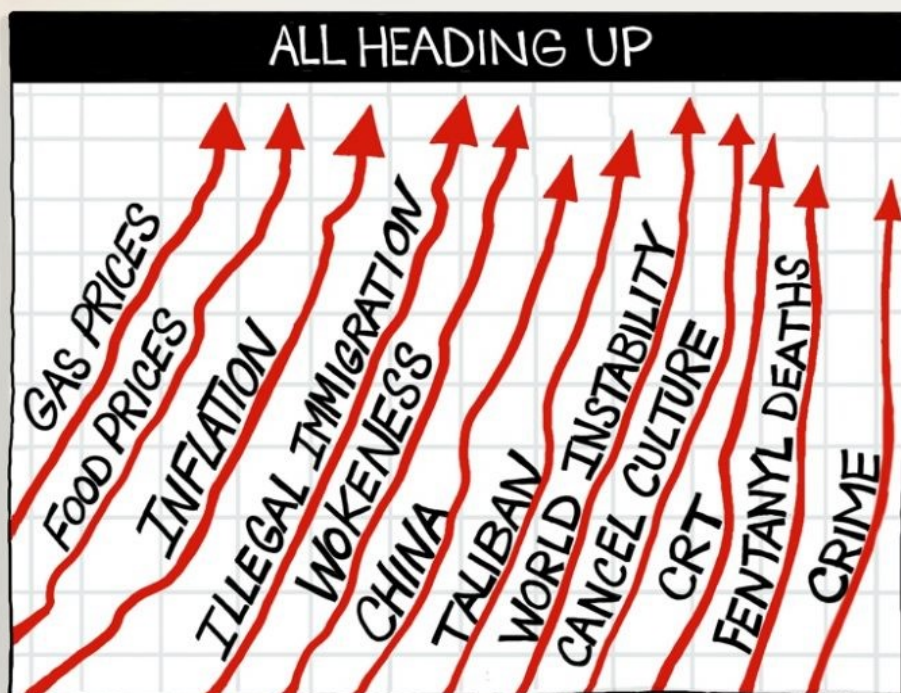
3) The economy had stalled when I entered office.

The reality is that Biden was bequeathed an economy with robust growth coming out of the pandemic. In the second half of 2020, the economy grew more than \$1.5 trillion at an annualized rate. The growth rate for the second half of 2020 even with COVID was almost 15 percent.

Moreover, when Biden entered office, the economy was prepped for an enormous

tail winds gust because of the Trump "operation warp speed" vaccine that was just hitting the market and allowing businesses to reopen and workers to return to the job.

4) I am responsible for the strongest job creation economy in modern times.

This is more an exaggeration than a bold-faced lie.

On jobs, we will give the president his due. This has been an impressive hiring spree over the past 14 months and the jobs are out there for those who want them. But this is NOT the strongest period for job creation. That hiring record was set in 2020 under Trump who presided over the initial recovery following the government-imposed lockdowns.

Job growth under Trump from May 2020 to Jan 2021 averaged 1.4 million jobs per month, for a total of 12.5 million people returning to work. But under Biden, average job growth per month has been cut by more than half, down to 542,000 with 8.7 million people returning to work. That means Biden has added 31 percent fewer jobs in 16 months than Trump did in nine.

5) Since I took office, families are 'carrying less debt, their average savings are up.

This is a strange and oft-repeated White House claim.

The amount families are able to save each month has utterly collapsed, falling 74 percent since Biden took office, while the personal savings rate has plummeted from 19.9 percent to just 5.4 percent. Likewise, the claim about declining debt is equally untrue. **Household debt** has risen by \$1.29 trillion in just the first 15 months of Biden's presidency. **Credit card debt**, which decreased over \$100 billion during the pandemic, is now exploding at the fastest rates on record as families run out of savings and fall into debt.

Put simply, they cannot afford to live in Biden's America. Biden also ignores a stock market selloff that has evaporated some \$10 trillion of Americans' wealth and savings. This is one of the greatest periods of savings disappearing.

6) I'm doing everything I can to lower gas prices.

We wonder if ANYONE actually believes this claim.

The folks at Institute for Energy Research have identified 100 separate Biden executive orders, regulations, and laws that have impeded oil and gas production and raised prices at the pump. These range from killing pipelines, to expanding EPA regulations on oil and gas drilling and refining, to taking hundreds of thousands of acres of prime oil and gas lands on public lands and in areas like the Gulf of Mexico off-limits for drilling. Economist Casey Mulligan of the University of Chicago estimates that these policies have reduced oil and gas drilling by 2 to 3 million barrels a day. That increased production would bring gas prices down at the pump.

Perhaps none of these half-truths and outright fibs should be too surprising. What should we expect from the administration that first **denied inflation**, then said **inflation was transitory**, then claimed it was only a **high-class problem**? Biden has done another about-face, decrying inflation as bad but now it is Russia's fault or greedy businesses, like meatpackers or oil companies and even **mom-and-pop gas station owners**.

C'mon Joe. We're not that dumb. Give us a little more truth.

CALIFORNIA Proposition One Will Allow LATE-TERM ABORTION Up to Time of Birth

Have we come so far away from God to even consider this evilness?

In November 2022, California voters will be asked if they want to dramatically change California's abortion laws to allow a baby to be aborted right up until the minute before that baby is born.

Right now, a woman can have an abortion in California up to the point where the baby can survive outside the womb or is "viable." Viability has been the standard for decades.

Based on polling, it is likely most Californians are comfortable with that viability standard. But legislative Democrats are testing how far voters are willing to go to allow legal abortions up to a baby's due date.

That's what will be on the ballot this November in California with Proposition 1.

How did we get here? Much has been said about the recent 6-3 decision by the Supreme Court of the United States in Dobbs vs. Jackson Women's Health Organization that reversed previous court rulings and found that there was not a federal constitutional right to have an abortion. The court ultimately concluded:

Prop 1 Text: "The state shall not deny or interfere with an individual's reproductive freedom in their most intimate decisions, which includes their fundamental right to choose to have an abortion and their fundamental right to choose or refuse contraceptives."

"Abortion presents a profound moral question. The Constitution does not prohibit the citizens of each State from regulating or prohibiting abortion." With that decision, determining public policy around the issue of abortion has been returned to each of the 50 states. State responses — like the people who live in them — are wide, varied and diverse. According to a Gallup Organization survey of the opinions of Americans on the issue taken in late May of 2022, 35% said abortion should be legal under all circumstances, 18% said legal under most circumstances, 32% said legal only in a few circumstances and 13% said all abortions should be illegal.

In other words, fully half of

Americans chart a middle course on this issue. On the football field of politics, most Americans find themselves between the 35-yard lines.

California's approach, though, puts us next to the progressive goal line. As a practical matter, the decision in Dobbs and the overturning of Roe v. Wade has no effect on abortion rights in California. Up until viability (generally regarded as 24 weeks into a 40-week pregnancy), women can obtain abortions for any reason. The state subsidizes the procedure and has passed laws encouraging "abortion tourism."

But the modest restriction precluding abortion after viability (unless done for the health of the

mother) would be eliminated if voters pass a constitutional amendment that has been placed before us by the Democrat-controlled state Legislature.

Proposition 1 on the California ballot would place these words into the state constitution: "The state shall not deny or interfere with an individual's reproductive freedom in their most intimate decisions, which includes their fundamental right to choose to have an abortion and their fundamental right to choose or refuse contraceptives."

With the passage of this amendment, abortion in Californians are passionate about the state of human rights around the world, rightly outraged at abuses in some countries that make our stomachs turn. With Proposition 1 we would become more radical than countries we abhor. New Texas Rep. Mayra Flores serves up spicy “Breakfast Taco” Inflation meme to Jill Biden

Mayra Flores served up a spicy reminder to first lady Jill Biden that the crushing inflation that has taken root during her husband’s disastrous presidency is inflicting pain on family budgets and greatly affected the ability to put food on the table by tweeting out a piping hot “Taco Inflation” meme.

The Texas Republican, whose victory in a deep blue district in a special election last month was seen by many as a bellwether for the rapidly approaching midterm elections, broke it down to show the additional amount that it costs to put together a taco with inflation at the highest level in four decades, according to the latest government data which showed a stunning 9.1 percent inflation in June, a major drag on Democrat hopes to extend their one-party rule.

Flores’ meme also included the words “Tacos are unique, ingredients may vary,” a jab at Dr. Jill who was hammered by critics after she likened Hispanics to breakfast tacos during a speech in San Antonio, intending to pander to the key demographic but managing to insult tens of millions of people instead

According to the congresswoman’s tweet, cheese is up 8.7 percent, lettuce 11.4 percent, tortillas 12.8 percent, and meat up an eye-popping 17.4 percent.

The flubbed remarks by the FLOTUS took place at Monday’s 2022 UnidosUS Annual Conference, formerly known as the National Council of La Raza where, during remarks praising UnidosUS President

and Presidential Medal of Freedom recipient Raul Yzaguirre, Biden badly mispronounced the word “bodegas” and dived into racial tropes with her comparison of Hispanics to the ethnic food item.

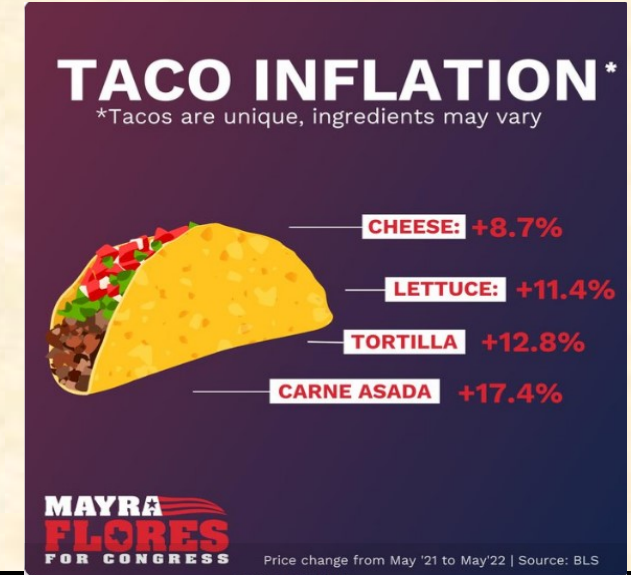
“Raul helped build this organization with the understanding that the diversity of this community, as distinct as the bodegas of the Bronx, as beautiful as the blossoms of Miami, and as unique as the breakfast tacos here in San Antonio, is your strength,” Mrs. Biden said to the stunned audience.

Biden indirectly apologized after her peculiar remarks ignited a firestorm with her spokesman Michael LaRosa taking to Twitter, “The First Lady apologizes that her words conveyed anything but pure admiration and love for the Latino community.”

But Republicans like Flores – the first Mexican-born woman to be elected to Congress – aren’t about to let her off the hook.

“US inflation hit 9.1% over the past year; early polls indicate more breakfast tacos are leaning Republican,” she wrote.

She appeared on Fox News where she said of Democrats, “They think that by giving us tacos and by playing Latin music that that’s all it’s going to take for us to vote for them in November- it’s going to take a lot more than that.”

MY VIEW by Ernie C. Salgado, Jr.: Irony or karma? It really doesn't matter at this point in time as the anti-American woke WNBA superstar **Brittney Griner** pleaded guilty to drug charges in a Moscow court on Thursday, July 8, 2022. As a result, she could face up to 10 years in prison.

"Sources said the guilty plea to charges of drug possession and smuggling was a strategy to help facilitate a prisoner swap that could bring Griner home, and it also was a recognition that there was no way she was going to be acquitted," Quinn reports.

Griner told the judge that she **"inadvertently"** packed the alleged hashish-oil cartridges in her luggage and did not intend on breaking Russian law. ***T'd like to plead guilty, your honor. But there was no intent. I didn't want to break the law,*** she reportedly said.

Despite her guilty plea, the United States government maintains that Griner was **"wrongfully detained"** by Russian officials. U.S. Secretary of State Anthony Blinken emphasized the government's commitment to getting Griner home.

New non-woke comic book rakes in over \$2M, causes massive leftist meltdown

Writer, content creator and musician **Eric July** is bucking woke culture with his first comic book **"Isom #1"** through his publishing company **Rippaverse** and leftists on Reddit are tearing their hair out over it.

He has crowdfunded more than \$2 million in the first few days of pre-orders for the venture. The comic book was launched on Monday and is a viral success. More than 19,000 people have ordered copies of the forthcoming comic book sensation.

And he did it all on a platform he could not get banned from, according to **Bounding Into Comics**.

Reddit has officially banned promotional videos for the comic book from certain subreddits for **"supporting comics from hate groups."** But Americans love it and July is laughing all the way to the bank and thanking God for his success.

July told Fox News that his comic book company does not support hate groups in the least, ***"A lot of it has to do with the fact that I am a person that they simply do not like."***

He is a Libertarian and hosts his own podcast. July has appeared on numerous media outlets as a political commentator as well. He asserts that he is ***"on a mission to spread liberty, speak out against nonsense and work towards a more free and prosperous society."***



The artist believes that Hollywood and entertainment entities are out to ***"beat people over the head with stuff like social justice"*** and left-leaning agendas.

"To see the industry go in the direction that it's gone kind of lights a fire under you," July commented. ***"It's not like it's getting any better. These people are doubling down on everything that they're doing no matter how often the fans reject it."***

That sentiment gave birth to **Rippaverse**.

"I put my money where my mouth is," July declared. ***"I just started a comic book company. I told people I'm not beating the audience over the head with my individual political views with this, and that got me called the most ugly names I've probably ever been called in my life."***

Getting his start as a rapper, July moved into cultural commentary in 2015, making videos about the economy, racism, police brutality, and more. His opinions soon caught the attention of Glenn Beck's The Blaze, where July became a contributor.

"I'm trying to get people thinking more critically about things, get your mind going, and be able to see right through all of it," July stated, according to the **Dallas Observer**.

He's also grown a YouTube channel with nearly 500,000 subscribers, putting him in the top tier of



YouTube commentators on culture.

Amid racist remarks and political jabs, the young Libertarian says it will not stop him from returning comic books to their roots and what they were meant to be.

July points out that people use comic books to get away from the problems they experience in their everyday lives. They want to enjoy themselves and ***"get their morale up."***

"I like seeing people be stoked. I like seeing people be happy and enthusiastic about something that is happening in entertainment. The last five, six years, it's been rough for a lot of people [because] folks have just been holding their nose as they go through and consume whatever entertainment it is that they're consuming," he noted to Fox News.

The comic book publisher wants his fans to share their ideas and build friendships with one another.

"We're seeing success and people are enthusiastic. Customers are enthusiastic and that's why they hate us," he asserted. ***"This is what I do. This is my pas-***

sion. I'm a comic book lifer."

"Isom #1" follows the story of Avery Silman, who is a common rancher in Floreapark, Texas. He ***"obtained some unique abilities"*** and spent a brief time acting as a hero under the moniker Isom.

Things change unexpectedly when he gets a call from his sister about an old friend who has become one of the most feared men in the city. Silman visits his friend and it gets violent as he is sucked into the world of **"excepts"** or **"special beings."**

The comic book is 96 pages long. It is the first foray into the Rippaverse Comics universe. July writes the comics, Cliff Richards does the pencil and ink work, Gabe Eltaeb is the artist who does the color layout, and Eric Weathers creates the lettering.

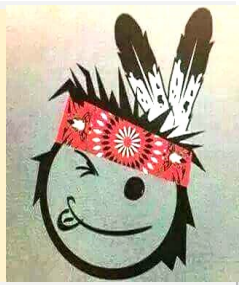
Now, begins the real work, and July is excited over it.

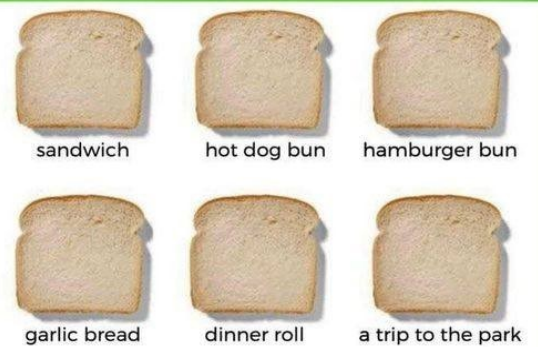

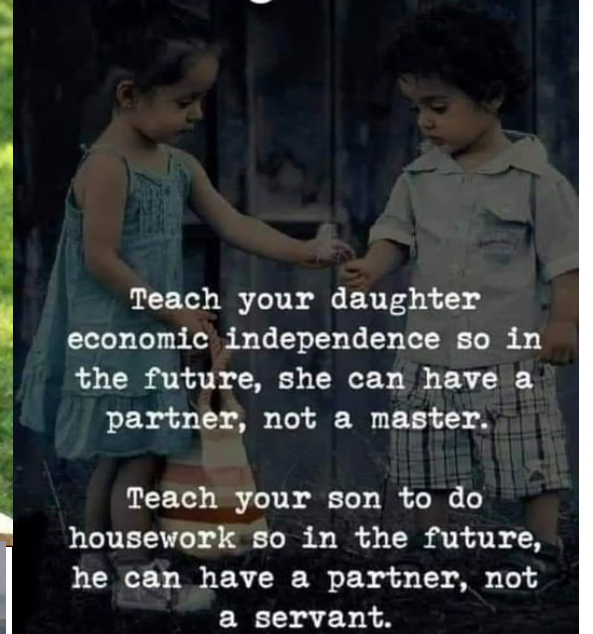

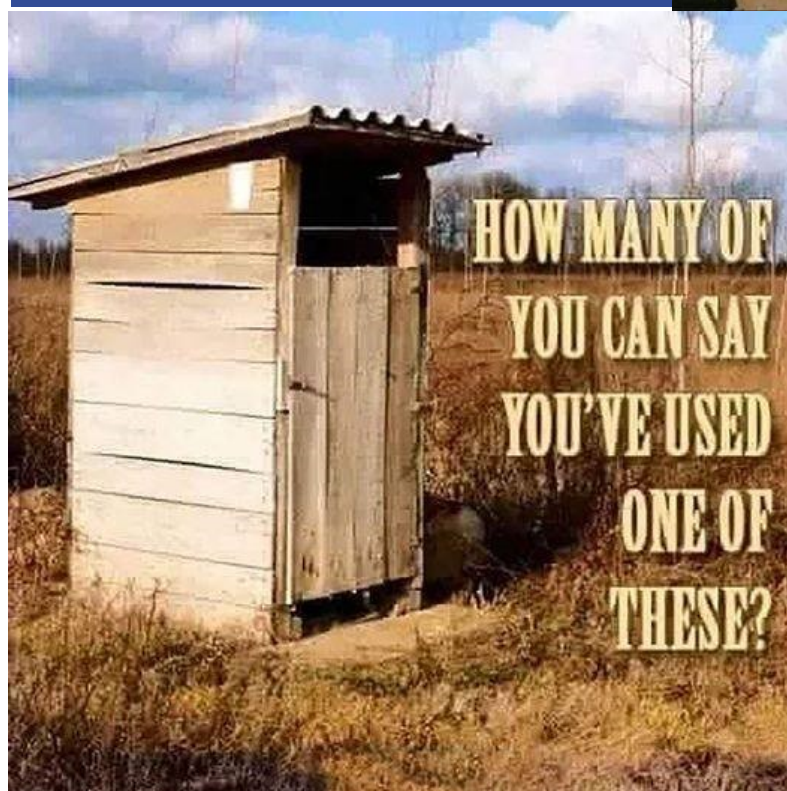
