Democratic gubernatorial candidate Stacey Abrams is defending remarks she made over the weekend that Georgia is the "worst state in the country to live," referring to its poor rankings in maternal mortality and incarceration rates, among other issues.

Abrams's remarks drew instant rebukes from her Republican rivals. One, former Sen. David Perdue, used her comments as a point of departure to accuse her of "demeaning her own race."


Abrams made the comments in question at a fundraising dinner for Gwinnett County Democrats outside Atlanta when she pushed back on Republican Gov. Brian Kemp's frequent boasts about Georgia being ranked the best state in the coun-<u>try for business</u>.

"I am tired of hearing about being the best state in the country to do business when we are the worst state in the country to live," Abrams, who is expected to formally receive her party's nomination for governor in Georgia's primary, said Saturday in remarks that received extended applause.

"Now, somebody's going to try to Politifact me on this - let me contextualize," Abrams continued. "When you're No. 48 for mental health, when you're No. 1 for <u>maternal mortality,</u> when you have an incarceration rate that's on the rise and wages that are on the decline, then you are not the No. 1 place to live in the United States. But we can get there. You see, Georgia is capable of greatness. We just need greatness to be in our governor's office."

Both Kemp and Perdue criticized Abrams for her comments.

Perdue made his response racial during an afternoon interview with John Fredericks, a conservative radio show host who bills himself as "America's Godzilla of Truth."

Centers for Disease Control and Pretion officials said that although any one can catch or spread the monkeypox virus, the "handful" of cases in the United States did not pose a risk to the larger population. They did not say that those infected are predominantly gay men who participated in deviant sexual behavior, although they did say LGBTQ members had a higher risk factor. Unlike AIDS, which hit the gay community hard in the 1980s and '90s, Monkeypox is not deadly, however, it is a disease that is transmitted through direct physical contact, in most cases it has been sexual contact between two men.

According to the World Health Organization, *"monkeypox virus is trans* 

But the CDC is gong out of their way to not stigmatize gay men, widely seen as a nod to progressive activists who have called on the CDC to not label this a sexually transmitted disease.

The fact is, if the CDC was blunt in the 1980's perhaps less people would have become afflicted with the disease. In 2022, there is no reason to not simply come clean and say sexual deviance has consequences, and monkeypox is one of them.

ted from one person to another by close contact with lesions, body fluids, respiratory droplets. and contaminated materials such as bedding. The incubation period of monkeypox is usually from 6 to 13 days but can range from 5 to 21 days."

The zoological virus is from the same family as smallpox, known as orthopoxvirus. It is spread from an animal, like a rodent transmitting to a human, and then spreading through the humans.

McQuiston said the outbreak being observed was from a milder West African strain of the virus circulating for the last few years in that region.

McQuiston also said the virus was not something people would likely contract from casual contacts, such as passing someone in a grocery store aisle.

People developing a rash after a fever were advised to isolate themselves for up to 14 days to prevent spreading the virus to others in their families, Brooks said. McQuiston also said the U.S. had a previous outbreak of monkeypox in 2003.

Over 2,000 American Indians from Oklahoma and New Mexico trained and fought as part of the 45th Infantry Division known as the "Thunderbirds". They saw almost two years of combat in Italy and Central Europe.

During the second World War, the U.S. military recruited American Indian from several different Tribes from trough out the country for their unique tribal 1st languages for usage as a battlefield code.

Lt. Jack C. Montgomery, who also earned the Medal of Honor in World War II for service in Italy, graduated from same school as Childers, the Chilocco Indian Agricultural School in north-central Oklahoma.

tary Campaign he singlehandedly attacked a German stronghold killing eleven of the enemy and taking thirty-three prisoners. Lt. Jack Montgomery graduated from the University of Redlands, California.

Pfc. John Resse Jr. (Comanche) was from Pryor, Oklahoma. On February 9, 1945 he was serving as a private first class in the Philippines. when an attack where he knocked out two machine gun nests and captured seventeen prisoners. He then went on to defeat three German tanks and carried two of his wounded men to safety. All of these exploits reinforced the "warrior" image.

Barfoot had been awarded a combat field commission prior to his action in Italy. He went on to serve in Korea and Vietnam and retired East Indies when the Japaas a Coronel.

After his retirement from the military he moved to a retirement community in Henrico County, Virginia to be near his daughter.

In mid 2009, the homeowners' association (HOA) of the Sussex Square, where Barfoot lived ordered him to remove the flagpole from which he flew the U.S. flag. The HOA bylaws didn't forbid flagpoles, but the HOA ruled Barfoot, then aged 90, would not be allowed to use it "for aesthetic reasons."



## Wearing Native American regalia kept Illinois high school American Indian student from grad walk

An Illinois high school American Indian senior was denied the opportunity to walk with his graduating class because he refused to remove a beaded cap and feather representing his Native American heritage.

NimkiCurleyi, a 17-year-old senior at Evanston Township High School, planned to graduate on May 22, wearing his graduation cap adorned with Native beads and an





eagle feather, WLS reported.

Instead, he was pulled out of line and sat in the stands with his family while his classmates crossed the stage.

"They wanted him to put on a plain one and he said none not walking then." his mother, Megan Bang, wrote on Twitter. "I'm so proud of him and furious at the same time."

Curley told WLS that his beaded cap was not for decoration to spice up typical graduation regalia.

"It's not just, like, a decorative thing," he told the news outlet. "It's a religious belief to hold these feathers sacred."

According to the school about 15 miles north of Chicago, administrators have "consistently shared" that adornment on caps is not allowed during graduation.

"Two people pulled him out and started yelling at him," Bang wrote in another tweet. "... Trying to convince him. Both my daughters consin to study Environmental Engineering. cried watching this unfold."

### **Viet Nam Veterans Memorial** "Wall of Faces"

The Vietnam Veterans Memorial is a national memorial in Washington, D.C., honoring service members of the U.S. armed forces who fought in the Vietnam War.

The 2-acre site is dominated by a black granite wall engraved with the names of those service members who died as a result of their service in Vietnam and South East Asia during the war.

The wall was completed in 1982, has since been supplemented with the statue The Three Soldiers and the Vietnam Women's Memorial.

The wall originally listed 57,939 names when it was dedicated in 1982; however other names have since been added and as of May 2018 there were 58,320 names, including eight women.

In 2003, after some years of lobbying, the National Park Service and the Vietnam Veterans Memorial Fund won permission from Congress to build the Veterans Education Center at The Wall.

The center was to provide biographical details and photographs of many of the 58,320 names listed on the Wall as well as the more than 6,600 service members killed since 2001 fighting the War on Terrorism.

After 15-years of efforts to raise the funding for the memorial center and the collection of 58,242 photographs the project was abandoned.

However, efforts remained to collect the remaining photographs that are still missing. A website had been established that displays the current photos that have been collected.



Janna Hoehn became involved in the Viet Nam Memorial Education Center Project in 2014 in her adopted State of Hawaii with the collection of photographs of the Native Hawaiians that lost their lives or were Missing in Action during the Viet Nam War.

Janna currently lives in Hawaii and is a former resident of Hemet, CA. Because of her growing up in Hemet, California and attending school with many of the American Indians from the local Indian Reservations, Soboba, Santa Rosa, Cahuilla and Ramona she took on the challenge of collecting the photographs of the 232 American Indians and Alaskan Natives that were killed or MIA in Viet Nam.

She was successful in her quest of collecting the 232 photographs of the American Indians and Alaskan Native kill or MIA in Viet Nam and South East Asia.

Her dedication didn't stop with the collection of the photos. In way of example, Joseph "Joe" Pink was not listed as an American Indian and because she knew Joe from high school she gathered the evidence of his tribal affiliation to insure his name was listed.

Although Joe was an enrolled member of the Pala Band of Mission Indians in north San Diego County he grew up in San Jacinto, CA and attended school there.

And although Janna attend school in Hemet her extended family also lived in San Jacinto.




