The Never Ending Tribal Wars

For over 500-years the American Aboriginal People have been fighting to maintain their land, culture and human rights. In their attempt to coexist with the early invaders the various tribes entered into Treaties with the ruling non-Indian political enmities which evolved into the United States of America.


However, the U.S. Government failed to honor the many Treaties forcing the Tribes to seek retribution within the legal venue only to be denied.

Historically, all Treaties and agreement between the American Indian Tribe and U.S. Government are based on foreign laws and doctrine. For example, the Aboriginal people, occupied the lands that are currently referred to as the United States of American when the early European invaded and claimed the continuant under the **Doc**trine of Discovery that emerged during In 1506, Pope Julius II ratified the Age of Exploration. And later with the Treaty of Tordesillas between the Treaties and laws created by the in- Portuguese and the Spanish by issuing vaders.

The current battlefield for the American Indian Tribal Governments is the federal courts including the supreme American jurisprudence court, the congress and executive branch. The first premise that must be understood to have a better understanding of the unique relationship between the American Indian Tribes and the United States Government is that it is political and not based on race.

This relationship predates the 1776 Declaration of Independence and the U.S. Constitution. The political relationship is established around the Treaties between the Tribes and the early settlers and the U.S. Government upon it creation. The U.S. Constitution is very clear regarding the recognition and legality of the Treaties.

However, over the past five hundred years the U.S. Government has failed to honor the majority of these Treaties. Historically, the decisions of the federal courts including the supreme court and the congress have been based on current standards, the impact on the community and who will benefit as opposed to the intent of the Treaty as the rule of In 1452, Pope Nicholas V issued the papal bull Dum Diversas, which authorized Portugal to conquer **Saracens** and **pagans** and consign them to "perpetual servitude." 

Dear Tribal Leaders, Tribal Counsel, and Tribal and Native Organizations,

Please find attached a copy of the Tribal Amicus Brief that was filed today with the United States Supreme Court in *Haaland v. Brackeen* on behalf of 497 Tribes and 62 Tribal and Native Organizations in support of the Federal and Tribal Defendants. Each Tribe and organization signed on individually in support of the Indian Child Welfare Act (ICWA) and the law's focus on the best interests of Native children. This is likely the most tribal signatories that have ever joined together on a single Supreme Court brief and it highlights Indian Country's unity in protecting and defending Native children, Native families, and tribal sovereignty.

An incredible amount of briefs are coming in today in support of IC-WA. We're working on a document that will include links to all of the briefs and a one-sentence summary of each, but they are all located on the Tribal Supreme Court Project page for this case (here) if you'd like to review sooner. The full suite of amicus briefs highlight the broad support for ICWA from states, Congress, former foster children, parent and child advocates, child welfare experts, legal scholars, historians, medical professionals, and more - it's an absolute avalanche of strategic, targeted support for ICWA.

Oral argument has been scheduled for Wednesday, November 9, 2022 and we will be sure to keep you updated on other case developments.



Ramos bill banning derogatory name used for Native American women as geographic name in California goes to governor

AB 2022 heads to governor on a 72-0 -0 vote

SACRAMENTO - A bill to prohibit the use of the word "squaw" (S-word) for geographic features and place names in California by January 1, 2024 has been introduced by Assemblymembers James C. Ramos (D-Highland), the first California Native American elected to the state legislature and Cristina Garcia (D-Bell Gardens), chair of the California Legislative Women's Caucus. Thirteen co-authors signed onto the legislation.

"AB 2022 would ban the use of the S-word and establish a process for renaming locations with that offensive racial and sexist term which began as derogatory word used against Native American women. It is an idiom that came into use during the westward expansion of America, and it is not a tribal word. For decades, Native Americans have argued against the designation's use because behind that expression is the disparagement of Native women that contributes to the crisis of missing and murdered people in our community," Ramos stated.

Ramos added that more than 100 places in California contain the S-word. The United States Department of the Interior has ordered the term "erased from the National landscape and forever replaced" on the almost 700 sites using the name on federal lands. Montana, Oregon, Maine and Minnesota have already banned the word's use.

Garcia commented, "The sad reality is that this term has been used for generations and normalized, even though it is a misogynistic and racist term rooted in the oppression and belittling of Indigenous women. AB 2022 begins to correct an ugly and painful part of our history by removing it from California's landmarks; it's the least we can do to help our indigenous women heal."

AB 2022 would require every state agency, local governing body or political subdivisions in this state to identify all geographic sites, public lands, waters, and structures under its jurisdiction containing the S-word. These bodies shall file a report identifying those names with the California Advisory Committee of Geographic Names. The advisory committee will establish a procedure to elicit input and rename locations that have been identified. In selecting replacement names, local governments, state agencies, and shall solicit input from tribes maintained on the California Native American Heritage Commission list and prioritize their input, as well as the input of appropriate local communities and members of the public.

The proposal defines a geographic feature as any location or publicly owned structure in the state such as navigable water, parks, local roads, bridges and publicly owned buildings. A place is defined in the proposal as a natural geographic feature or street, alley, or other road within the jurisdiction of the state or political subdivision of the state.

AB 2022 is sponsored by the American Civil Liberties Union CA, Alliance for Boys and Men of Color, Restorative Justice for Indigenous Peoples and Renaming S-valley Coalition.
