Democrats and left-wing operatives in the mainstream media say there is “no evidence” that Joe Biden did anything wrong to warrant impeachment.

This key Democrat “talking point” has been carefully crafted as the evidence and seriousness of Biden’s corrupt actions is enough to make your blood boil.

- 1) In July 2023, former Biden business associate **Devon Archer** described how Joe Biden was “The Brand” and was used to send “signals” of power, access, and influence to enrich the Biden family from foreign sources.
- 2) Devon Archer alone was aware of at least 20 times in which then-Vice President Biden spoke on speakerphone with Hunter Biden’s foreign business associates. Democrats would have Americans believe that these phone calls with then-Vice President Biden were simply to discuss the weather.
- 3) In February 2014, then-Vice President Joe Biden dined with oligarchs from Russia and Kazakhstan who funneled millions of dollars to Hunter Biden and his business associates
- 4) In April 2015, then-Vice President Biden dined with Hunter Biden’s foreign business associates, including Ukrainian Burisma executive Vadym Pozharsky. Burisma was then being investigated by Ukrainian Prosecutor General Viktor Shokin for corruption.
- 5) Then-Vice President Biden had coffee with Hunter Biden’s Chinese business associate, Jonathan Li of BHR, in Beijing and wrote a college letter of recommendation for his daughter.
- 6) In 2015, then-Vice President Biden hosted Hunter Biden and Devon Archer and other business associates at the official residence of the Vice President. The topic of discussion was filling the top seat at the United Nations. The Kazakhstani government official who wanted the U.N. position attended both dinners at Café Milano with then-Vice President Biden.
- 7) Using the pseudonym “Robert L. Peters,” Vice President Biden was informed by his staff of a call in 2016 with President of Ukraine Petro Poroshenko. Copied on that official email? Hunter Biden, who was sitting on the board of the Ukrainian company Burisma.
- 8) On December 4, 2015, Biden business associate Eric Schwerin wrote to Kate Bedingfield in the Office of the Vice President providing quotes to use in response to media outreach regarding Hunter Biden’s role in Burisma, a Ukrainian energy company. Later that day, Ms. Bedingfield responded to Mr. Schwerin saying, “VP signed off on this[.]” According to Devon Archer, after a Burisma board of directors meeting in Dubai on the evening of December 4, 2015, Hunter Biden “called D.C.” to discuss pressure that Burisma asked him to relieve.
- 9) In May 2017, James Gilliar, a Biden family associate, emailed Hunter Biden and other associates to formalize how they would divide the profit from their deal with CEFC, a Chinese Communist Party linked energy company. Gilliar indicated Joe Biden would receive 10 percent, which has been confirmed by former Biden family associate, Tony Bobulinski.
- 10) On May 20, 2017, James Gilliar told Tony Bobulinski, another business associate, “Don’t mention Joe being involved, it’s only when u are face to face[.] I know u know that but they are paranoid[.]”
- 11) In a September 21, 2017, email, Hunter Biden wrote that Joe Biden is his business partner and provided Joe Biden’s personal cell phone if the recipient seeks confirmation. Emails also show that Hunter Biden, CEFC officials, and Joe Biden would share offices under the Hudson West/CEFC/Biden Foundation name.
- 12) On July 30, 2017, Hunter Biden demanded money from Chinese business associates and threatened that Joe Biden was sitting next to him: “if I get a call or text from anyone involved in this other than you....I will make certain that between the man sitting next to me and every person he knows and my ability to forever hold a grudge that you will regret not following my direct.”
- 13) On August 3, 2017, Hunter Biden claimed “The Bidens are the best I know at doing exactly what the Chairman wants from this partnership[.] Please let’s not quibble over peanuts.” The Chairman is Ye Jianming is a Chinese billionaire tied to a CCP-intelligence gathering agency. Ye stated that CEFC China’s vision “is to obtain overseas resources and serve the national strategy.”
- 14) During Rob Walker’s recorded interview with the FBI in December 2020, he told agents that Joe Biden attended a CEFC meeting.
- 15) As Vice President, Joe Biden allowed his son to travel on Air Force Two with him to court business around the world. Vice President Biden brought Hunter Biden along to at least 15 countries where he sold “The Brand” to enrich the Biden family.
- 16) Hunter Biden’s business associates reportedly visited the White House more than 80 times when Joe Biden was Vice President.
- 17) In February 2014, a report indicates then-Vice President Biden met with two of Hunter’s Mexican business associates at the White House.
- 18) In October 2015, a report says that Hunter Biden arranged a video call with his father and Mexican business partners. The next month, then-Vice President Biden hosted Mexican business partners and a Biden associate, Jeff Cooper at the Vice President’s official residence.
- 19) In February 2016, then-Vice President Biden allowed his son and Biden associate, Jeffrey Cooper, to fly to Mexico on Air Force 2 to meet with business partners.
- 20) The FBI’s June 30, 2020 FD-1023 form contains allegations that then-Vice President Joe Biden allegedly engaged in an extortion scheme where he was paid \$5 million in exchange for certain actions.]
- 21) Hunter’s pitch to Chinese investors was access to his father, Joe Biden. In September 2011, while his father was Vice President, Hunter wrote in an email that his value to Chinese investors “has nothing to do with me and everything to do with my last name.”
- 22) In 2019, Hunter Biden texted his daughter, claiming that, “unlike Pop I won’t make you give me half your salary.”

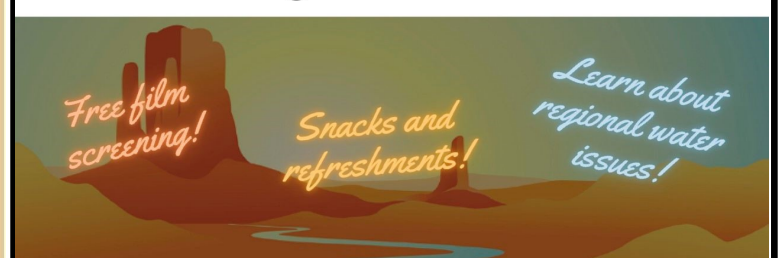

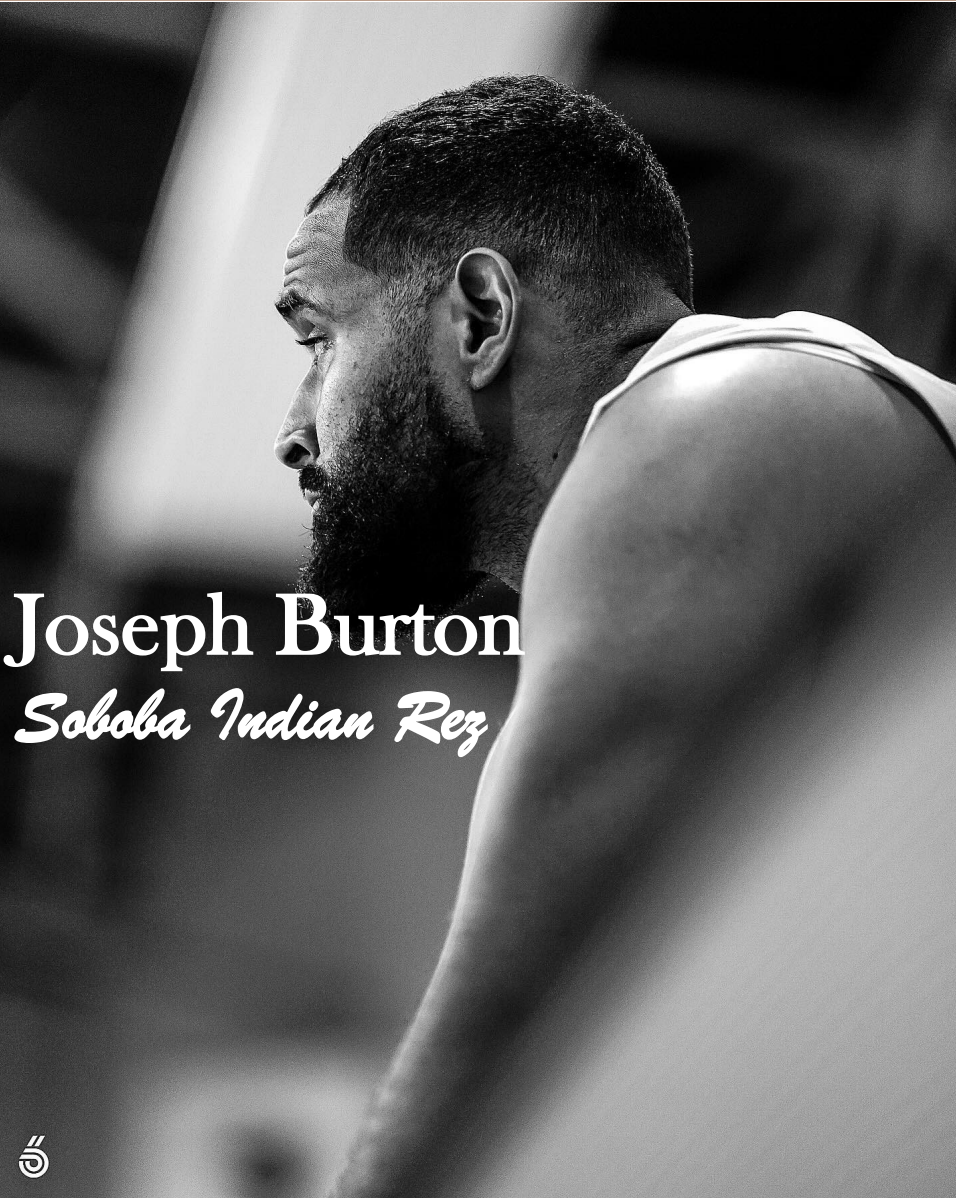

Work on a mine to tap into the country's — and possibly the world's — largest lithium deposit has started in Nevada has begun, but the battle to halt the project is far from finished.

Lithium Americas began construction on the mine on Thacker Pass in Nevada earlier this year after winning federal approval from the Trump administration despite pushback and protests from Native American tribes who as-

cribe sacred and historical value to the land that was once the site of a brutal massacre.

According to generations of indigenous oral history, Thacker Pass was the site of a brutal massacre of 30 to 50 of the Numu people at the hands of federal soldiers in the 1st Nevada cavalry on Sept. 12, 1865.

The massacre was also reported in a newspaper at the time and two witness accounts were fea-

tured in 1929 book, according to the Associated Press.

Despite ongoing legal efforts to block the project, Lithium Americas was approved to start construction.

"All the people here on the reservation were not consulted when this mine was approved," Dorece Sam, a direct descendant of Thacker Pass massacre survivor Ox Sam, told the Guardian.

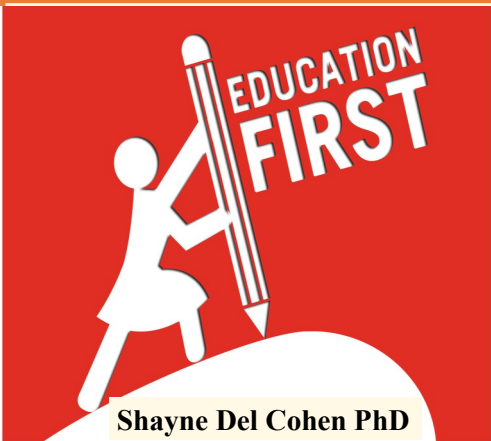

“Every Tribal Community Should Have a Disaster Prevention Plan or Develop One.”



September was National Disaster Prevention Month. While various organizations put out posters and programs as usual they fail to address tribal archives and records

Does your community have a Disaster Prevention Plan for your archives and records? Each community is different, thus each plan will be different. But the knowledge contained therein is critical for future generations. Records, archives and artifacts are not just dusty old boxes of interesting material - they are the presence and voices of past and present who educate for the future.

While generic disaster plans have some templates for business and corporate records, they often do not reflect how records and archives are maintained by tribal communities. Not only are the daily business operations of different units. In many cases, tribes also conserve and protect historical records, photographs, manuscripts and physical ephemera. Often these documents and artifacts are not stored in the same place, so the plan for each site must be developed

Additionally there is now the challenge of electronic records. Fire, floods, hurricanes/tornados, vandals and pests - the usual suspects causing disaster are now competing with electrical outages and hackers.

So your mission, should you choose to accept it, is to review your community’s Emergency Response Plan and if there is none, to create one.

Who is the individual in each tribal unit responsible for records, archives or artifacts?

Does this person’s job description reflect this responsibility?

Have they had adequate orientation and training for emergency responses?

Do they have an emergency response form posted?

Are the corporate papers of a tribe critical, so is there a person with overall supervision of tribal records, archives and artifacts?

Do they do an annual audit of all collections? update responder information?

Is there a clear protocol for the first few minutes and then the hours after an emergency occurs that specifically addresses records, archives and artifacts?

Are emergency numbers and personal contacts clearly posted in areas where records, archives and artifacts are stored. Are these names/numbers included in new employee orientation?

Are first responders, police and fire, oriented to where collections are and what the best method for rescue are? (For example, the best method of rescuing wet paper is to throw it in a freezer. As the paper cells freeze, they force out the water as little ice particles that may be vacuumed off the document.)

Suggested listing include:

Hopefully the Boy Scout motto “Be Prepared” will ensure you and your staff will never have to utilize the listing, but the hour to prepare the information will save you many dollars and time, to say nothing of irreparable loss should Mama Nature or some wayward individuals target your collections.

In closing I will note that your Insurance should cover the ability to create replacement and interruption of business costs.

Additionally, a tribal ordinance that defines tribal records, archives and artifacts as tribal property then provides a clear legal path to indict and punish any who damage or steal said property.

Biden administration pushed social media networks into potential First Amendment violations, federal appeals court affirmed

The White House, health officials, and the FBI possibly violated the 1st amendment regarding people’s posts on social media about Covid 19.

The decision from the 5th Circuit Court of Appeals partially upheld an order from a Louisiana federal judge that banned some federal agencies from having contact with companies like Facebook, YouTube, and X (then Twitter) regarding content moderation.

The three Republican judges wrote, “There would be no way for a federal official to know exactly when his or her actions cross the line from permissibly communicating with a social-media company to impermissibly ‘urging, encouraging, pressuring, or inducing’ them ‘in any way.’”

The Fifth Circuit criticized the injunction issued by U.S. District Court Judge Terry A. Doughty, a Trump nominee, as “overbroad,” “duplicative,” sometimes “unnecessary,” and potentially limiting legal government actions.

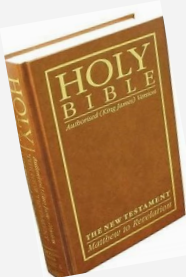

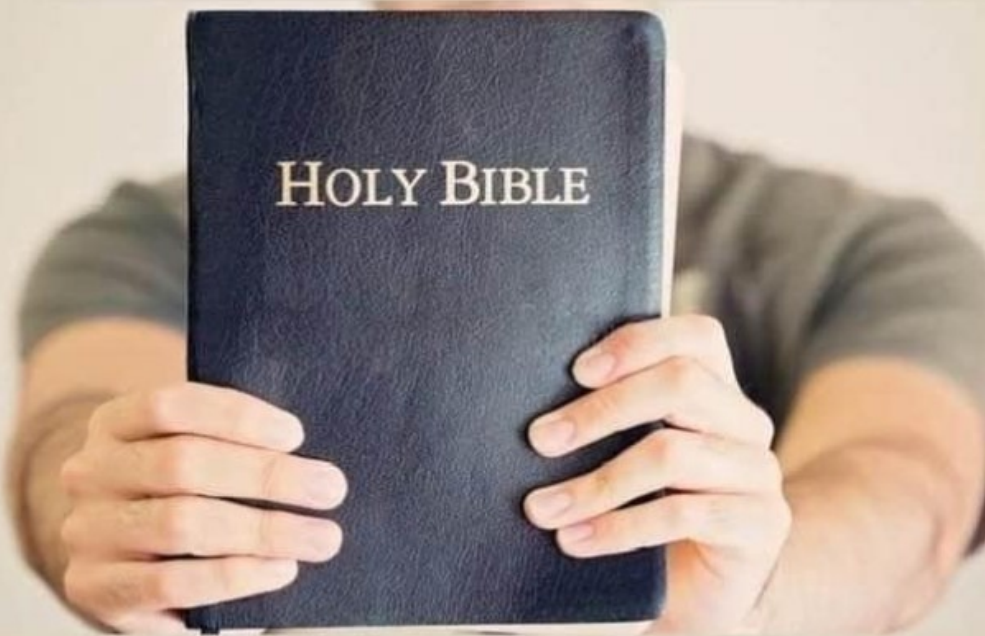

FLORIDA JUDGE BACKS CHRISTIAN TEACHER WHO REFUSED TO USE STUDENT’S PREFERRED PRONOUNS: ‘GOD MADE NO MISTAKES’

Van Laningham wrote in his decision that Mundaray told Pat she could not comply with the child’s request because of her Christian faith. Pat replied, “*I think God made a mistake.*” “*I’m a Christian, and my God made no mistakes,*” Mundaray responded.
