Go in Peace & God Bless, My Friend

I had the distinct honor of meeting Governor Richardson in San Francisco CA around 1993-94. He was a Representative for New Mexico and was serving on the Subcommittee on Native American Affairs in the 103rd Congress (1993-1994) during the Clinton years and was the lead on the Federal Recognition Commission.

Regional Tribal Federal Recognition Commissions were established through out the Nation. In California the Commission consisted of nine tribal reps. of which six were selected by the federally recognized tribes and the un-federally recognized tribes had three.

California was divided into three regions, Southern, Central and Northern. Each region had three representatives consisting of two recognized Tribal representatives & one un-federally recognized Tribal rep.

Joaquín (Jim) Fletcher from Pechanga and I (Soboba) were the recognized tribal reps. for the Southern CA region & Mrs. Mitchell was the representative for the un-federally recognized Tribes. She was a member of the San Juan Capistrano Tribe.

Needless to say the over all experience was heart warming when a Tribal group was granted Federal Recognition. The qualifying criteria was a little strenuous, & a lot of the groups were not able to make it. That was very had for me because I new in my heart they were Indian people.

Although the Regional Federal Recognition Commissions were tribal and selected by tribal members the criteria to gain federal recognition was created with little tribal input. Regardless of this short coming many tribes were granted Federal Recognition status which is a good thing in my view.

The historical background said and done we can get to the **“True Bill & Ernie Story”**

I got a phone call from the Commissions’ Chairman asking if I could attend an emergency meeting in San Francisco the next day at 1pm for a couple of hours and return home on the 6pm flights. The purpose of the meeting was to see if we could resolve a Tribal conflict so that the Tribe could gain Federal Recognition.

Congress was getting ready vote to grant federal recognition status to a number of tribe in the Nation and wanted to resolve the California issue before it’s congressional session ended in a few days.

The conflict was with the San Juan Capistrano Tribal Leadership. It seemed they had two separate groups claiming legal representation of the Tribe, Two Tribal Councils. One of the Tribal Groups was on record as filing the request for

Federal Recognition while the other group claimed that they were the legal elected Tribal Council.

Rep Richardson was attending the meeting and a quorum was committed to attend.

I flew out of Ontario and Jim caught a commuter flight from Sacramento where was working as the Director of the State Housing at the time. Mrs. Mitchell and a couple of her supporters flew up the night before as did a couple of the original Tribal Council.

Pointless to say their was a lot of tension in the room the next day and as with most things Government, we had a delay.

While we’re standing around shooting the bull, Jim, myself a couple of other guys on the Commission and another guy I didn’t know, but he fit right in with the rest of us in a polo shirts, Lévi’s and wingtips and I’m thinking we’re waiting for Richardson and he’s already a half hour late.

Jim and I had already talked to Mrs. Mitchell about the concerns as well a one of the guy on the opposing team. I can’t remember his name. He was an attorney and had worked for Governor Jerry Brown during his 1975-83 term along with Ed Castillo and Joe Carrillo from Tule River.

So as we wait I go into **“Ernie insert Foot in Mouth Mode.”** First thing out of my mouth was, **“What the f.k, this ass..le think he’s the only one got a business to run?”** And we’re off to the races. I’m on a roll & and it got worst from there until the suit shows up and the guys standing next to me excuses himself and heads for the suit. I’m thinking he must be the suits flunky. Hopefully he’ll blow it off.

The suit addresses the room apologizing for the delay. He said he was waiting for a call from Washington D.C. regarding this matter, (*This was before cell phones*) he then said. **“I’ll let the congressman explain it to you, please have a seat.”** Me, I’m trying to find a hole to crawl into.

I glanced over at Jim and he’s smiling like the cat that just caught the canner. He knew Richardson. I had just made a complete Ass of myself and he thinks its hilarious.

Richardson had met with the California Commissioners in Sacramento CA a couple on months earlier. **It didn’t end there.** Richardson smiled and looked right at me and said **“Don’t worry about the time Ernie, we’ll get you out in time.”** Still no hole to crawl into.

He turned out to be a great guy, he came up to me after the meeting and shook my hand and said **“be safe my friend.”** And although we were never close we could always count on him.

Richardson told the group that the call from Washington was not the best news as the vote for federal recognition would take place in two hours and since congress already has a formal tribal council request for federal recognition they would not include San Juan Capistrano in the vote for federal recognition in the midst of an internal political conflict.

Richardson explained to the groups that congress was not going to deal with a local political issue. He told the group that even if the primary tribal council stepped down San Juan Capistrano would need to start the process all over again.

He was honest and brutally frank with Mrs. Mitchell’s group suggested that they compromise and dissolve their claim and reduce it to writing and allow the original group to represent the Tribe and gain Federal Recognition and come-back to fight another day. It was a no brainer.

In a word she said. **“No.”**

In addition to being a day of total humiliation by making a complete fool of myself, it was a very sad day, especially for the tribal people of San Juan Capistrano.

It’s been over 30 years & I often think back and wonder if there was something I could have done to change the outcome. I shake my head to the potential of San Juan Capistrano as a U.S. Federal Recognized Tribal Nation.

The people of San Juan Capistrano deserved better.

DOJ blocks Rachel Levine from being exposed in Alabama's law on banning sex changes for minors litigation

The Department of Justice intervened to protect Biden appointee, assistant secretary for health Dr. Rachel Levine, from discovery in Alabama litigation relating to its ban on transgender sex change procedures for minors.

Alabama's attorney general – Steve Marshall – is defending litigation against an Alabama law that made it a felony, punishable by up to 10 years in prison, to prescribe puberty blockers or hormones to transgender children for a sex change.

The Department of Justice requested to be a

party in a lawsuit against the Alabama law blocking sex changes for minors, making some federal agencies considered experts on the topic, subject to discovery. Discovery is a procedure during litigation in which parties present and request evidence before trial.

Marshall then requested Levine's records, believing she is one of the primary voices in the federal government – and relevantly in the Health and Human Services Department – who is advocating for sex changes in children with gender dysphoria.

"It is not hyperbole to say that Admiral Levine is the leading public-facing official in the United States government when it comes to transitioning treatments for minors," the AG said in a court filing. It proceeded to mention how Levine *"routinely endorses puberty blockers and cross-sex hormones"* for minors, lectures physicians discussing the treatments, and oversees the division at HHS that published the federal guidance endorsing sex changes for minors.

DOJ claims subpoenas can't 'be enforced' in Hunter probe, blocks testimony from FBI and IRS agents

Department of Justice Assistant Attorney General Carlos Uriarte fired off a letter to committee Chairman Jim Jordan (R-Ohio) informing him that the agency would not comply with subpoenas in the Hunter Biden probe.

The letter informed the House Judiciary Committee on Tuesday night that it was refusing to cooperate with subpoenas for two FBI agents involved in the department’s investigation of Hunter Biden. The refusal was ostensibly because of the committee’s stipulations for their depositions.

A letter obtained by the Washington Examiner written by Uriarte to Jordan asserted that his subpoenas to the two agents “lack legal effect

and cannot constitutionally be enforced” because Jordan had prohibited DOJ lawyers at their depositions.

“The subpoenas issued by the Committee prohibit the attendance of agency counsel at appearances by two FBI employees where the Committee has indicated it will ask questions regarding information they learned within the scope of their official duties, including regarding the ongoing criminal investigation,” Uriarte stated in the letter.

He also called the compelled testimony from special agents Thomas Sobocinski and Ryeshea Holley of the FBI’s Baltimore Field Office “premature.”

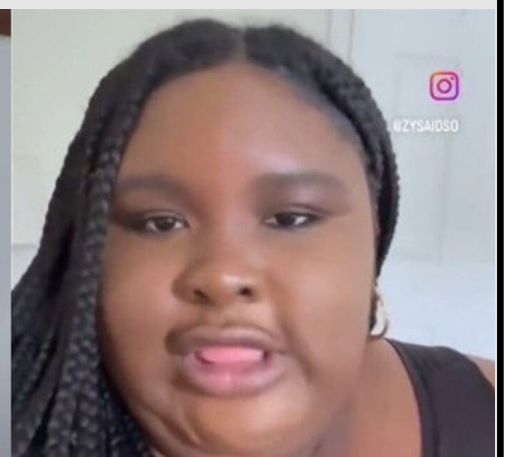
Dove faces growing boycott over partnership with morbidly obese BLM activist and hate hoaxter

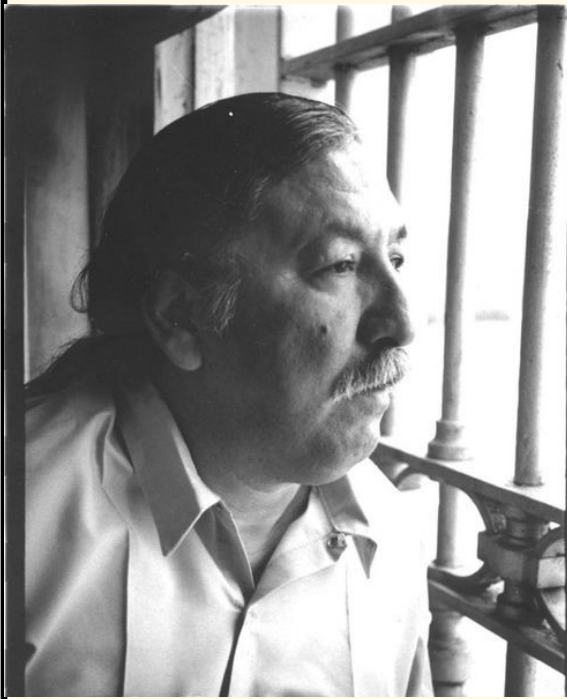

President Biden, Listen to Indigenous Voices: Free Leonard Peltier.

As the son of a law enforcement officer who was killed in the line of duty, I do not take the writing of this lightly. My father, Leslie Macarro, died in 1988 when I was 24 years old, and I know the depths of grief a family bears with the loss of a loved one.

I have also been a Tribal leader for more than 30 years and currently serve as the 1st Vice President of the National Congress of American Indians (NCAI), the oldest, largest, and most representative American Indian and Alaska Native organization in the United States.

This background has given me a perspective on the equitable application of justice that compels me to urge President Biden to immediately grant executive clemency to Leonard Peltier or support his petition for compassionate release.

Leonard Peltier, a citizen of the Turtle Mountain Band of Chippewa Indians (ND), is in his 48th year of imprisonment. He is serving two life sentences for aiding and abetting in the deaths of two FBI agents during a shootout on the Pine Ridge Indian reservation in South Dakota in 1975 - a case where his co-defendants, principally charged with the crime, were found not guilty on grounds of self-defense.

Mr. Peltier will be 79 years old on September 12, 2023 - now a frail and elderly man who continues to serve out his sentence at the maximum-security facility at the United States Penitentiary - Coleman, in central Florida. Imprisoned at the age of 32, his conviction is turning into a de facto death sentence.

Serious questions about the fairness of his trial have been raised, including clear due process violations and evidence of racial prejudice by one

of his jurors. The FBI investigators on the case, moreover, intimidated witnesses, coerced false testimony, and withheld evidence.

In fact, in recent years, several officials involved in prosecuting Leonard Peltier's case have come forward in support of his release, noting the prosecutorial misconduct and constitutional violations that led to his conviction.

Gerald Heaney, the judge who presided over Mr. Peltier's 1986 appeal in the Eighth Circuit, has called for his release and former United States Attorney James Reynolds, whose office handled the prosecution and appeal of Peltier's case, has called for the commutation of the remainder of his sentence and observed that, *"his conviction and continued incarceration is a testament to a time and a system of justice that no longer has a place in our society."*

The United Nations Working Group on Arbitrary Detention specifically noted the anti-Indigenous bias surrounding Peltier's detention, stating simply that he *"continues to be detained because he is Native American."*

Retired FBI Special Agent Coleen Rowley, who served with prosecutors and agents directly involved in Mr. Peltier's case, wrote President

Biden last December and noted the impacts and role the *"long-standing horribly wrongful oppressive treatment of Indians in the U.S."* played in Peltier's case and, critically, the *"FBI Family vendetta"* behind the agency's opposition to clemency.

Peltier's release is no doubt a politically sensitive one for any president. For decades, the FBI has campaigned to keep him behind bars. But President Biden has pledged that racial justice would be a core pillar of his domestic agenda, including a comprehensive overhaul to the clemency process to redress historical inequities in the criminal justice system. **The President further underscored his commitment to equal rights for Indigenous communities.** And as he ramps up his visits on the campaign trail, rest assured that our communities will be asking him about his commitment to mend the relationship between Native Americans and the U.S. government.

On February 14, 2022, the NCAI adopted a resolution for the third time in its history in support of Leonard Peltier's release.

Mr. President, I urge you to listen to the voices from Indian Country, joined by human rights leaders around the world, and free Leonard Peltier.

More than 30 Arrested in Washington, D.C. at Leonard Peltier Demonstration

Today, 35 people were arrested and cited for violations in Washington, D.C., during a planned demonstration near the White House advocating for the release of Leonard Peltier from federal prison.

The organized demonstration took place near Lafayette Square, a public park just north of the White House, bringing hundreds of supporters to push an organized message to President Biden to free Peltier from

prison on his 79th birthday.

"For 79 years, this warrior, a relative, our elder, walked these lands with purpose, with a fire, and with a calling, a special calling upon his life, and he has galvanized a movement for justice in the United States," said NCAI President Fawn Sharp at Tuesday's rally in front of the White House. *"I want to stand here with you, as we celebrate, our Elder, as we celebrate the sacred day he was born."*

Among those arrested were "Reservation Dogs" actor Dallas Goldtooth, NDN Collective CEO Nick Tilson, National Congress of American Indians President Fawn Sharp, Amnesty International USA Executive Director Paul O'Brien, Chris White Eagle, and Hermus Betteyoun for blocking a sidewalk. The arrests all came with a \$50 citation and no one was taken to jail.

Dakota tribe reclaim its native land back from the government after 160 years in joyous feat

The Land Back movement in America and Canada in recent years has garnered a lot of support. The objective of this movement is to give the control of the land back to the native tribes. These tribes lost the land because of manipulations by the colonial forces. Most of the time the authorities duped them and did not fulfill the promises they made to the tribes. For years tribes have been trying to garner some control over the land that was snatched away from them through petitioning and raising awareness. They have garnered a huge victory in this battle as the Upper Sioux Community has finally succeeded in getting their ancestral land back, as Bored per Bat.

The Upper Sioux Agency State Park holds a lot of significance for the namesake tribe because it is present as the burial site of their ancestors. These ancestors died fighting their colonial rulers in a war that was fought to make the former realize their end of the bargain. After almost a century the tribes will finally have the chance to get the land back for which their ancestors sacrificed their lives. This rare step has been taken by the Minnesota State as a means to apologize for the gruesome act that took place at the time, resulting in the largest mass hanging in US history.

Kevin Jensvold, chairman of the Upper Sioux Community, reflected on the importance of the park for his tribe, "It's a place of holocaust. Our people starved to death there." The park measures a little more than 2 square miles and houses a federal complex in which officers withheld food and other essential items from the native tribe. This action caused a wave of death and starvation among the people of the tribe. The starvation and backing away from promises have been cited to be the primary reasons behind the U.S.-Dakota War of 1862 between settler-colonists and a faction of Dakota people.

Despite Supreme Court ruling, ICWA challenges remain

Although the U.S. Supreme Court upheld ICWA in June, challenges have continued in state courts

The nation's highest court recently upheld the Indian Child Welfare Act (ICWA) in a major case over the law's constitutionality, a decision hailed by many as a victory for Indigenous children and their families.

But while the 7-2 majority decision in the Brackeen v. Haaland case firmly rejected key arguments against the law known as ICWA, state-level challenges have been moving through lower courts across the country, with varying degrees of success.

Cases in Nebraska, Alaska, Iowa, Montana and

Oklahoma center on different legal issues than those decided by the U.S. Supreme Court last month. Plaintiffs in Brackeen v. Haaland — a group of states along with white adoptive parents seeking custody of Native children — argued unsuccessfully that ICWA was unconstitutional because it exceeds the “plenary powers” of Congress to pass legislation governing tribal affairs, “commandeers” states to follow federal law and violates equal protection guarantees

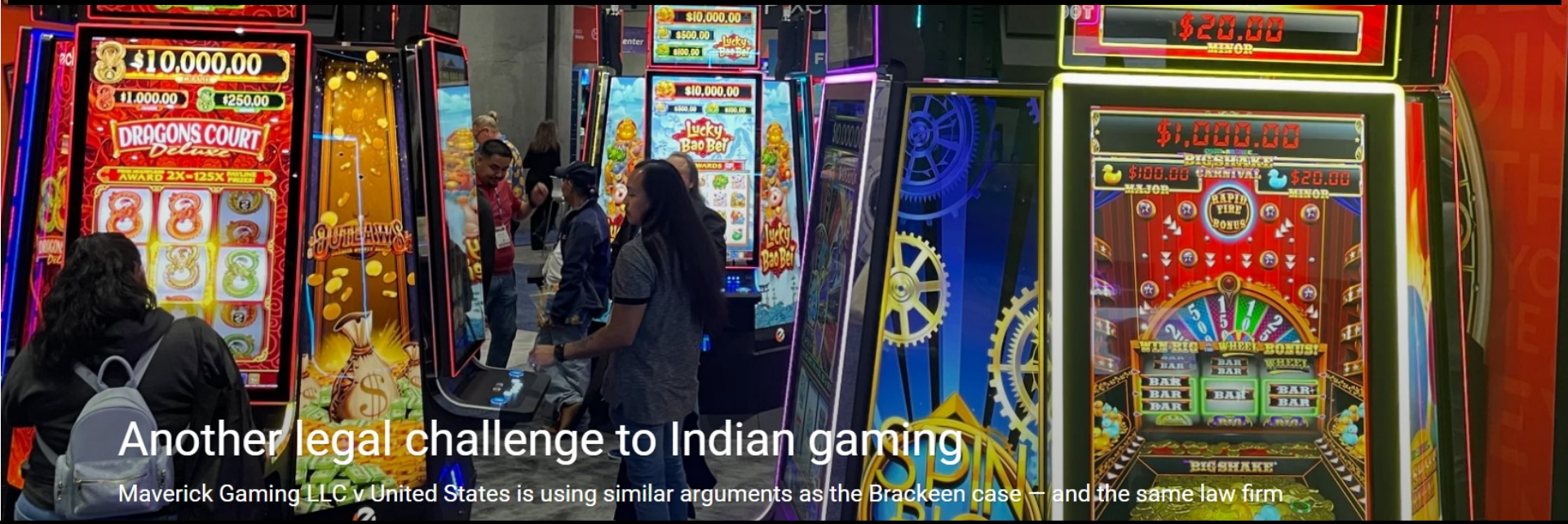
Yet while the Supreme Court upheld ICWA's constitutionality for now, legal experts who are both supporters and critics of the 45-year-old

federal law say the Brackeen case doesn't rule out future challenges to tribal sovereignty.

What's more, justices declined to delve into the equal protection arguments in the case, stating only that the plaintiffs “lack standing” on that issue because the adoptions of Indigenous children they sought had been finalized. Some court watchers say that leaves open the possibility of future lawsuits on equal protection issues.

Another legal challenge to Indian gaming

Maverick Gaming LLC v United States is using similar arguments as the Brackeen case — and the same law firm

SAN DIEGO — Owner of Maverick Gaming, Eric Persson, was in an interview with Fox News at one of the 31 casinos he owns across the West called Great American Casino in Tukwila, Washington. Persson was wearing a baseball cap with his company's logo on it.

“There's zero circumstances in which I'd settle,” Persson said resolutely. “There's zero circumstances in which I'd quit. I have the resources to go all the way, and so do they. So there's going to be a battle. We're going to have a lot of fun, and I'm going to win.”

In Washington, card rooms attached to bars and restaurants are legal. At one point there were over 200 card rooms but that number has dropped significantly.

“We've seen as it's been reducing, it's been consolidating and turning more into a casino business than a

mom and pop restaurant with a game to play to help increase the sale of cheeseburgers and beer,” said Christine Masse, an attorney at Miller Nash LLC during a panel at the 2023 Indian Gaming Association Convention and Tradeshow in San Diego, California.

“We're talking about basic infrastructure and in my lifetime running water,” George said. “To think of the undoing of IGRA, it's hard to stomach as an Indian person from the reservation, knowing and seeing where this money goes.”

Persson, a competitive poker player, now owns 23 of the 40 or so card rooms in the state. Shockingly, the Shoalwater Bay citizen is the lead plaintiff in Maverick Gaming LLC v United States, a case challenging the Indian Gaming Regulatory Act on the ground of equal protection, stating that tribal status is based on race. Tribal status as a political classification is affirmed by treaties, the United States constitution and several case laws including Morton v Mancari.

First red heifer in 2000 years fulfills Biblical prophecy and signals ‘end of days’

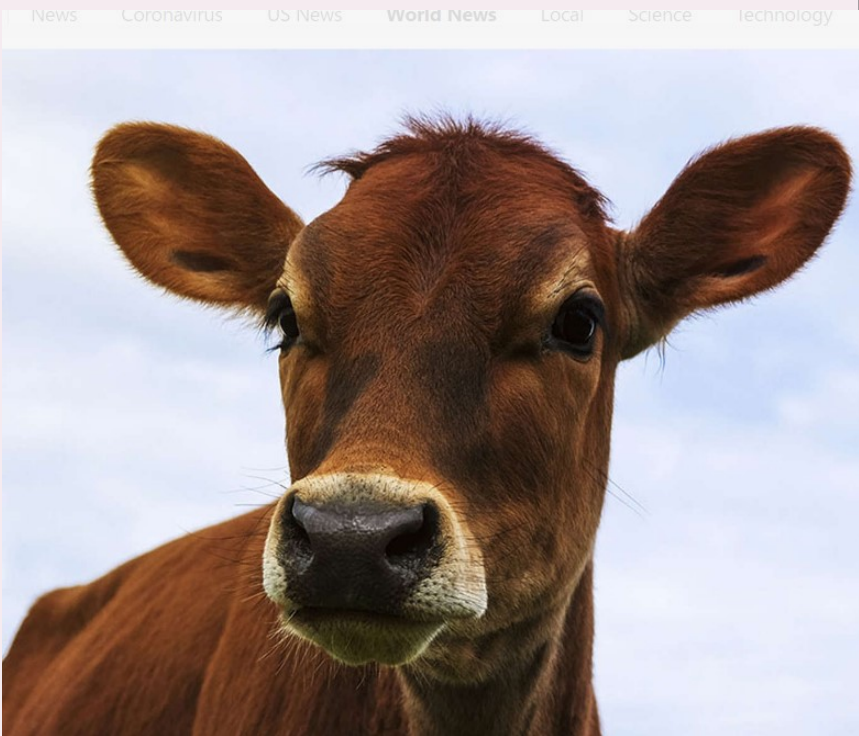
When it comes to biblical prophecy and the anticipation of the “end of days,” few phenomena have captured the imagination of believers in Christianity and Judaism as profoundly as the concept of the red heifer. The birth of a red heifer is not merely a biological occurrence; it is laden with theological and eschatological significance. 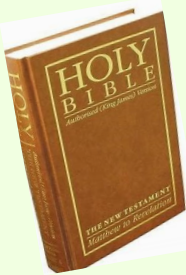

'We've got a real crisis coming': Kevin O'Leary warns the US is headed for trouble thanks to the 'unprecedented' speed of interest rate hikes

about a “crisis emerging” in the United States. In a recent [interview on Fox Business](#), the entrepreneur and television personality was asked if the small and mid-sized businesses he works with are becoming more optimistic about the economy. *“No, that’s not what I hear, and I live in the real world,”* he said.

O’Leary expressed his concern with [rising interest rates](#), and with further rate hikes on the table, he worries it could push some businesses into deep distress.

Small business outlook

Small business optimism ticked up recently. The National Federation of Independent Businesses’ [Small Business Optimism Index](#) increased 0.9 points in July to 91.9, although that’s still lower than the 49-year average of 98.

O’Leary believes the numbers mask a deeper issue.

“We have a crisis emerging,” he said, referring to the 10 consecutive [interest-rate hikes the Federal Reserve](#) has imposed since March 2022. *“These rapid rate hikes that have occurred and the unprecedented speed of these hikes has put my small businesses [in a difficult position] ... The cost of capital has gone through the roof.”*

O’Leary believes smaller companies are particularly vulnerable.

“If you’re in the S&P 500, you have no trouble financing your business,” he said. *“You can’t say that about small businesses anymore.”*

He goes on to highlight the fact that small busi-

nesses with five to 500 employees represent 60% of the U.S. economy, which is why this liquidity crunch is a concern.

“We’ve got a real crisis coming here,” he said. *“When the Fed raises rates another 50 basis points that’s going to make it worse.”*

Republican Georgia Attorney General Chris Carr has indicted dozens of people on racketeering charges over years of riots and protests in opposition to the Atlanta Public Safety Training Center, which is under construction. "Cop City," as the facility has been called by left-wing activists, has been targeted since it was announced by organized protesters.

In an indictment that was announced on Tuesday, Carr called those who have been targeting the facility *"militant anarchists,"* the [Associated Press](#) reported. The indictment, which is dated Aug. 29, uses Georgia's anti-racketeering

or **RICO** law and targets 61 people. This is the same statute Fulton County prosecutor Fani Willis has used to charge former President **Donald Trump** and 18 other people for questionable alleged crimes related to the challenging of the state's 2020 election results.

Carr's indictment could be viewed as a sign the state's Republican Party is fighting fire with fire. The AG has accused all of the defendants of conspiring to obstruct the construction of the police and fire training center, accusing them of violence, intimidation and destruction of property.

In July, a police cruiser near the facility was targeted by an arsonist. Other fires were set in March when the facility was targeted by masked protestors but the effort to prevent it from being completed started in 2021. Carr cited the instances of violence and intimidation as his rationale for going after the individuals he said were behind it.

Those of you that read my “Journal” (www.shaynedel.com) know that at the beginning of each month I publish a list of scholarships with the application deadlines a month away. Believe it or not, this is only the tip of the iceberg.....there are many more to be found.

(One of the great services of American Indian Reporter is that they have created a searchable archive wherein one can pull up past issues and retrieve such scholarships at shaynedel.com).

I would encourage everyone to read the lists, even if you are not looking for post secondary financial assistance. Although it may appear tedious, reading each description of the myriad of scholarships is very instructive.

First of all for students, reading about the different kinds of opportunities and different educational institutions available can help a student who has not yet found their passion or direction to get ideas. Many scholarships are now granted to juniors in high school so starting early never hurts!

Scholarships are also indicative of

new “professions” or 21st century manifestations of prior files. STEM enrollment garners many scholarships and there is definitely a focus on computer engineering and cybersecurity. I have noted that several of the traditional garden club sponsored scholarships have enlarged their definition of study area into horticulture, land use/landscaping and water conservation. Terms like “supply chain management” have become eligible majors. One can also bet that studies in artificial intelligence and related topics will soon be encouraged.

From theological institutions with decades-old curriculum to the essay contests for atheists and agnostics, each subject silo has wide parameters, encouraging creativity in application.

Beyond the standard paper forms, many applications are now electronic and emerging are the video and essay contests rather than traditional submittals.

Language studies are gaining support and I anticipate there will be awards to help students decipher cursive. Again this skill is vital for those doing tribal research and rights assertion.

For students, counselors, parents and the general public, the perusal of the variety of scholarships shows the society’s perception of some of the very unique situations in which students find themselves

From those suffering cancer, autism, physical challenges, leukemia, diabetes, etc. there are scholarships catering to them. There are more numerous scholarships for trade schools, single mothers, people re-entering a higher education path after several years and substantial financial assistance for vets or children of vets as well as those who lost a parent in community service (police/fire/armed service).

Many students, families and counselors do searches using “Indian, Native American and rarely Indigenous”. This is very limiting as the number of scholarships for “traditionally overlooked”, “marginalized”, “people of color”, etc. now fill the lists and limiting one’s search to the ethnic terms will

not provide the wider swath of opportunities.

Some scholarships are geographically targeted. These are worthwhile reading even if you do not live in the area. First off, you may know someone in that part of the country to whom you can make a referral and secondly, if a scholarship appears in one place of the country, it may be sponsored by a sister organization/chapter in your area. A quick google search will tell.

Lastly, reading the panorama of scholarships may give you, your business, your civic organization, etc., an idea of what kind of education boost project they might sponsor. We all know “education” is a valuable tool; though many systems are now providing tuition-free assistance to native students, there remain the associated costs of housing, food, transportation and supplies to be covered.

Community foundations will often host your scholarship, relieving you of the administrative burden and shining a spotlight on what may be an invisible population in your community. Be creative; be assertive - the next generation will continue your legacy.

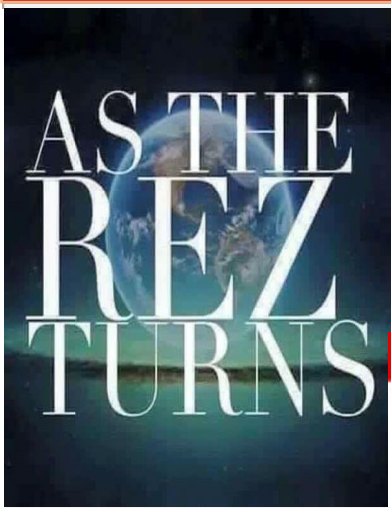

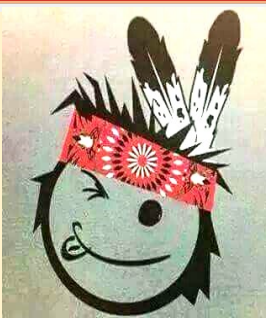
