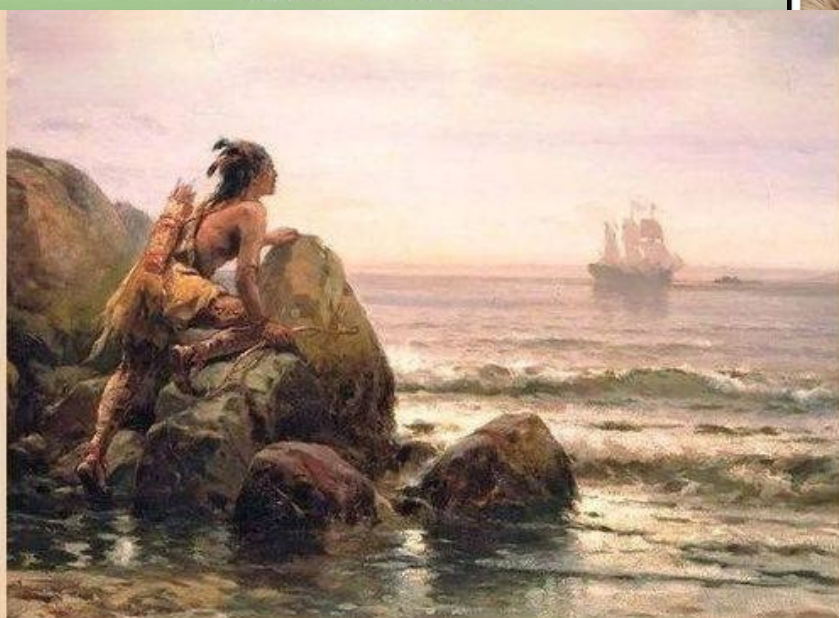

- The Uintah and Ouray Reservation in Utah is the second largest, covering 6,800 sq miles. It is home to the Ute tribe, divided into three bands.
- The Tohono O'odham Nation Reservation in Arizona is the third largest, but most people live off the reservation. It features astronomical sites like the Kitt Peak National Observatory.

There are many (565 American Indian Rancherias, Villages and) reservations in the United States for Native Americans. These often have long and troubled histories, and they are mostly found in the western half of the country. Some of these reservations are open to visitors, while others are largely closed off to outside visitors. Some are quasi-nations in their own rights, while others are uninhabited

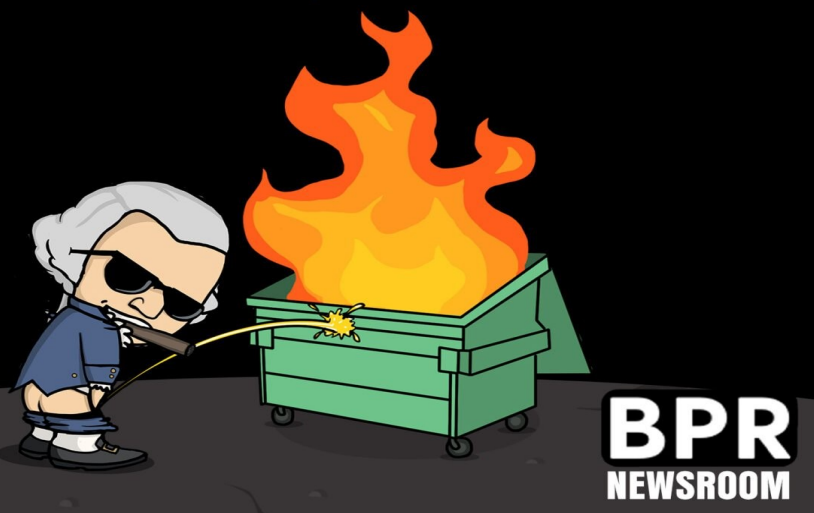

Supreme Court to consider Biden admin censorship efforts in historic free speech case

Years of government takedown requests and meetings with social media platforms to discuss "misinformation" will culminate Monday (March 17, 2024) in a case before the Supreme Court.

The case, *Murthy v. Missouri*, asks the justices to consider what a district court judge referenced as the Biden administration's "Orwellian" efforts to suppress speech online. It stems from a lawsuit filed in 2022 by the attorneys general of Missouri and Louisiana along with five individual plaintiffs whose speech was censored on social media.

"Even if you have not been personally censored, you've been impacted by this censorship because the First Amendment exists, not just for the speaker, but also for the listener," Dr. Aaron Kheriaty, one of three doctors who joined the case as a

plaintiff, told the Daily Caller News Foundation. "It's necessary in a democracy that people have access to both sides of a contested issue or a public debate."

Records obtained by the plaintiffs in the course of the litigation highlighted explicit requests by the White House asking platforms to remove posts "ASAP" or take down an account "immediately" — along with demands using more colorful language.

"Are you guys f***ing serious?" the White House emailed Facebook on July 15, 2021, the same day the White House and the surgeon general held a press conference calling for platforms to be held accountable for allowing the "poison" of misinformation to spread.

Cherokee Nation-(1951-)

Sonny Sixkiller, an American Indian professional football player, quarterback position, is a Cherokee Nation tribal member. He was born in Tahlequah, Oklahoma on September 6, 1951. His family moved to Ashland, Oregon, when he was about one year old.

HIGH SCHOOL FOOTBALL STAR

Young Sonny attended Ashland High School in Ashland, Oregon, and wanted to play in-state college football for Oregon State, but they didn't offer him a scholarship (it's been said) because of his small size for professional football: 5'11" and 171 lbs.

COLLEGE FOOTBALL STAR

However, Sixkiller did receive a scholarship to the University of Washington in Seattle. As a sophomore in 1970, he became the starting quarterback for the Washington Huskies and led the NCAA in passing. Sonny Sixkiller was a stand-out athlete and held some fifteen school athletic records.

WASHINGTON UNIVERSITY

In just 28 games (1970-1972), Sonny Sixkiller became one of the most popular players in Washington University athletic history.

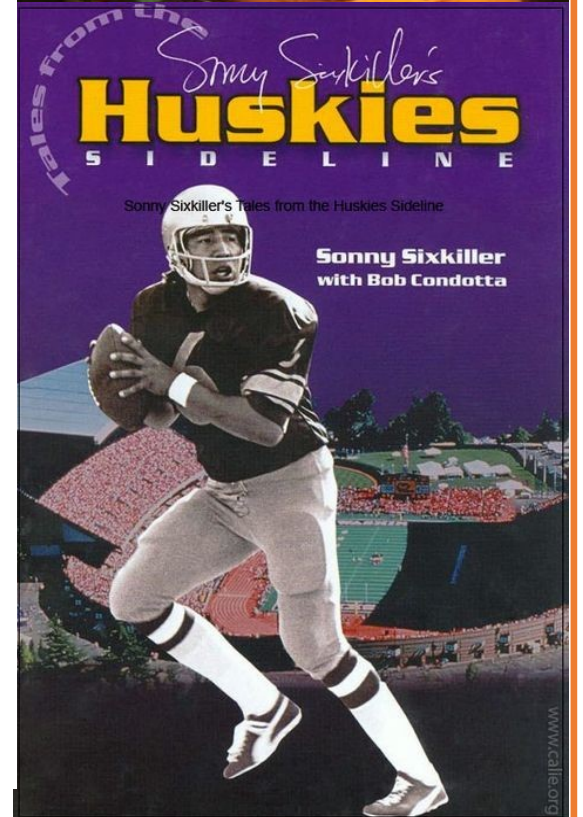

FOX NEWS HOST SUED FOR DEFAMATION BY FORMER BIDEN BUSINESS PARTNER

Former Biden business partner Tony Bobulinski is suing Fox News host Jessica Tarlov over her claims a super PAC connected to former president Donald Trump paid his legal fees.

Bobulinski filed the defamation lawsuit in Manhattan district court Thursday afternoon demanding \$30 million in damages from Harlov, the liberal co-host of *The Five*, for remarks she made on the show last week about a pro-Trump super PAC paying Bobulinski's legal fees as recently as January. Stefan Passantino, an attorney for Bobulinski and a former Trump administration official, is also a plaintiff in the lawsuit.

"Ms. Tarlov lied to achieve media headlines and ratings and to serve her political agenda by deliberately besmirching the character of Messrs. Bobulinski and Passantino," the [complaint](#) begins. Since 2020, Bobulinski has spent over \$500,000 on legal fees and denies taking money from any Trump-affiliated organizations during that time period.

"The Continuing Legal Struggles To Protect Tribal Water Rights"



To be pedantic, the above underscores my yapping about the ability to read cursive. Even someone employed to digitize records needs to be able (at least) to see if a document is right side up, etc., and in a longer exhibit, if pages are sequential.

"Right now, it's practically impossible to know who has the right to use water, how much they're taking and from what river or stream at any given time in the state."

Underscoring the seriousness of the subject is that California obviously gets it now....especially with the Colorado River rights being negotiated three years late. Since the Colorado River rights affects tribes in Wyoming, Colorado, Utah, Arizona, Nevada and California, I implore y'all to make sure your water right arsenal is in great shape.

Each tribe has a different story/legal statues, so one pronouncement will not fit all. Those from other states would do well to review their own status on their rivers.

Please also remember that one must put one's rights in a chronology of the specific reservation formation in terms of territorial (federal) or state law at the time of reservation creation/settlement and the evolution thereof. Who was given jurisdiction over the designated water? Has their been a change in local law recently?

Then there is the (magical) time in which the (Bureau of Indian Affairs) BIA, churches, etc. managed tribal rights and then the history of (Indian Reorganization Act 1934 AKA the Wheeler-Howard Act,) IRA or non-IRA tribes



administering their legal legacies.....as I have said before, "quite complex" and an unexpected education on so many sub-topics.

Add to this, the evolution of various state laws and the active - or non-active - participation of tribal communities. Have fun.....call if you need some idea thrashing.

California has committed approximately \$60 million from the general fund to the water rights digitization and data modernization effort underway at the water board. Project managers estimate the new system, called CalWatrs, will be operational sometime in 2025

The California State Water Resources Control Board aims to build a database that integrates a century of water rights records, geospatial mapping and up-to-date water diversion data that's available to the public is a major ambition.

The new directory will, most crucially, help regulators make high-stakes decisions on who to cut off when the next drought hits. **One must thus be vigilant in determining if tribal records are included in the "up-to-date" data base,** that the appurtenant rights are upheld, and that any re-

sultant reallocation of water is consistent with the law(s).

As stated before (ad nauseum), this will require a tribe to have personnel that understand how/why data bases are created and operate in order to determine the tribe's history in the local historic record. It will also require "fix-it" people for the actual physical systems as well as those with astute fiscal minds that can wade through "obscure" data held in a variety of historical repositories, to say nothing of legal eagles who can fly through the morass.

And while the state is digitizing its records, so may a tribe. This will necessitate the tribal team to know and understand the repositories that might have relevant records should their secretarial BIA collection not be readily available.

The saying "Water is Life" might be transposed and read "Life is Water" once one enters the tangled web known as tribal water rights. And yet is one of the key foundations of and for .tribal survival. Don't let it be ignored in your planning or human resource development.

Each tribe has a different water legacy and each tribe must determine their response to not only the legal challenge, but that of climate change which will definitely affect water rights. Education of technical staff is critical; so is community-at-large education.

There will be some difficult decisions to be made as well as personnel supported through a change in technology and law. Educated choices are so much easier than those made in a vacuum of knowledge.
