



Wes Studi's has had one long enjoyable acting career. He was raised in Nofire Hollow Oklahoma, speaking Cherokee only until he started school. At 17 he joined the National Guard and later went to Vietnam. After his discharge, Studi became politically active in American Indian affairs. He participated in Wounded Knee at Pine Ridge Reservation in 1973. Wes is known for his roles as a fierce Native American warrior, such as the Pawnee warrior in Dances with Wolves. In the Last of the Mohicans he plays the Huron named Magua, which was his first major part. Soon after he got the lead role in Geronimo: An American Legend. He was in Skinwalkers, The Lone Ranger, and The Horse Whisperer. He played the Indian out in the desert in The Doors movie, and he was also in Avatar. Studi also plays bass and he and his wife are in a band called Firecat of Discord. Wes Studi also serves as honorary chair of the national endowment campaign, of the Indigenous Language Institute that's working to save Native Languages. He and his family live in Santa Fe New Mexico, and Wes has been in several other movies, TV shows and movies, and mini series. He also received an Academy Honorary Award, becoming the first Native American and the second North American Indigenous pers to be honored by the Academy, the first was Buffy Sainte-Marie, a First Nations Canadian Indigenous musician.

70 AD: Romans destroy the temple



The team I'm working with were all hand selected and are extremely capable people. I look forward to learning from them, and helping inform the project from a Tribal perspective. Proving the PHM Service at this scale is a first-in-the-nation endeavor, and including Tribes in the building process will result in greater health equity and fewer health disparities in the future. There is a lot of work ahead, but I love a good challenge and look forward to engaging and informing my team and Tribal communities throughout this process.

Redbone was a Native American rock band. They reached the Top 5 on the U.S. Billboard Hot 100 chart in 1974 with their single, "Come and Get Your Love". The single went certified Gold selling over a million copies. It also made Redbone the first Native American band to reach the top five on the Billboard Hot 100, with the song reaching number 5.[1] Redbone achieved hits with their singles "We Were All Wounded at Wounded Knee", "The Witch Queen of New Orleans", "Wovoka", and "Maggie" in the United States, although these singles were more successful overseas

Tracy Lee Nelson, "The La Jolla Man" began his music career with Redbone shortly after he graduated from Hollywood High School, before launching his own band.
